

While Friendship Baptist Church is located in Spartanburg County, it is very near the Union County line and therefore you will find members there from both counties. It was founded in 1765 making it the oldest Baptist church in Spartanburg County. However, no records prior to 1801 are known to have survived. This book includes the complete transcript of the church minutes, listings of church members and officers, and an inventory of the cemetery. It is a soft bound book consisting of 193 pages of text and a full name index.

Spartanburg County Deed Abstracts 1848-1852

Transcribed by Betty Jean Dill Edited by Joseph R. Gainey

Deeds are a staple of genealogical research in the South. The abstracts in this volume cover the waning years of the antebellum era. Included here, in addition to deeds transferring title of land, are slave sales, mortgages, contracts, business agreements, and other miscellaneous records. With the exception of the deeds, none of these items are included in the index at the deed office in Spartanburg or at the SC Dept of Archives in Columbia, SC. Therefore the abstracts and full name index found in this volume are especially useful to the researcher. In addition to individuals, the index also includes creeks, rivers, roads, churches, corporate names and even family cemeteries. If you think you have exhausted these records, you will be surprised at what new information awaits you. The book is hard bound and consists of 240 pages and has a full name index.

THE WILLIAMS FAMILY OF PICKENS COUNTY, SOUTH CAROLINA

Being asked to write an article on the Williams family was a pleasure, but also a horror. I was ashamed to say that I have not worked on my surname much, because it is such a hard name to research. Even in 1790 the Williams name was the seventh most used surname, the first US census listing 2283 Williams families, and today it is around the third most used surname in the United States. However, it seemed that the day after I agreed to write this article, I received information from cousins that inspired me to work on my Williams family.

Joseph and Rebecca Bowen Williams

Joseph and Rebecca Bowen Williams are my fourth great grandparents, and they are my Pickens County, South Carolina ancestors. Joseph Williams was born between 1780 and 1785 in Caswell County, North Carolina to Henry and Elizabeth Williams. Joseph moved to Pendleton District, South Carolina (in the area of present day Pickens County) by 1799, when his first son Zebulon was born. His wife was Rebecca Bowen, who was born September 4, 1781 in Tazewell County, Virginia to Capt. Robert P. and Mary Gillespie Bowen. Joseph is listed in the 1800, 1830, and 1840 Pendleton/Pickens censuses; he is not to be found there in the 1810 and 1820 censuses. Joseph is named in many Pickens District records. He left a will which was signed on September 14, 1840 and probated in Pickens District on November 2, 1840. [Editor's note: See this Quarterly, Volume XIII, No. 1. February, 1999, p.27 for a transcript of Joseph Williams' estate.] Joseph died September 20, 1840 in Pickens District and was buried in the old Williams Family Cemetery. (Later the graves were moved to the Williams section of Peters Creek Baptist Church Cemetery because of vandalisim.) His wife Rebecca died July 4, 1859 and is buried beside her husband. (Rebecca is listed in the 1850 Pickens District census in the household of her son John H. Williams.)

Rebecca Bowen's father, Capt. Robert P. Bowen, was born in Augusta County, Virginia in 1740 and died August 25, 1817 in Hickman County, Tennessee. Her mother, Mary Gillespie, was born in Augusta County, Va in 1744 and died July 20, 1822 in Pendleton District. Robert Bowen is listed in the 1800 Pendleton District census; he moved to

Tennessee six years later. Rebecca's siblings were the following:

1. John Bowen 2. William Bowen 3. Agnes Bowen, who married John Pickens 4. Robert Bowen

 Reese Bowen 6. Charles Bowen 7. Mary Bowen, who married Mr. Helm 8. Lillian Bowen, who married a McClure.

Robert Bowen was the grandson of Moses Bowen, who was born in 1674 in Carmartin, Wales. Mary Gillespie was the daughter of William Gillespie from Scotland, who died about 1800 in Pendleton District.

Children of Joseph and Rebecca Williams

Joseph and Rebecca were the parents of eleven children, all born in Pendleton District, and all but two of them remained in Pendleton/Pickens County. Their children are listed below:

- 1. Zebulon Williams, my third great grandfather, was born in 1799 and died July 6, 1879 in the Hightower area of Cherokee County, Georgia, to which area he moved about 1842. He married Office Barker (1806-1882); both are buried in the Hightower Baptist Church Cemetery. They raised twelve children, whose names are the following: 1. Henry B. Williams 2. Joseph W. Williams 3. Mary Ann Williams 4. John L. Williams (my second great grandfather) 5. Rebecca C. Williams 6. Sarah E. Williams 7. Joel M. Williams (died in Civil War) 8. Eliza C. Williams 9. Berry H. Williams 10. James M. Williams 11. Thomas J. Williams 12. Altzeany Abi Williams. In the 1880's, Joseph, John, and Berry remained in Georgia, while the other nine moved to Oklahoma as Baptist missionaries.
- Elizabeth Williams was the second child, being born June 28, 1800. She died August 8, 1878 and was buried in the Williams section of Peters Creek Cemetery. Elizabeth never married.
- 3. Isaac Williams (1805 -1895) was co-owner in the Hendricks/Williams store in Easley. He married Susan, the daughter of George Hill, and he is named in his father-in-law's will (May 13, 1834) in Pickens District. Isaac and Susan had eight children: 1. Elmira Williams, who married James Hester. 2. Elzara Williams, who married Warren Keith. 3. Augustus Williams. 4. Van Buren Williams. 5. Theodore G. Williams. 6. George M. Williams. 7. Martha A. Williams, who married Bennett Medlin. 8. Joseph F. Williams.
- 4. Abel F. Williams (1807 after 1891, in Pickens County) married Nancy Hester (1806,SC-October 23, 1891, Pickens County). They are buried in Nine Forks Cemetery. Abel moved to Georgia about 1844, later moving back to Pickens County in 1871. Abel's and Nancy's children were Martha L. Williams, Thomas H. Williams, and probably others unknown to me.
- 5. Henry Williams (October 10, 1808 February 20, 1904) is buried in Peters Creek Cemetery with his wife, Rebecca Trotter, whom he married on July 13, 1825 in Pendleton District. Rebecca was born June 13, 1809 in Pendleton District and died November 22, 1877. She was the daughter of James Trotter of Virginia and Elizabeth Griffen. Henry and

Rebecca had nine children: I. James H. Williams, who died in the Civil War. 2. Grace Williams, who married first Garland Jones and second William Hughes. 3. Martha Williams, who married Williams Lindsey. 4. Pickney Halbert Williams, who married Josephine D. Robinson. 5. Joseph Berry Williams. 6. John Silas Williams, who married Catharine Josephine Jones 7. Tyre L. Williams, who married Polly Robinson. 8. Henry Jacob Williams, who married Susan Alexander. 9. Hester Williams.

6. Mary Williams (1813 - December 22, 1887, in Cherokee County, Ga) is buried in Hightower Baptist Church Cemetery. She married Thomas Hester, who was born about 1812 in Pendleton District to William H. and Susan Crenshaw Hester. Thomas died July 13, 1849 in Pickens County. Thomas and Mary Hester had seven children: 1. William Hester, who married Elizabeth Vandike 2. Rebecca Hester, who married first Andrew Jackson White and second James W. Smith 3. Elizabeth Hester, who married George Cole 4. Harriett Hester, who married Samuel J. Gilland 5. John H. Hester, who married Rilla B. Cannon 6. Joseph S. Hester, who married Eliza Jane Jefferson 7. Andrew Thomas Hester, who married Elizabeth Davis. Mary and her family moved to Cherokee County, Ga, near her brother Zebulon, soon after Thomas Hester died.

7. William Williams (March 24, 1814 - August 19, 186_) is buried in Oolenoy Baptist Church Cemetery, in Pickens County, beside his wife Elizabeth Reid. Elizabeth was born January 15, 1818 and died February 4, 1880. They were the parents of ten children: 1. Josiah Williams 2. Malendia C. Williams, who married Lum Tate 3. Nathaniel Jefferson Williams, who married Rebecca Edens 4. Isaac Williams 5. Harrison Williams, who married Mary -? 6. John Williams, who married a McWhorter 7. Mary E. Williams, who married J. Pickney Robinson 8. Elliott Williams, who married Jane Jones 9. Eliza Williams 10. Rebecca Williams.

Thomas Williams (1821 - ?) married Anna Lydia Hester. They had the following children: 1. James P.C. Williams
 Abraham Williams 3. William Williams. This family was enumerated in the 1850 Pickens Census, but where they went afterward is unknown to me. However, they were back in Easley by 1891.

9. John H. Williams (August 28, 1824 - May 22, 1896) is buried at Rock Springs Cernetery, Pickens County, beside his wife Eliazabeth (January 4, 1828 - June 22, 1904). "Elizabeth" may be the middle name of Margaret Hester, with whom he had a male bastard child, and was charged on June 11, 1858 in Pickens County.

10. Martha Mahala A. Williams (October 5, 1825 - February 17, 1888) married Jeremiah A. Robinson (1822 - 1860-70). Jeremiah appears to be the son of Catharine Robinson (b. 1791-92), who was listed in his household in the 1860 census. According to The Piotens Sentinel, Martha is buried at Peter's Creek. Martha and Jeremiah had four children: 1. J.P. Robinson 2. Julia Robinson 3. Josephine Pickney Robinson 4. Silas P. Robinson, who married Martha S. -?
11. Eliza Ann Williams (May 31, 1826 - December 15, 1891) is buried in Peters Creek Baptist Church Cemetery. She was never married. There is some uncertainty that Eliza was a child of Joseph and Rebecca because she was not named in Joseph's will (but she would have been only fourteen years of age then). There is in a female in her age bracket in the 1830 and 1840 censuses for Joseph Williams. Eliza and Rebecca Williams were listed together in the 1850 household of Rebecca's son John H. Williams, and in 1870 she was living with Martha Williams Robinson. In Eliza's obituary it is stated that she died at the home of her brother Thomas Williams.

Parents of Joseph Williams

Joseph was the son of Henry Williams, who was born November 3, 1734 in Hanover County, Virginia. He died in 1785 in Caswell County, North Carolina, leaving a will that named his son Joseph. Joseph's mother was Elizabeth, who is listed in the 1800 and 1810 censuses of Caswell County and in numerous tax records. She died in 1814. Henry Williams received land grants in Caswell County totaling to over 1100 acres. He became a very wealthy plantation owner there, after moving from Granville County about 1770. Joseph's siblings were the following: 1. Henry Williams Jr., who was listed next door to his mother and brother Nathan in 1800 and 1810. 2. Nathan Williams, who was born December 26, 1776 and died June 24, 1838 in Henry County Tennessee. He matried Frances McNeil. 3. Davis Williams, who was born April 19, 1783 and died September 12, 1853 in Laurens County, South Carolina. He matried Nancy Andrews and raised a family of over eleven children. 4. Daniel Williams, who matried Anne Rice 5. Elizabeth Williams 6. Jane Williams 7. Mary Williams, who matried Thomas Slade and died in 1782–8. Nancy Williams, who matried Mr. Rice 9. Sally Williams, who matried Mr. Brooks—10. Susannah Williams, who matried Mr. Rice 11. Ursula Williams, who matried Reuben Peeples and died about 1803.

Parents of Henry Williams

Henry Williams was the son of Daniel and Ursula Williams. Daniel was born September 26, 1710 at Queen's Creek in York County, Virginia. He died in 1759 in Granville County, North Carolina, leaving in his will two slaves and male mulatto to Henry. Ursula Henderson was born March 15, 1710 in Virginia and died in North Carolina. Though born in York County, Daniel Williams moved to Hanover County, Virginia and lived there until his removal to Granville County. In addition to Henry, Daniel and Ursula had the following children:

- 1. Maria Williams, who married Benjamin Goodman and removed to Laurens County, South Carolina
- 2. John Williams, who removed to Laurens County, South Carolina
- Col. James Williams, the famed patriot in the Battle of Kings Mountain, who lead his militia to a victory, but met his death. He married Mary Wallace and had a small family before his death.
- 4. Joseph Williams, who married Sarah Lanier
- 5. Mary Williams, who married first Issac Mitchell and second John Satterwhite
- Daniel Williams, who married Anne Henderson and removed to Caswell County, North Carolina, where he owned
 a considerable amount of land

Ancestors Before Daniel Williams

Daniel Williams was the great grandson of the immigrant John Williams I, who was born about 1614 in Wales and who came to York County, Virginia in the 1640's. Daniel's grandfather was John Williams II, and his father was John Williams III. Ursula Henderson was descended from Capt. George Keeling and King James IV of Scotland.

Decendance To Author

My second great grandfather John Lewis Williams (son of Zebulon son of Joseph) was born in Pickens District, South Carolina on February 16, 1835 and died March 27, 1913 in the Orange Community of Cherokee County, Georgia, where he was buried at Macedonia Baptist Church Cemetery. He is buried beside his wife, Mary Ann Wooten, whom he married on August 8, 1854 in Cherokee County. Mary Ann was born in Georgia on January 28, 1834 and died July 19, 1909. John Lewis Williams ("Jack", as he was known) served in the 56th Regiment from Hall County, Georgia in the C.S.A. with his brother Joel M. He was a private and was captured at Vicksburg. He received a pension. Jack became the superintendent of the county home in the early 1900's. He had nine children, including number seven Green Berry (my great grandfather). Green Berry Williams was born October 16, 1869, removing to Cobb County. Georgia in 1922. He died March 1, 1960 in Marietta, Georgia and is buried at Sardis (now Paper Mill Road) Cemetery beside his wife Jennie Lou Verda Young. Jennie was born May 11, 1873 in Pickens County, Georgia, and she died on July 11, 1934 in Marietta. Green Berry and Jennie were married on July 16, 1892 in Cherokee County, where all their children were born. (I was able to take a wonderful trip last summer with my grandfather GB Williams, age 81, a great uncle, age 85 and family, through Cherokee County. We visited the birthplaces, homes, churches, and communities of our Williams'. We saw the brand new marker in the Hightower Baptist Church Cemetery put up for Zebulon and Ollie by their descendants. Also, my grandfather and I, with other relatives, went through-out Cobb County and visited the homes and cemeteries of our Williams' in Cobb.)

My grandfather GB was the last of ten children born to Green Berry and Jennie Williams. He was born September 8, 1917 in the Gober community of Cherokee County, Georgia. He married on October 22. 1942 in Smryna, Georgia to Eula Vonceil Curtis, born August 18, 1923 in Smryna. Her family was from Cherokee County. GB rose from the poorest of the poor to become a wealthy man. He began in 1936 by borrowing \$50 from his parents to start a cafe in downtown Smryna. GB's cafe stayed in business for 37 years. Now, after 56 years of marriage, GB and Vonceil live at their home on his property outside of Smryna.

Living next door since 1979 is his third and last child, Terry Dwayne Williams. Terry was born June 20, 1958 at Kennestone Hospital in Marietta. In 1976, Terry graduated from Osborne High School, where he met Karen Jane Glosson. They were married July 28, 1979 in Marietta. Karen was born in Pensacola, Florida on March 13 1959. Terry is employed by Georgia Tech in Atlanta. The first of two children, their son Chad Spencer Williams was born November 6, 1984 at Cobb Hospital in Austell, Georgia. He is now in the eighth grade at Floyd Middle School, and he has been an honor roll student and student of the month for all of his three years at Floyd. He is a member of Milford Baptist Church. He has done research for four and a half years and enjoys history, which he may pursue as a profession. He also helps run the boarding stables owned by his grandfather by keeping the books and also raises pigeons with him. He is the author of this article.

HISTORY OF THE HUNSINGER FAMILY

Charlotte transcribed the notes of Romeo Hicks HUNSINGER, who lived in Gastonia, NC, from a handwritten manuscript belonging to her father. She has retained spelling and punctuation of the original. Betty Jean Foster Dill has a grandson, James Toliver Kennedy, who was named for Toliver Brady who was named for Toliver Hunsinger. The father of Christopher Columbus Hunsinger arrived in America in 1770, and settled in Moore County,

N.C. about six miles from Carthage, the county seat of Moore County, N.C. The father of Christopher Columbus Hunsinger married twice in Moore, the first wife having one son, Christopher Columbus Hunsinger. The writer does not know if there were any children born of the second marriage. Christopher C. Hunsinger was born about the year 1790. After his mother's death, and he grew to young manhood, he left his home in Moore County, N.C. and settled near Columbia, S.C. and went to work as Supt. of farms for a number of years. The father of Christopher C. Hunsinger fought in the Revolutionary War.

Becoming dissatisfied with his work in Columbia, S.C. Christopher C. Hunsinger left Columbia, S.C. and went to the western side of Polk County, N.C. There he soon secured work as Supt. of farms for Joe Coxe & Columbia Mills. This farm is now known as the Colonel Frank Coxe farm or the Miss Maude Coxe farm. This farm is located on Green River, eight miles west of Rutherfordton, N.C. Christopher C. Hunsinger was married to Susan Brewster of Polk County, N.C. Christopher C. Hunsinger died near the age of eighty and was buried near the Coxe Farm in Polk County, N.C. The exact place is unknown to the writer.

There were born unto this union, the following children: Adam Hunsinger, Noah Hunsinger, Peter Hunsinger, Toliver Hunsinger, Dee Hunsinger, Abner Van James Hunsinger, and Thomas Hunsinger. The girls were Minnie Hunsinger, Rachel Hunsinger, & Visie Hunsinger, Winnie having died before she married.

Adam Hunsinger, first son of Christopher C. Hunsinger, married a Miss Goode of Polk County N.C. He raised his family in Polk and Madison Counties, N.C. Unto this union were born the following children: Noah, Spashe, Pete, Bob, Jim, and Tom Hunsinger. The last two children named were by Adam's second wife. Noah Hunsinger went to Indiana and married there and raised his family there. Pete and Bob Hunsinger went to Madison County, married there and raised their families there. Spashe Hunsinger Married in Madison County N.C. and in the year 1894 moved to Deneson County, Texas raised his family there and died there. Spashe Hunsinger had two sons, Herbert and Nelson Hunsinger. Pete, Bob, Jim and Tom Hunsinger all married in Madison County N.C. and mostly raised their families there. Pete Hunsinger, in the year 1922, fived near Weaversville College, Madison County N.C. Tom Hunsinger had a daughter in training in Asheville, N.C. He also lived near Weaversville College for some time. Jim Hunsinger moved to Winston-Salem, N.C. and later moved to High Point, N.C. and died there. Adam Hunsinger's daughters were Winnie, Frances and Elizabeth Hunsinger. Winnie never married and died years ago, Elizabeth married a Mr. McAbee of Madison County, N.C. and after they married moved to Knoxville, Tenn. They lived and died there. Their children are to be found around Knoxville, Tenn. One of the daughter's of Elizabeth McAbee married a Mr. Hood of Tryon, N.C. Here the children are to be found in and around Tryon N.C. and Landrum, S.C. Sally McAbee married a Mr. Hensley of Hot Springs N.C. and was still living in the year 1930. In the year 1936, Furman McAbee lived at Brightsville, Tenn. Vennie McAbee never married and died when young.

From the best information the writer has, Spashe Hunsinger has children and grandchildren in Oklahoma.

City, Oklahoma.

Frances Hunsinger, daughter of Adam Hunsinger, married a Mr. J.H. Hensley and unto this union were born the following children: Mrs. Hazel Melton, Mrs. Maggie Henderson, Mr. Otis C. Hensley, Leroy Hensley, and Hester Pettyjohn. Frances died many years ago. All the children mentioned above either live with or near Mr. J.H. Hensley on the Wilkerson Boulevard about four miles East of Gastonia, N.C.

Pete Hunsinger, son of Adam Hunsinger, was still living in the year 1922, near Juno, N.C. He was about eighty years at that time. Bob Hunsinger died near Arden, N.C. Tom Hunsinger married and lived near Weaversville College, Madison County, N.C. A past of his children attended Weaversville Colleges.

Winnie Hunsinger, daughter of Pete Hunsinger, married a Mr. Ballard, now deceased, and the year 1922, Winnie lived in Valdese, N.C. Burke County. Unto this union were born the following children: Earle Ballard, Hazel Phelps, and Billy Casey. At this writing some of the Ballard children still live at Valdese, N.C.

Jim Hunsinger married in Machson County, and as stated on Page one moved to High Point N.C. and died there. Born unto Jim Hunsinger, the following children: Lee Oskar Hunsinger of Fort Mill S.C., R.H. Hunsinger of Woodruff, S.C., Gary Hunsinger of Whitmore [Whitmire?], S.C., Mrs. Stenner Stultz of Virginia, Mrs. Winnie Waldrop of Union County, S.C. and Mrs. Kate Culp of Gaffney, S.C. Lee Oskar Hunsinger of Fort Mills, S.C. has a daughter Perle Hunsinger who recently married. The writer has written this girl several letters in recent years.

The writer knows but little about Noah Hunsinger, second son of Christopher C. Hunsinger. The only child the writer knows about was Dave Hunsinger, which lived mostly in Polk County N.C. Dave Hunsinger had two sons, the writer knows of, Volney Hunsinger of Polk County N.C. and John Hunsinger of Avondale, Rutherford County N.C. Dave Hunsinger had the following girls: Lizzie, Rhodie, Mollie, and one girl that married a Goforth. All the girls married but the writer has forgotten to whom they married. Rhodie lives near Avondale, N.C. with or near her mother which is still living.

Peter Hunsinger, third son of Christopher C. Hunsinger, married in Polk County, N.C. but the writer does not know to whom. Peter had the following children: One Arm Jim, as he was called when he was a young man, Joe Hunsinger and Little Tom Hunsinger, and John Hunsinger. One Arm Jim married a Brady, and unto this union were born the following children: The late B.C. Hunsinger, The late G.T. Hunsinger, had the following girls: Emley, Dovey, and Maggie Hunsinger. Emley Hunsinger married John Finch and lives near Inman S.C. Dovey Hunsinger married Boss Seay and lives near Boding Springs S.C. Maggie Hunsinger married Andy Reid and lives in Georgia. B.C. The writer met one of Emma's sons a Mr. Chapman that carried a rural route out of Spartanburg, S.C.

Ed Hunsinger, son of Tom Hunsinger, lives in Sparianburg, S.C. and operates a grocery store. Ed Hunsinger

has been married twice and has several children.

Charley Hunsinger, son of Little Tom Hunsinger, married a Miss Johns of Spartanburg County S.C., They left several children. The writer met two of Charley's children, Ellen and Louise Hunsinger. They are lovely, bright, Christian girls. Ellen married Grady Hodge of Union S.C. and they have a durling little boy. He is so handsome! Louise married a gentleman from Sparianburg S.C. and they live there at this writing. The writer loves Ellen like I do my sister. She is a wonderful girl. Little Tom Hunsinger had another son that went to Alabama, married and died there. He raised his family in Alabama. Lula Hunsinger, daughter of Little Tom Hunsinger, married George Briant and went to Texas. Effie Hunsinger, daughter of Little Tom Hunsinger, married Rufe Potter of near Chesnee, S.C. Spartanburg County.

Toliver Hunsinger, fourth son of Christopher C. Hunsinger, married Elvira Jones of Polk County, N.C. and unto this union were born the following children: Beauregard Hunsinger, Humphrey Hunsinger, William Hunsinger, Dolphus Hunsinger and Charley Hunsinger. Toliver's girls were Ruthey, Margaret and Sue Hunsinger, Toliver moved from Polk County N.C. to the Copeland place on North Pacolet river in the year 1882. Toliver lived on the Copeland place for about thirty years. Toliver Hunsinger moved to or near Inman S.C. and lived there for the remainder of his days. Toliver lived to be very old.

Humphrey Hunsinger, second son of Toliver Hunsinger, married Manerva Owens of near New Prospect, S.C. Unto this union were born the following children: A.L. Hunsinger of Campobello, S.C. Mrs. B.L. Tuck of Inman, S.C. Route #2, Loran Hunsinger of Inman S.C. Will say that the writer visited the home of the late Humphrey Hunsinger, met his widow, a son and a daughter-in-law, the year 1938.

The late William Hunsinger, third son of Toliver Hunsinger, lived in East Spartanburg, S.C. William had four

girls, all married.

Dolphus Hunsinger, fourth son of Toliver Hunsinger, married a Miss Foster [Note BIFD: Leila Foster, daughter of Robert W. Foster] of Roebuck, S.C. Charley Hunsinger, fifth son of Tokver Hunsinger, lives on the farm, Route#2, Campobello S.C. Spartanburg County. Charley has three children as follows, Mabell, Jason, and Everette Hunsinger. These children are all grown and live at home with their father and mother. Charley Hunsinger is the only son of Toliver Hunsinger now living.

Ruth Barnett, was the oldest daughter of Toliver Hunsinger, and was still living in the year 1931, at Tucarau, S.C. Ruth Barnett had two sons, both living at this writing. One lives at Tucapau, S.C. and the other son at Arcadia, S.C. Mag's children are all living but scattered all over the country. Mag's boys were in the world war. Sue Hunsinger never married and has been dead for a number of years. Sue was the youngest daughter of Toliver Hunsinger.

Dee Hunsinger, fifth son of Christopher C. Hunsinger, married Frances Nodine of Polk County N.C. and unto this union were born two children: One girl died when young, General Hunsinger was the only son. Dee Hunsinger lived and raised his family at John Camp Mills about thirty years. General Flunsinger was raised at the mills. General Hunsinger married Mary Jane McForland of Polk County, N.C. Unto this union was born one son, Eddie Hunsinger. In the year 1889, General Hunsinger took his wife and son and moved to Grayson County, Texas, and his address is Anna Texas, Route#1. General and his wife died a number of years ago. Eddie Hunsinger, their only son, still remains on the farm they settled on when they left N.C. in the year 1889.

Eddie Hunsinger, son of General Hunsinger, married Lucy Lee Echols of Texas, and unto this union were born the following children: One Child dead, two boy's and two girls living as follows: Ida Frances married Mr. Turner of Texas and they have the following children: Four daughters and six boy's. The writer has visited the homes of several of George Buchannon Brady's children. Some of them live in Landrom, Inman, and Campobello S.C. The writer found all of these Bradys to be a high class set of people, christians and good citizens.

The writer is sorry that he can not learn more of the old gentleman (John Brady) that married Vissie

Hunsinger.

Osker Brady, son of George Buckhannon, lives at Landrum, S.C. and operates a retail lumber and building material business there. Webster Brady, lives near Landrum, S.C. Webster Brady, ia a house building contractor. The writer visited Osker Brady's home in Landrum, S.C. and met his wife and several small children, in the year 1938. The writer also visited Laura and Ada Brady's homes, near Campobello, S.C. We also met some fine young girls and boy's, grand-children of George Bock Brady. The first time we visited Laura Brady's home, we met Kansas Brady, the wife of the late George Buckhannon Brady. She was very old. She has since passed away since that date in 1938. The first time the writer, saw Kansas Brady, was the year 1883. The writer met George Buckhannon Brady, Doctor Thurston Brady, and Bud Brady, many years ago. The writer saw Visie Hunsinger Brady, the year 1885. I visited her home

on the North Pacolet River in Spartanburg county S.C. The writer never, saw Rachel Hunsinger Brady, that married Jesse Brady.

There are a number of other Hunsingers that the writer did not get into this family history, simply because it would have cost must more than it has cost [so far] to do so. To have gotten the names and addresses of all the Hunsingers, in the United states into this history would have cost the writer \$5000.00. The young generation will not take any interest in this history, but if you care much about the name, when they get old, they ill regret that they did not buy one of these family histories. I am sure you will feel sad when you get old and you do not know what nation [-ality] you were and where you came from.

The Hunsinger race of people were Dutch. The name Hunsinger is a German name but not German. Some time about 1700, a German by the name of Hunsinger went up into Holland and married a Dutch girl. This accounts for their being many people in Holland today by the name of Hunsinger. The writer's great-grandfather was then, and [we] still are today, a peace loving people. Quite peaceful people. The old race was a short quick spoken people. Their

The writer, the youngest son of Abner Hunsinger, and grandson of Christopher Columbus Hunsinger. his uncle Dee Hunsinger, Toliver Hunsinger, and his father Abner Hunsinger, all three of these brothers were short quick spoken men. The old race of Hunsingers were honest, truthful, and not on the extremes about anything. They were not cranks over religion nor neither did they scorn religion as a great many people do today. The writer's grandfather, Christopher Columbus Hunsinger, was a bible student. He knew the Bible from cover to cover. He was also a great fisherman. He could eatch fish out of the Green River in Polk County, N.C. when the river was froze over with ice. He did not think it a sin to fish on Sunday. The Hunsingers are just like any other race of people. Some of them are just as educated and refined gentlemen and ladies as anyone in these United States. Of course some of them have married into a different races of people until some of them are not what the writer thinks they should be. In the year 1770, when the first Hunsinger boy arrived in America, there was no other person in America by the name of Hunsinger. Today the Hunsingers are scattered from New York to Florida and from New York to California. Noah Hunsinger was in Indiana, and the Hunsinger name appeared in Moore County, N.C., but most of the old race of Hunsingers were raised in Polk County, N.C. A great many of them moved into South Carolina, Georgia, Florida, Alabama, Texas, and Oklahoma. The son in Oklahoma City has found people there by the same names and they stated their grandfather was from North Carolina. The writer of this family history has been gathering information myself. I also have letters and notes from many relatives, and other persons which I am giving to you here. The writers mother was raised near Christopher C. Hunsinger and Christopher Hunsinger lived with the writer's father and mother for a number of years before his death.

The writer of this family history is one of the old race of Hunsingers and perhaps has met more Hunsingers than any other person living. Some of them allowed their named to be spelled with a T. in the name but this is wrong. There never has been a HunTsinger in these Southern states - but if they don't care, let them spell their names with a "T".

The writer is not ashamed of this great-grandfathers name. It's usually the uneducated Hunsingers that spell their names with a T. in it. This information has been gathered from the year 1879 up to the year 1939, the truth is, the writer has been making notes on this history all his life.

This information was gathered and written by R.H. Hunsinger of 517 North Broad Street, Gastonia, North Carolina. This history was completed in the year 1939.

The above was copied from a manuscript given to Mrs. Elizabeth (Lizzie) Hunsinger Phillips by R.H. Hunsinger who visited in her home. Some dates, after 1939, and names have been added to the Phillips family as they were not given to the writer of the history. Lynching in Abbeville

A Colored Man Taken Out Of Jail And Hanged For Stealing Cotton And Beating The Cotton Planter. Special Dispatch to the News and Courier

Abbeville, January 1 - Dave Roberts, colored, confined in jail on a charge of stealing the cotton of Dr. H. G.

Klugh and committing a desperate assault on the doctor, was taken from the jail last night by a body of men, carried two miles from town and hanged as is to a tree, where his body was found this morning with "cotton thief" written on the breast. The crowd effected an entrance into the jail by pretending to have a prisoner. At first only four or five presented themselves. The Sheriff and his young son went up stairs in their night clothes to lodge the pretended prisoner, and when they reached the third story the men demanded the keys to Robert's cell, which being refused they siezed and held the sheriff while they took the keys by force from the boy. By this time the jail was full of men. The sheriff was put into a room, guards put over the members of his family, and the crowd proceeded to secure their victum. The men were disguised and the sheriff did not recognize any of them. Being salesday, men are present from all parts of the county. So far I have heard nothing but condemnation of the act.

TAYLOR FAMILY OF PENDLETON, SOUTH CAROLINA

James Taylor of Virginia, son of James Taylor, came from England, 1654, married Hannah Williams of Pennsylvania and settled on a farm which is now a part of Philadelphia, Pa. Upon his death his widow and one son, Samuel Taylor, survived him. His widow married Mr. Van Swearenger. His son, Samuel before the Revolution was an officer in the British army but joined the American army and served as captain, when he was transferred to the South, and served faithfully to the end of the war, having been promoted to the position of colonel. He married Mrs. Eleanor Hudgens, nee Cannon. Large tracts of land on Seneca River near Pendleton were deeded to him by the Government. Contributor's notes: On page 208 of Volume XII, No. 4, of this Quarterly, this contributor stated more research was needed to determine whether the Samuel Taylor enumerated in the 1800 census of Pendleton District was the grandson of Ann Cannon or her son-in-law. He was unaware that the question was already answered by the Editor on page 151 of Volume IX, No. 4, where he listed some Pendleton District marriage bonds for the years 1792-1799. Included in the list was the bond, dated 30 September 1799, for the marriage between Samuel Taylor and Leah Reese. Since Major Samuel Taylor died in 1798 (see elsewhere in this issue), the Samuel in 1800 was thus the grandson of Ann Cannon. Samuel Jr. was a son of the Major and Eleanor Cannon Hudgens Taylor. The following family information for this couple is taken from pages 249-250 of the book Our Harris Family by Ouida May (Harris) Milner (no publisher named and no publication date given).

Leah (or Sarah) Reese, 4th child of Dr. Thomas and Jane (Harris) Reese, was b. 1 Dec. 1779 in S.C.; d 1835/6, Eutaw (Greene Co) Ala. (Note: In some records Leah is sometimes referred to as Sarah Reese.)

REVOLUTIONARY WAR FILE OF JOHN O'SHIELDS

On this 26th day of September A.D. one State of South Carolina thousand eight hundred and thirty-two Spartanburgh District

personally appeared in open Court being the court of Session & Common pleas for the District of Spartanburgh now sitting, before John Boncal presiding judge, John Osheals a resident of the State and District aforesaid aged seventy-one years who being first duly swom according to law doth on his oath make the following declaration in order to obtain

the benefit of the act of Congress passed June 7, 1832 - That he entered the service of the United States under the following named officers & served as is herein stated. He drafted & went into service in the Spring of 1777 under Captain Thomas Blassingame in Colonel William Wofford's Regiment in Union District, South Carolina; he marched from Union District into the lower part of South Carolina, crossed the Savannah River below Augusta & went into the State of Georgia to a fort about twenty-five miles from Augusta, which was in the possession of the Tories, for the purpose of taking the fort, but the Tories left there before Colonel Wofford's Regiment reached there. He was then marched back, re-crossed the Savannah River near Ebenezer into South Carolina where he remained opposing the Tories, sometime, when he was marched back to Union District until the latter part of the winter of 1780 when he again drafted & went into service under the command of Captain Thomas Blassingame, Lieutenant Samuel Jackson, Major. Bullock's Battalion in the regiment commanded by Colonel Stean, marched to liberty hill in Edgefield District opposite to Augusta, Georgia where he remained guarding prisoners until the expiration of six months when he was dismissed & returned home where he remained a few months when he drafted again & went into service under Captain Thomas Blassingame, Major Ford's Battalion in the regiment commanded by Colonel Thomas Blassingame (?). He then marched toward Charleston to the ten mile house where he was stationed for the purpose of protecting the City. He remained there a few months, was marched back to Union District & was dismissed having served six months. He then remained at home a month or two & entered the service as a volunteer under Captain Thomas Blassingame in Colonel Brandon's regiment & marched to Augusta, Georgia - from there he was marched toward Savannah & met with Colonel Hammond's regiment about four miles from Augusta. The two regiments marched on toward Savannah until they met General Lincoln's army about the last of May or first of June 1779. General Lincoln took the command and marched back across the Savannah River into South Carolina & on to Parkers Ferry on _____ River where the army remained a few days, when General Lincoln with the main army crossed the river & marched on toward Charleston. He remained under the command of Captain Blassingame to guard the ferry until his term of service expired which was seven months when he was dismissed & returned home where he remained but a very short time when he was ____ Tories & went & joined General (Morgan's) army at Smith's Ford on the Broad River in Union District in the Fall of 1779 as a volunteer in Captain John Thomson's company, Major McJunkin's Battalion in the Regiment commanded by Colonel Brandon; marched from there to the Grindl Shoals on the Pacolet River where the army halted & remained about two or three months; from which place he was marched in a detachment under the command of Colonel Hays in the direction of Ninety-Six in pursuit of a party of Tories under the command of a Major Lanthrope, which party Colonel Hays met & defeated in Laurens District. When he returned to the main army at the Grindl Shoals, General (Daniel) Morgan lay there until news reached him that the British army under Colonel Tarleton were pursuing him. He then retreated with the army into Spartanburgh District to the Cowpens, where the army was halted & preparations made for the Battle which commenced early the next morning being the 18th January 1781 which terminated in the defeat of the British army. This deponent then went to Salisbury, North Carolina as one of a guard who carried the prisoners to that place & delivered them to the American army then stationed there. He returned to South Carolina about the last of February & was dismissed having served about five months; he remained at home but a very short time when he again joined the same company in Colonel Brandon's regiment with the same officers & in the Spring of 1781 marched to the siege of Ninety-Six where he joined General Pickens; they remained around Ninety-Six, now Cambridge, until the news reached them that a strong reinforcement of the British army under Lord Rawdon was advancing. General Greene then quit the siege & retreated who_____ Colonel Brandon's Regiment - to which this Greene's army & returned home wh he was dismissed having served about two or three months. This deponent then moved to Spartanburgh District & joined Colonel Benjamin Robuck's regiment in Major John Ford's Battalion in the company commanded by Captain Joseph Wofford in which company he was elected 1st Lieutenant & as a Lieutenant he served in Colonel Robuck's regiment in South Carolina skirmishing with the Tories from the Spring or first of the Summer in 1781 until the end of his revolutionary career which terminated with the war, which time was, he thinks, about 18 months or two years. After the termination of the revolutionary struggle, this deponent settled himself in Spartanburgh District, South Carolina where he has lived ever since. He hereby relanquishes every claim whatever to a pension or annuity except the pension & declares that his name is not on the pension roll of the agency of any state. Answer #1: Born in North Carolina about the year 1761. Answer #2 : I have a true record of my age in a family bible in the possession of my sister which belonged to my

father. [His sister, Apsley, married John Lancaster in NC in 1770]

Answer #3: Was living in Union District, S.C. & removed to Spartanburgh about the time of Tarleton's defeat where I now live & have lived ever since the revolutionary war.

Answer #4: Was drafted [for full answer see declaration]

Answer #5 : See declaration

Answer #6: Never received a written discharge nor held a commission

Answer #7: In support of my declaration and my character as a man of veracity, I refer to William Smith, Jethro Osheals & James Howard who knew me in the service of the United States in the war of the revolution.

The State of Alabama Circuit Court for Said County

Pickens County April Term ____ day of the ____ AD ___

On this 22nd day of April AD 1836 personally appeared in open court before the Judge of said court Marshall Franks a resident of the county of Pickens and State of Alabama aged eighty four years, who being first duly Sworn, according to law, doth on his oath make the following declaration, in order to obtain the benefit of the pension made by the act of Congress passed June 7th 1832. That he was a Soldier of the Revolution, and was engaged in the Service of his country, as a Soldier most of the time from the fall of the year of 1775, to the close of the war & acknowledgement of the Independence a great many of the officers & especially the sub officers, he can not now recollect, in consequence of old age, & the consequent loss of memory.

The first of his service commenced in the Fall of 1775. he was then living in the State of South Carolina in a district then known by the appellation of Ninety Six district, but now called Lawrence [Laurens] district in said State. he was then about twenty three years old, about this time troubles commenced with the Tories & partizans of that part of the country. The particular circumstances which gave rise to this tour of service was this: The Governor (he presumes) had sent up to Cambridge Courthouse a large quantity of powder & etc; And the Tories had determined to take possession of it; a company of volunteers was raised in order to save the ammunition from being plundered; I was one who volunteered in this expedition. There was no definite or fixed time for the Service to continue then except -- as above stated, & to disperse & subdue the Tories who stimulated & encouraged by one Robert Cunningham of Tory renown was keeping the people in continual alarm & terror. This expedition was conducted by Capt Jas Dillard (?) 2d Lieut Jonathan Downes (?). This company marched to Cambridge & there joined several other companies. The whole force embodied at the above mentioned place was commanded by Genl Andrew Williamson, of whom it was afterwards said, that he proved traitor to his country, & afterwards joined the enemies army. Col Robert McCrary was also with them and in command. They succeeded in securing the powder as they desired, & subduing the Tories, who all remained neutral until the British invaded the Country which cheered their hopes & brightened their prospects. They had quite severe skirmishes with the Tories at Cambridge, which continued three days & nights. They finally surrendered on terms viz that there should be no hostilities for twenty days. They were verbally discharged after having rendered service for the term of at least one month. The applicant is not certain whether it was or not, but believes from the best of his recollection that it was in the year 1779 while he continued to live at the same place first mentioned, he was drafted

into the Service under Col Williams who was mentioned as his first Captain under which he served, & who had now been promoted to Col. The Captain under whose command he was, was called Charles Sexton, the Lieut not recollected. This draft was for three months. The forces were marched to Liberty Hill opposite Augusta in Georgia; the British then had possession of Augusta. They did not remain long after the arrival of the Whig but marched off for Savannah & on their way thither encountered & routed Col Ashe's forces of N. Carolina Troops. In meantime Genl Williamson, who had taken command of the forces, remained at Liberty Hill, but frequently sent scouting parties across the River to reconnoiter the country. In one of these parties the applicant happened to be when they had a skirmish with the Tories on Briar Creek in Georgia. This applicant states that Col Hayes (who was then a Captain) commanded him, and he thinks that Col Leroy Hammonds commanded. Col Thomas Brannon was also in command. There was some fo--- on five hundred of the enemy, consisting of British & Tory. The Whigs numbered to four hundred. They immediately on sight of the enemy charged on them, who fied in confusion, & our forces followed. This applicant in the charge was cut of from the main body of his company, & in winding his way down the creek to rejoin his friends he encountered & took prisoner a Tory of fame & renown & for whom Col Williams had offered a reward of five hundred dollars, his name was Aquillah Hall. Aquillah had been cut off from his friends & mistook the applicant [Marshal Franks] for one of his friends until he was ordered to surrender, which he was compelled to do. before he rejoined his friends he encountered & took another prisoner called Hector McNeal, who was also known as a Tory of considerable influence in this country. This applicant found it somewhat difficult in getting along with his two prisoners who seemed very sullen, but fortunately he met with one of his friends by the name of Wm Smith who joined him in guarding the prisoners into his friends. ---- be amiss he were to state how he took "Hector" inasmuch as he already had over in his custody his plan was this. Hector was with another dragoon who immediately on sight of this applicant & his prisoner put spurs to his horse & cleared himself he had given "Aquillah" his orders, to join him in his threats against Hector who was now left alone, or his life should pay the forfeit which "Aquillah" "done manfully." Hector thinking himself outnumbered gave up without any resistance. The party returned to Liberty Hill. From Liberty Hill they marched to Cambridge having taken in this tour a number of Tories amounting in all (together with those which had been sent to them at Liberty Hill by Col Pickens) to three or four hundred. They remained at Cambridge some time until one Judge Pendleton from Charleston arrived who tried the prisoners for their ----, five of whom was hung, the famous Aquillah Hall already mentioned being one of the number. They were then verbally discharged & this applicant returned home having served in this tour at least three months. The third tour the applicant was drafted, under Col McCravy & Capt Charles Sexton. The latter commanded the applicant's company. This force marched over into Georgia on Cupboard Creek, in order to prevent the British from retaking Augusta; after remaining in Georgia a short time, they pushed for Charleston in order to save that point but they received information by one Patrick Calhoun (a true Whig) that the town of Charleston had surrendered before they got to Orangeburgh District. The army was then remarched back near to Camden when they were verbally disbanded in great confusion, dismay & despondency, was discovered in every countenance, and the command of Col Pickens to us, was "that we would have to shift for ourselves." I now will recollect his looks, when he spoke these words the tear was clearly perceived by me to glisten in his eyes; this applicant then returned to his home, having served his country at least three months in this campaign. The fourth tour this applicant served under Col Levi Casey, under the immediate command of Capt. Lewis Duvall. This applicant states that from the time they received the information of the fall of Charleston & from the time they were discharged in the confused manner already mentioned by Col Pickens, they were not permitted to remain at home. The country was invaded by the enemy. The Tories were in arms & committing the most outrageous deeds of massacre & bloodshed and he thought the most certain safety was in camp. Soon after the above mentioned discharge was there not a draft in the company to which he belonged. The offscer who commanded indicated to them the plans (places) of meetings & they obliged, for they were generally if not in camps outlying or not ventured to sleep under their own roof & so it continued until near the close of the war. The officers marched to Ninety Six; it was the Spring of 1781 to the best of his knowledge. They attempted to besiege this place. It continued for near a month during which time Robert Pickens, a brother to Col Pickens (afterwards General) was killed; finally Rawdon was ascertained to be on his march up to the aid of the enemy, and Genl Green (who commanded him) left & made his way to the Eutaw Springs. The officers that commanded this applicant turned up towards N. Carolina & continued to reconnoiter the country, taking the advantage of the enemy whenever their numbers & position would justify it. This applicant states that he can not positively say whether he during his service above mentioned was a Militia Man, or belonged to the State Troops; he however well knows that he served fully three months. This applicant states that in the fall of 1781 he went on a tour into the Cherokee Nation under the command of Cols Anderson, Pickens and Clark & Mags Wm Muliose (?). In this tour this applicant served as a Second Lieux in his company which appointment he yet had in his possession purporting to be from Governor Rutledge & signed by Col. Jos. Hayes dated September 24th 1781. The object of this

tour was to dislodge a large squad of thieving, murdering Tories that had taken refuge among the Indians, & frequently made sallies into the white settlements for the purpose of plundering & committing depredations. They had some skirmishes - took many prisoners & returned home having been in this tour (altogether) in actual service two months.

This applicant states that shortly after the surrender of Charleston, the British invaded the Country, the Tories who had before been subdued, encouraged by the success of the British, became numerous & flooded the country with ; that they had become more in i towards him; especially in consequence of his having taken two of their leaders one of whom had been hung at Cambridge before mentioned. That he well knowing their vindictive feeling towards him seldom ventured home & when he did, remained but a short time. That from the year of 1776 for the reasons just mentioned he kept himself pretty much in continuous service until the close of the war, at which time he received seven hundred fifty pounds sterling as _____ for that _____. That he in the Spring of 1833 made application to the Department for a pension under the ___ act, that his application was returned as being informal in many things and that he returns this to the department as his amended Declaration. He hereby relinquishes every claim whatever to a pension or amnesty except the present, & he declares that his name is not on the pension roll of the agency in any

In the first second 3d 4th 5th 6th & 7th interrogatories propounded by the court to the applicant he answers in substance that he was born in the year 1752 in Charlotte County VA; that he has a record of his age in his own family Bible. That at the commencement of the war he was living in old "Ninety Six" or Craven Dist So Carolina. That he has since lived in Giles County, Tennessee, and now lives in Pickens County Alabama where he has resided for the last twelve years. That he was a volunteer whilst under Capt Williams as aforesaid; but whilst under Captains Saxon [Sexton] & Duval, he was a militiaman belonging to their companies & went whenever or dated to do so without any draft. That he served as a private until he achieved the accompanying commission. That he was acquainted with Col Mason & Capt John Caldwell of the regular Army. That this deponent never received any discharge in writing. That in his present neighborhood he is acquainted with diverse citizens who can testify to his character & with veracity and refers the court to the Revd Thomas Archibald and James Randle (?) for satisfaction and to John Mangum for proof of a part of his services. The remainder of his services he cannot prove by any person living to him at this time known. And the said court do hereby declare their opinion that the above named applicant was a Revolutionary Soldier and Served as he

Sir: I advise you from the papers in the Revolutionary War pension claim, S. 10703, it appears that Marshall Franks was born in 1752 in Charlotte County, Virginia. While residing in Ninety Six District, South Carolina, he enlisted and served with the South Carolina Troops, as follows:

In the fail of 1775, one month as private in Captain James Williams' Company, Colonel Robert McCrary's Regiment, and was in several skirmishes with the Tories; in 1779, three months as private in Captain Charles Sexton's or Saxon's and Hayes' Companies, Colonel James Williams' Regiment, and was in the battle of Briar Creek; about the time of the "fall of Charleston", three months as private in Captain Charles Sexton's or Saxon's Company, Colonel McCrary's Regiment; three months as private in Captain Lewis Duvall's Company, Colonel Levi Casey's Regiment, and was in the siege of Ninety Six; and September 24, 1781, he was commissioned Second Lieutenant and served two months in Captain Lewis Duvall's Company, Colonel Joseph Hayes' Regiment. He was allowed pension on his application executed April 22, 1836, at which time he was living in Pickens County, Alabama.

That in the tour that said Franks was in at Liberty Hill he knew him well as a soldier. That he was at last mentioned place when the party returned from the Briar Creek Expedition with the prisoners, & knows that it was thus stated & believed that said Marshall had taken Aquillah Hall a prisoner & has never heard that contradicted but knows nothing as to Hector McNeal the other prisoner mentioned. That he was well acquainted with the said Aquillah Hall but not with Hector McNeal. That he knows that he served at least three months during the Tour at Liberty Hill. The next Tour that the affiant knows of his own personal knowledge, that the applicant done actual Service, was the time mentioned by the applicant when they marched to Cupboard Creek in Georgia. This affiant saw the applicant during that Tour frequently,& believes that he served three months. This affiant afterwards frequently saw this applicant while he (the applicant) Served under Col Hayes & Col McCrary but does not know how long he Served under him. This affiant frequently saw the applicant while he acted as Second Lieutenant in Capt Duvals company commanded by Col Hayes, but did not then see his commission, but knows that he was so called, & understood to be - does not know how long he Served after he was elected Second Lieutenant and furthermore this affiant saith not.

DIED. At her residence in the district, on the 24th of May last, Elizabeth Wingo, in the 83d year of her age.

The subject of this notice was born in Amelia County, Virginia, and became the wife of **Abner Wingo**. In 1800 they removed to Spartanburg district. In 1811, her husband died, leaving her to provide by a family of small children. This she did. Mrs. Wingo has been a member of the Methodist Episcopal Church for upwards of 20 years before her death. She was the mother of 9 children, 4 only of whom are now living, the grand mother of 54, the great grand mother of 81, and the great grand mother of two of the fourth generation. Earle Ibequeath the land on the West side of the Seneca river above the mouth of Seneca Creek & adjoining said creek & river, provided he makes titles the said Earle makes titles to my son William Taylor to tract of land granted to his wife and adjoining the tract of land where I now live, Eastwardly-Item. To my beloved son William I bequeath the tract of land where I now live on the East side of Seneca river. [This land today holds part, if not all, the Clemson University campus.] I tem. I appoint my son John, Andrew Pickens, William Steele, & George Reese Exercises to carry the will to Execution-hereby disannulling any other will or wills by me written or made ... W. Norris, W. M. Fall, W. Hall lands of late John M. Fall and others, which land was originally conveyed to her said father by deeds from John E. Davis and Levi Davis. That the said tract of Land was left and has continued to be in the possession of your petitioner's mother Mary Cannon and is subject to partition amoungst the heirs at law of her father, the said Ephraim Cannon, who are of full age (unless it be some grandchildren) and are as follows: To wit, your petitioner and her mother Mary Cannon who is the widow of the deceased, and Elias Cannon in Georgia Lucinda Elrod widow of Yancy Elrod in Georgia, Eli Cannon out of state, & it is not known whether living or dead, the heirs of James Cannon, deceased to wit Mary Jane, James, Ephraim, Thomas, and Lilly P. Cannon all of whom are enfants and reside in MIssissippi, Martha Scott widow of Ebenezer Scott in Alabama, Jesse Cannon in Mississippi and John Cannon in this District. The bill further shows that John Cannon is the father of the following children to wit Jane who married John Sligh who died leaving her and a son Henry Sligh who is still alive ... that Jane afterward married James Hutchison & died leaving him and another son George I Hutchison [See the amended

bill above.] & the said Henry Sligh her only heirs and next of kin, David, Ephraim, Anna, James & Bartholomew. The bill states John Cannon the father of the complainants is now old and infirm & has expressed his covenant[7] & wish that the land be and Negro should be sold and the money arising therefrom should be let at interest which he is willing to receive for his support during his natural life and that after his death that it should be divided equally amoung those that might be interested therein. The bill states that in as muchas the land is very much wasted and the negro advanced inyears the complamants have concluded the plan suggested by their father John Cannon is the best that can be pursued but in as much as a question may arise whether the children of the husband and two children of Jane who thes on the _____ day of 182_ are entitled to any interest or shares in the said land or negro at the death of the said John Cannon the complainants have them parties to this bill and submit their rights to this court. The prayer of the bill is that the land and negro be sold and the interest of the proceeds be applied to the support of John Cannon during his natural life and after his death be divided equally between the parties according to their rights for general relief and for a sub.ad respondendum to be directed to John Cannon, James Hutchison, Henry Sligh & George I Hutchison.

WILLIAMS DAVIS MARTIN GARRARD THOMAS PARROT MIDDLETON Oneita Gay Brimberry, 305 West Market Street, Palestine, IL 62451

I am very interested in finding information on my ancestors from Newberry Co, SC. I found where there is a publication titled "Williams Family Cemetery, Newberry County, South Carolina" (Vol. 4, Issue 3, July 1986 Quarterly, PERSI Code SCGH). How do I obtain this publication? I am very interested in anything on ROBERT WILLIAMS, listed in 1743 as a Colony SC Resident, Purrysburg, his son, WILLIAM ELDER WILLIAMS, b. 1763 in Lee CO. VA, listed in 1779 as a Colony SC Resident of Old 96th District, was in the Revolutionary War from the 96 District, Newberry Co, SC, and the marriage of DANIEL ELDER WILLIAMS, wife unknown. They had a daughter, DRUSILLA, b. ca 1759. It is said that DANIEL ELDER WILLIAMS was the uncle of JEFFERSON DAVIS, President of the Confederate States; his mother was the grandmother of JEFFERSON DAVIS by her second marriage to EVAN DAVIS, II in 1729. I believe DANIEL ELDER WILLIAMS was a Colonel in the War of 1812. DRUSILLA WILLIAMS m. JOHN MARTIN (2) of Newberry Co, SC, b. 1759 on the Great Peedee River, SC. JOHN MARTIN (2) was the son of JOHN MARTIN (1) who is listed in 1716 and 1717 Colony SC Petitioner, no Twp listed, again in 1763 and 1764 Colony Warrant for Land, no Twp listed. JOHN MARTIN (1) was born on the Great Peedee River, SC and was in the French-Indian War, at Bradock's Defeat; he had two known sons THOMAS and JOHN (2) above. He also served in the Revolutionary War, probably from the 96th District, Newberry Co, SC. JOHN MARTIN (2) was also in the Revolutionary War from 96th District, Newberry Co, SC (Rev War Pension File #S16459), I have no record of when JOHN MARTIN (2) and DRUSILLA WILLIAMS were married, I would say around 1779, as their first child was born in 1780. I have another ancestor, WILLIAM GARRARD, b. 1 Jan 1760 in Stafford Co, VA, who was reportedly married in SC to a lady named RUTH in abt 1789. He also was enlisted in the Revolutionary War at Chester Co, SC in May 1779 and served three months under Capt. ANDERSON THOMAS. He was called again in 1780 to serve under Capt. THOMAS. In 1781 he served with THOMAS PARROT and Col. MIDDLETON. The daughter

of WILLIAM GARRARD and RUTH (?), MARGARET "PEGGY" GARRARD, b. 11 May 1791, was married to JOHN MARTIN (3), the son of JOHN MARTIN (2) and DRUSILLA WILLIAMS. JOHN MARTIN (3) and MARGARET GARRARD were married 7 April 1808 in KY. I would love to find out who the father of WILLIAM GARRARD was and the last name of this wife RUTH. I am hoping for a reply and the cost of this information. I am disabled due to two bouts with bone cancer in my left hip and have to depend on my poor old computer (limited hard drive space) to find information. So, if you will help me in my quest, I will be eternally grateful to you! I am compiling information for a little handbook for my grandchildren, nieces and nephews, so they will know what a wonderful heritage they have and something to be proud of. They get more interested in what I am doing all the time. They are starting to ask questions about what I have found out lately. It is time they learned the sacrifices and hardships our ancestors went through to make our country what it is today.

Although I have absolutely no relatives at New Prospect Baptist Church, which is located in northern Spartanburg County, this is a long awaited volume for me. I have always had a special fondness for church minutes. They show our forefathers as the human beings they were with foibles and faults just like us and not as the pious, perfect paragons of virtue which certain political and religious leaders point to as models for emulation in both the sacred and secular sphere. These records did not disappoint me. Here are people embroided in both devotion and discord. Holiness and hate go hand in hand in these pages. They are a good read for anyone interested in the social mores of the era. (If modern churches held their members to the standards found here, the pews would be empty.) Founded in 1820, this congregation still exists and one of its charter members was a sister of Henry Clay. Unfortunately, these are the only records which exist for the first 150 years of the church's history. The congregation never had its records microfilmed or otherwise copied and they were lost in a fire which destroyed the church building in 1983. Mr. Vehorn's volume is based on a transcript made by Samuel Lancaster (an ancestor of the editor). It is hoped that the copy Mr. Vehorn used will be microfilmed or made otherwise available to researchers.

Although no detailed editorial methodology is provided, this appears to be a verbatum transcript of the original. The index is well done. Slaves and servants are indexed under servants and persons appearing in the records without a surnane can be found at the beginning of the index. The only real regret I have is that full tombstone inscriptions are not provided. Thus, you are deprived of some real gems (and valuable information) such as that found on this stone. It is one of my favorite tombstone inscriptions of all time. On page 97 is found "John White Died 23 Aug. 1863. In 43rd year". The complete text of the inscription (retaining orthography and punctuation as found on the marker) reads as follows:

TO THE MEMORY OF / JOHN WHITE,/ who died on the 23rd, of August / 1822. in the 43rd, year of his age. / In him were combined those virtues / which enoble and adorn the character / of man, truth and honesty of purpose / guided all his actions. He had a rea- / dy and discriminating mind. / When his country was invaded by / vandal robbers from the North, he / was among the first to volunteer in / its defence, and died at the post of hon- / our and duty.

He was a sincere christian and had / been for many years a member of / the Baptist Church.

Blessed are the dead that die in the Lord; the[y] / rest from their labours and their works do follow /them.

As the reader can see, much interestering and significant information has been omitted. The additional space required for complete inscriptions may have increased the cost of this volume. But, it would have been worth every penny of it. Despite this shortcoming, New Prospect Baptist Charch Minutes is a well done book worth the cost even if you don't have any ancestors there. I enjoyed every word of it.

This volume contains abstracts of marriage and death notices from the Caraina Spartan which was published in Spartanburg County, SC. In addition, it contains genealogical information found in probate notices, sheriff's sales, church committee notices, and other lists such as civil court cases and letter lists. Also included are abstracts of court cases. Those cases involving only businesses or corporations have been omitted. No marriage or death notice has been left out—including those for major historical figures such as Robert E. Lee or people residing elsewhere who made news due to the sudden or violent circumstance of their death or any other reason. The latter includes those who may or may not have local connections and is one of the most attractive features of the volume and one I wish more abstract volumes included. This is a much more comprehensive volume than most abstracts which don't include anything beyond vital record notices. This book is a great facilitator to the research process for anyone who is attempting to do research in Spartanburg County during Reconstruction.

This well documented and thoroughly indexed genealogy is the result of nearly 30 years of research by the author as well as 20 additional research years by others. All known descendants of William Nelson West (July 31, 1775 in VA or NC to Oct. 25, 1846, Tallahatchie Co., MS) and his wife Alsey Rogers (ca. 1801 Sumter Co., SC to Sept. 1, 1862 in Smith Co., MS) who was the daughter Shadrach Rogers are included. (A section of the text attempts to untangle the various Shadrach Rogers in South Carolina.) That includes over 4,000 descendants up to the time of publication. (In some instances, there are tenth generation descendants of William and Alsey.) Mrs. Scott has well documented her work and her narrative is well written. A 19 page bibliography of sources is included. Illustrations are profusely provided. This is an excellent book and I'm glad to highly recommend it. In addition to West and Rogers, the more numerously represented surnames include Beard, Brown, Case, Cash, Daughdrill, Davis, Furlow, Gieger, Hargrove, Harralson, Harvey, Hollan, Jolly, Kelley, Kenmore, Maize, Moore, Rogers, Staples, Thompson, Thomhill, Venable, and Weir.

This genealogy traces the descendants of John Michael Kreider (1712-1761) who emigrated to Philadelphia from Germany via Rotterdam, Holland in 1732. (It is possible that he is the same Michael Kreider born to a couple in Bavaria.) He settled in the part of Philadelphia County, PA which was formed into Montgomery County in 1784. While some of his children remained in the Philadelphia area, others migrated to Virginia, Kentucky, and Tennessee and further west and with the passage of time the name became Crider. (One branch wound up in Hempstead County, Arkansas.) The author has traced nine generations of many branches of the family to the present. The earlier generations often include narratives which provide both information and documentation. This volume is fully indexed. It is well worth being a part of your collection
