Will of George Neely

In the name of God amen I George Neely of the State of South Carolina and District of Laurens ... Being of sound mind and memory do make and ordain this my last will and testament in the maner following (to wit) First I direct that after my death all my just debts and funeral expenses be paid out of my estate 2nd I give and bequeath to my beloved wife Margaret Neely for her use as she may think fit and proper during her natural life all of my estate both real and personal 3rd At the death of my wife I give and bequeath to my Sons W.T. Neely G.W. Neely James Neely John G Neely Clayton C Neely for their use during their natural lives and then to their legitimate children the tract of land on which I now live containing four hundred and fifty acres more or less equally divided amongst them without sale an equal number of acres each W.T. Neelys part where he now lives James Neelys part where he now lives Clayton C Neelys part including my present dwelling house G.W. Neelys part where he now lives John G Neelys part adjoining lands belonging to J M Hill 4th I give and bequeath to my daughter Nancy Cannon the right to build and occupy a dwelling house and five acres of land during her natural life on the plantation where I live. 5th I give and bequeath to daughter Elizabeth Neely the right to build and occupy a dwelling house and garden on the plantation where I live during my life of my wife and one bed and furniture and one cow and calf 6th I give to my son Clayton C Neely one horse saddle and bridle one bed and furniture cow and calf. 7th I give and bequeath at the death of my wife the sum of thirty to my son Henry C. Neely 8th I give to my son W T Neely and Ellis Cannon at the death of my wife in trust for the children of Addison Grant my grandchildren the sum of thirty dollars 9th I give at the death of my wife to my daughter Patsy Ling the sum of Ten dollars 10th I give and bequeath to my daughter Margaret Ling one cow and calf 11th the ballance of my estate I divide equally (at the death of my wife) amongst my daughters Elizabeth Neely, Mary Ann Thornton, Nancy Cannon and Margaret Ling 12th I Authorize my executors by and with the consent the consent of my wife to sell all of my real estate not here in disposed of and apply the proceeds to the benefit of my wife during her natural life either in the purchase of a slave or otherwise lastly I do hereby appoint my son W T Neely and Ellis Cannon of this this my last will and testament in testimony of which I have hereunto set my hand and affixed my seal this 31" day of October in the year of our Lord Eighteen hundred and fifty four (1854)

Remarks: It is known from Mathew Mathis's journal (this Quarterly, Volume XIII, p.34) that Hiram Nelson married Sealy Cannon. The marriage date recorded in that old journal was November 30, 1841 in Spartanburg County, SC. The name Sealy is a variation on Celia. Other marriages recorded in Hiram Nelson's Bible were the following:

Remarks: It is almost certain that Hiram Nelson was a son of Abraham and Elizabeth Morrow Nelson. See elsewhere in this issue the family information for Abraham Nelson. One of the unproven entries there is for a Hiram Nelson, born January 22, 1817, which is exactly one year earlier than the birth date recorded above. The probability that two Hiram Nelsons were born exactly a year apart in the same county is vanishingly small.

Columbia, May, 1868.

The defendant, Green McElwee, a person of color, was convicted of petit larceny before Judge Beatty, of the District Court of York District, on the 7th November, and sentenced to three months' imprisonment.

He was indicted with two others, who were acquited, but who the Judge believed were the really guilty parties. This defendant is quite young, under nineteen, and the former owner attests the good

character of the boy.

The Judge in his report commends the party to Executive clemency. I have, therefore, remitted the remaining term of imprisonment on condition that he pay the costs of prosecution and jail fees up to the day of his discharge.

Columbia, November 27, 1866.

The prisoner, Moses Lackey, was convicted of horse stealing before Judge Munro, at Anderson, Fall Term, 1866, and sentenced to be executed on Friday, the 30th instant.

The prisoner was certainly guilty of the offence, and exhibited a dexterity and cunning in its perpetration which was far beyond his years. He is represented to be under eighteen years of age. He was recommended by the Jury, as part of their verdict, to Executive elemency. A petition to the same end has been submitted, signed by over three hundred citizens of Anderson District. The Judge who tried the case, in consideration of the extreme youth of the prisoner, expresses the opinion that it is a fit case for the exercise of Executive elemency.

In deference to the recommendation of the Jury, and the numerous petitions of the prisoner's neighbors, and considering his extreme youth, I have commuted his punishment to imprisonment in the Penitentiary, at hard labor, for the period of ten years from the day he is delivered to the Keeper of the Penitentiary.

Columbia, November 27, 1866.

The prisoner, Ned Williams, was tried before Judge Munro, at Fall Term, 1866, at Greenville, and convicted of burglary. He was sentenced to be executed on Friday, the 14th instant. The burglary consisted in breaking and entering a store, in the night time, whre the clerk occasionally slept, and within two hundred yeards of the owner's dwelling, and stealing some fifty dollars worth of goods. Most of the goods and money were recovered. There is nothing in the case making the crime peculiarly heinous. A petition for a commutation of his punishment to imprisonment in the Penitentiary has been presented, and the Judge who tried the case and the Solicitor unite in the recommendation of the petition. I have, therefore commuted the death penalty to imprisonment at hard labor in the Penitentiary for the term of seven years from the date of his delivery there; to be retained in close custody at Greenville till the cells are ready to securely keep convicts.

Columbia, December 1, 1866

The prisoner, Sarah Calhoun, was tried before Judge Munro, at Pickens, Fall Term, 1866, and was convicted. She was accused of infanticide, and convicted. She was sentenced to be executed on the third Friday in December.

The deceased was her own child, about eight years old. The child was secretly murdered and thrown into a creek. When the body was discovered, a few days after, it exhibited signs of the most deliberate and shocking brutality on the part of its slayer. The child was believed to have been a mulatto. The reputed father of the child, a negro, was arraigned and tried with Sarah Calhoun, the mother of the deceased infant. The testimoney was circumstantial. She was examined on the trial, and denied that she had murdered the child, or had any agency in its murder. She stated on her examination that she had carried the child some miles away from the place of its birth, and had, when eight days old, delivered it to the father; that she did not see the child afterwards; but she persistently refused to disclose the name of the father to the Court and Jury. The negro was acquitted. As the evidence was entitely circumstantial, there is a possibility that she did not perpetrate the horrible deed herself, though the circumstances show she must have had a guilty knowledge of it.

The jury who tried the case recommended the prisoner, as part of their verdict, to Executive clemency. A petition, signed by some of the most respectable citizens in the District, urge tht the imprisonment at hard labor in the Penitentiary for life be substituted for the death penalty. Judge Munro, who tried the case, united in the recommendation. I have, therefore, commuted her punishment of death as follows: That she remain in prison at Pickens until the cells at the Penitentiary are ready to receive convicts; that she be then brought to the Penitentiary by the Sheriff of Pickens District, and delivered to the Keeper thereof, and that she be confined there at hard labor for and during her natural life. [Note: This prisoner, after remaining jail at Pickens nearly two years, was, on 25th April, 1868, pardoned.]

Your Petitioner Madison Neely a citizen of York District residing in the 46th Regiment of South Carolina Militia, showeth that he is fifty years of age has a wife & eight children-his oldest son is a soldter in the confederate army-his other children reside with him of these six are girls and one about three year of age a boy. Petitioner is very poor owns no land nor slave nor horse-is destitute of money or provisions and his family are sholly and entirely dependent on his labor for their support. For the last two years he has followed the business of an overseer his wages have supported his family. He is engaged for the present year as overseer on the plantation of F. H. Brown and petitioners family reside on said F. H. Browns premises. If Petitioner is sent to the army not only will his family be deprived of the means of subsistence by the stoppage of his wages but also of a home as his employer will need the house in which they live for whomever he may employ in Petitioners place. If Petitioner has to leave, his family must suffer for the necessaries of life and he respectfully asks to be exempted from service as one of the Militia beyond the limits of his District and detailed for the support of his family the ever will be.

ROBERT TURNER'S LETTER TO GOVERNOR A. G. MCGARATH

To his Excellency, Gov. A. G. Magrath. South Carolina

Regiment So Car Militia, showeth that he is fifty one years of age-is a farmer by occupation owns a tract of land in said District whereon he resides and has thereon eight slaves [illegible word] of whom belong to himself & two of whom are hired for the present year. With Petitioner resides his son about twenty one years of age and a small boy about ten years old. No other white persons reside with him. His said son in conswauence of fits to which he has been subject from birth is incapable of attending to managing Petitioners farm. He is able to labor somewhat but said fits attack him at irregular periods to prevent him from giving that attention to the farm that is necessary & proper. His said son has been exempted from Military Service in consequence of said fits. Three of the slaves on petitioners plantation are field hands & they together with Petitioner & his son when able, work his farm. W. M. Sutton Petitioners brother is a soldier in the confederate army & on his plantation about a mile distant from Petitioner reside his daughter about sixteen years of age & his two sons aged one about eleven & the other about nine years old--with them live Petitioners mother seventy four years of age. Said W. M. Sutton owns one negro man. Petitioner therefore has managed the farm of said W.M. Sutton & will do so during the present year if permitted to remain at home. The only horse said W. M. Sutton owned has lately died and his farm must cease unless Petitioner can provide a horse to work his crop, which he intends to do if possible. Petitioner now hauls fire wood and in various ways helps & assists his said mother & the family with her. Petitioner gives a general attention to the business affairs of the families of many soldiers in his neighborhood, buying and selling for them many articles preserving these supplies & land he is sure his services in said matter are highly advantageous. He is one of the Commissioners of Roads for York District and in addition to his other duties, has to return within his division all male slaves liable to road duty and when required by the State agent, return those of them liable to labor on the fortifications on the coast. This he has found to be a troublesome & onerous duty. He feels sure he can do more good by remaining at home than by any Military service he can render. He therefore respectfully asks to be exempted from military services beyond

Carolina, for the purpose of being declared exempt from State Military service, and of being detailed to support his dependent family, respectfully represents, that he is in the fifty second year of his age-that his wife is dead-has five children alive-two of his sons having died in the military service of their country, and these were your petitioner's main dependence for the maintenances of his family-the oldest child now at home is a daughter nineteen years old-his oldest son at home is fifteen-his youngest child is four years old-this daughter above mentioned is in very delicate health, your petitioner being convinced that she is laboring under excipient consumption. Your petitioner owns a small tract of poor land, no slaves & posses a very small portion of worldly substance-is indeed a poor man, and his daily labors are absolutely necessary to providing his family with the common necessaries of life and that suffering and want will be the inevitable destiny of his children if he be made to leave them, & to enter military service. Your petitoner's father & mother are dead-he has only three brothers-two of these are in active military service-the other is at home on a short furlough-two of these brothers are married, and neither is able by their means, to render any assistance to your petitioner's family, all being as destinute of worldly goods as your petitoner. He avers, that he has not now corn enough to bread his family, and missed raising a wheat crop almost entirely. He morever, is not in the enjoyment of good health being much afficted with pains, but refers your Department to the Certificate of his physician, of which the following is a true copy:

"I have attended Robert Turner. He suffers at times with acute Lumbago. He also has a nervous afflection, which produces general wakefulness. He has tried military service & broke down. I would recommend him to your consideration in applying for an exemption.

This certificate, when considered in connection with the other facts of your petitioners case, especially as to the loss of his wife-the afflicted state of his oldest daughter-the great necessity for his daily labors for the support of his family-and the absolute certainty that destitution and want and suffering will fall upon his children, if his labors be withdrawn, your petitioner hopes, will not only substantiate his feeble situation as to bodily health, but make his request both reasonable & proper.

Contributed by Jim Crocker, 210 Scenic Circle, Boiling Springs, SC 29316. The following appears to be a family cemetery. It is located on the left side of Henderson Road, near Chesnee, SC. The cemetery is about 200 yards from the North Carolina state line. There are three graves side by side, and each plot is outlined with an ankle high concrete barrier. The oldest graves there are the Robbins' graves and hence the name Robbins Family Cemetery.

This grave has no headstone. It does have a simple metal marker that is inscribed: Lewis M. Coffey 1929-1993 - McKinney-Landreth Funeral Home

This grave has a metal marker identical to the first grave: It reads: Gail C. Mason 1942-1991 - McKinney-Landreth Funeral Home

The final grave is also marked with a cement slab standing on end. It is apparent that while the cement was still wet, someone wrote in it so as to make a headstone. The numbers and letters are uneven in size and shape and are poorly spaced. However, it appears to be a labor of love and devotion by someone that was not able to provide a better stone. The inscriptions read:

In ca. 1734 NEILL McDONALD owned over 2,000 acres in the Berkley District of SC. I have to find out why my grandfather was named NEILL, as he was a firstborn son. Other names in my line are WILLIAM and CHARLES. Will be glad to hear from anyMcDANIEL/McDONALD of NC/SC. I have a great 20-year-accumulation of McD/McD NC/SC records and can be of help. Lanham, as Master v Haynes (85 S. E. 966.)

Before Sease, J., Spartanburg, December, 1914. Reversed.

Rule to show cause issued at instance of S. T. Lanham, as master, against John S. Haynes, to compelcompliance with his bid at master's sale. From an order directing compliance, the purchaser appeals. The facts are stated in the opinion.

Messrs. Carson & Boyd, for appellant, submit: A trust is an estate in property held by one for the benefit of another: (etc. etc.)

Messrs. William M. Jones and Nicholls & Nicholls, for respondent, submit: None of the beirs of Barnell High, except those parties to this action, nor their ancestors, have been in possession of this land for over forty years: Code Civ. Proc., sec. 134;76 S. C. 432.

July 31, 1915

The opinion of the Court was delivered by Mr. Justice Watts.

This is an appeal from an order of Judge Sease made in a rule to show cause upon an application of S. T. Lanham, Esq., master for Spartanburg county, against John S. Haynes why he should not comply and to complete his purchase of a tract of land bid off by him at a public sale of said land by the master. Haynes made return to the rule and averred his readiness and willingness to comply with his bid and pay for the property, but when he employed cousel to examine the title to the said property, that he was advised by them, that the title was not good, and for this reason he refused to comply with his bid, and desired the Court to pass upon the title, and if it is adjudged good and valid he is ready to comply with his bid. It appears that the sale was made in a partition proceeding among the descendants of Frances Turner and that the title came to them from Burnell High, through the following deed:

"State of South Carolina, Spartanburg District. Know all men by these presents, that I, Burnell High, of the district and State aforesaid, for and in consideration of the love and affection I have for my daughter, Frances Turner, do grant, give and release unto my daughter, Frances Turner, a certain tract of land lying and being in the district and State aforesaid, on Standing Stone, a branch of Lawson's Fork, containing one hundred and ninety-six (196) acres, more or less, adjoining lands of Anderson, Bishop, W. P. Bishop, I. R. Poole and others, with all the appurtenances thereto appertaining, and also the crop of all descriptions during her natural life, free and unincumbered, not subject in anywise to the debts of her husband (or any future husband), Henry Turner, and at her death it is to be equally divided between the children of her body, share and share alike, a child or children of deceased child to represent his or her parent. But if she, the said Frances Turner, should die without children, then, and in that case, the said land is to revert back to my estate. I do hereby appoint and consitute Wm. G. High as trustee to manage the tract of land and products above mentioned for the purpose set forth in said deed of trust.

Whereunto I set my hand and seal this 13th day of September, 1860. Burnell High. Signed, sealed and delivered in the presence of M. T. McKinney, John Tuck."

"State of South Carolina, Spartanburg District. Personally appeard before me, M. T. McKinney, and made oath that he saw Burnell High sign, seal and deliver the within deed of trust for the use and purposes therein contained, and that he, with John Tuck, in the presence of each other, witnessed the due execution thereof. M. T. McKinney. Sworn to before me this 13thSeptember,1860. J.B.Tolleson, Clerk and Magistract ex officio."

He alleges that under this deed Frances Turner took only a life estate, and that at her death the property went to such children of her body as were in being at the time of the execution of the deed to take only a life estate; that the parties to this action are the children of her body, or their representatives, and that this sale conveyed only the life estate of such children as were in being when the deed was made September 13th, 1860; that at the death of such children the title reverts to the heirs of Burnell High, many of whom are not parties to this action.

His Honor, Judge Sease, construed the deed to be a trust deed, not to be constured by the strict technical rules of the common law, but by the intention of the grantor, and that it was the intention clearly of the grantor to convey the whole estate in land to Frances Turner for life and to her descendants, if she left any surviving her, and to have the land revert to his estate only in case of her dying without leaving heirs of her body a specified in the deed, and as she left surviving her such heirs of her body there is no reversion, and the estate of Burnell High has no interest in the land, and he adjudged and decreed that the rule be sustained and defendant, John S. Haynes, be required to comply with his bid. From this order defendant appeals, and alleges error on the part of his Honor, in holding that the childrena dn grandchildren of Frances Turner took any estate in fee in the land conveyed by Burnell High to William G. High; and in not holding that the surviving children of Frances Turner took only a life estate under said deed and at their death the land reverted to the estate of Burnell High.

Respondent's attorneys served notice they would ask that the order of Judge Sease be sustained on the additional ground that neither the heirs of Burnell High nor their ancestor or grantor have been in possession of the land within forty years, and that they would be barred by section 134 of the Code of Civil Procedure from bringing action to recorver the land or any interest therein.

The appellant's exceptions must be sustained. There are no words of inheritance in the deed at all. There can be no conveyance of a fee without the use of the

- word "heirs," and no other words are susceptible of being construed into a conveyance of the fee regardless of the grantor's intention or the consequences to grantees or heirs. Under the term of the deed
- neither is there a conveyance of the fee nor is the instrument of conveyance a trust deed. Under this deed neither Frances Turner nor her descendants took any estate greater than a life estate. Frances Turner
 - under the deed took a life estate; at her death her children and granchildren took an estate for life, and as far as this deed is concerned, and under it, the respondent here has no title in fee simple that the master could convey to the appellant, and appellant should not be required to comply with his bid. The respondent does not show under the deed he claims a fee simple estate that may be conveyed. He may have a fee simple title from other sources, but that is not before the Court. There is no question that the title tendered is defective. The additional ground relied on by respondent has no application here and cannot avail the respondent.

Judgment reversed.

With the exception of real estate transfers, none of these items are included in the index at the deed office in Spartanburg or at the South Carolina Department of Archives in Columbia, South Carolina. Therefore, the abstracts and full name index found in this volume are especially useful to the researcher.

The book is hard bound and consists of 240 pages and has a full name index.

This book has over 800 surnames. In addition to individuals, the index also includes creeks, rivers, roads, churches, corporate names and even family cemeteries. If you think you have exhausted these records, you will be surprised at what new information awaits you in this book.

Some Spartanburg County Cemeteries, compiled and edited by Joseph R. Gainey 130 pages, indexed. Soft Cover

Unlike other cemetery books, this one is crafted to meet the genealogist's needs by paying special attention. to the plot and row arrangement of the graves. It presents transcripts of 58 Spartanburg County cemeteries in their entirety. Among the churches presented are Philadelphia Baptist, Bethesda Baptist, Concord Methodist, Mount Carmel Methodist, New Hope Methodist, and North Pacolet Presbyterian. In all, 21 churches, including 7 extinct ones, are published. Also, 34 family cemeteries, and 3 community and private cemeteries appear here.

Marriages From THE CAROLINA SPARTAN Newspapers 1866-1869, compiled and edited by Faye Berry Emory 27 pages, indexed. Soft Cover

This is a complete listing of 1866-1869 marriages found in THE CAROLINA SPARTAN, a Spartanburg, South Carolina newspaper. Although these marriages are found in Spantanburg newspapers, they are not confined to that area. Many pertain to persons living in other counties of South Carolina and a few concern persons living in other states.

The Descendants of James Crook and Related Families 1746-1978, compiled and edited by Martha King Neubauer \$50.00 463 pages, including 63 page index

The society has acquired the 28 remaining copies of this detailed study of the James Crook family of Virginia and later Spartanburg County, S.C. However, the late Mrs. Neubauer did not limit this work to this particular family. She included information on other branches of the Crook family in England and America. She also included pictures of tombstones and various Crook homes. The second part includes information on the following related families: Anthony, Bane, Barry, Brockman, Burk, Coleman, Evins, King, Mann, Newman, Patton, Stallworth, Travis, and White families. "Bits and Pieces" (Part III) is an abstract from records of persons of the same sumame, but with whom no proof of relationship had been established.

Faye Berry has abstracted the information found in the 1820 federal census for the over 1,500 families then living in Chester District. (Included in this volume are 14 families headed by "hee persons of colour.") This volume eliminates the need of sitting in front of a microfilm viewer to find your ancestor's family here in 1820. It is a great research aid presented in a easy to use size and format.

The History of Mount Zion Church and Her People, by Dr. J.B.O. Landnum, edited by Joseph R. Gainey 17 pages plus index, soft cover.

This is a republication of a 1885 volume on Mount Zion Baptist Church, near Inman, Spartanburg County, S.C. It traces the church from its establishment as a mission of Bethlehem Baptist in 1804, through it organization in 1827, up to the history's publication in 1884. This volume, though small in size, contains a wealth of information, both historical and genealogical, on Mount Zion and its early members.

The Tie That Binds, by Joseph R. Gainey. 135 pages, flustrated, soft cover

This book is a history of the Carlisle Wesleyan Church located in Spartanburg County, South Carolina. It contains many pictures and extensive genealogical notes on its early families. It also contains miscellaneous data on the community.
