

OLD PIECE OF CLOTH FROM AN OLD SPINNING WHEEL

Editor's Note: The following article was published in the Tri-County News, a monthly newspaper edited by Mr. Watson. It existed for about one year during the late 1958s. It is hoped that Mr. Watson will contribute other such interesting articles from this source.

Mrs. Zelline Hill Watson of Hobbysville, is the proud owner of a piece of cloth, woven at Hill's Mill more than a hundred years ago. Mrs. Watson received this cloth from her father, the piece being much larger at one time since she has given samples to textile mills in this county. Her son, Russell Hill, carried a piece of the cloth with him to Clemson College when he was studying textiles there.

The piece of cloth is very thick and durable and was woven from cotton raised in Spartanburg County, and it is unbleached.

The mill which made this cloth was established by Leonard and George Hill, William B. Sheldon and John Clark in 1816 or 1817 with 700 spindles when it started. When Leonard Hill died, ownership of the mill was taken over by his four sons, James, Albert, Whipple and Leonard. In 1845, Whipple and Leonard retired and sold their interest to James and Albert who continued operation of the plant through the War Between The States.

The plant started operations as a spinning mill and the yarn was sold to settlers in the area who made homespun from it. Many people from the surrounding area went to see the factory.

Leonard Hill, George Hill, William B. Sheldon and John Clark all came to this section from near Providence, Rhode Island, and decided to cast their lot with the people of the "Old Iron District." There were others in the party that came South. William Bates and John Weaver were two other men. Bates went further into Rutherfordton County, North Carolina, where he erected a building and began to spin cotton into yarn, and John Weaver drove down stakes and began the same business on the banks of Beaverdam, near Oneall, South Carolina.

History tells us that Leonard Hill, George Hill, William B. Sheldon and John Clark were master mechanics and manufacturers, and that they went to work in earnest to erect the mill, afterwards to be known as Hill's Factory, Leonard Hill being chosen as foreman or business manager. All the machinery had to be conveyed by wagons from Charleston through scantily settled country when public highways were much neglected.

Mrs. Watson is the widow of the late Russell Watson who for many years before his death served as a rural mail carrier. She has one son, Russell Hill, who now lives in Morganton, North Carolina.

Samuel Downing, of Saratoga county, New York, the last living soldier of the Revolutionary, is threatened with a visit from a Congressional Committee.

THE STORY OF MT. BETHEL CHURCH by Sara Sullivan Ervin

Mt. Bethel Methodist church, at whose shrine hundreds and thousands have worshipped God and passed on to that reward for the faithful, is well past the century mark in age and one of the most historic locations in the upper Carolinas. The church is situated between Reedy and Saluda rivers in Sullivan Township, Laurens County. (Laurens County itself is now 133 years old). Not far distant is the ruins of an old Indian village and also a lead mine where bullets were made during the Civil War. It was also near this spot that "Old-timers" say the first skirmish of the Revolution took place between Bloody Bill Cunningham and the patriots.

Mt. Bethel is surrounded by a grove of ancient oak and pines that have watched over the church since infancy. In the rear of the church at the foot of a hill, is the famous Mt. Bethel spring, bubbling about 608 gallons of water per hour. It is about eight feet square, six deep and outlined by huge native rock. There is a legend that the Indians used to bring their sick to these sweet and healing waters. We are told that in the early days of the church, the water was analyzed and found to contain forty different mineral properties. Local people know its value and the sick ones drive out each day to drink at the spring or else keep jugs of the water in their homes.

In the long ago, it seems that a vacant building first was used as a church and the planters arranged for a preacher to visit the community at intervals to hold sevices for their families and slaves. We are told that some of the early Bishops of the Methodist Church in America were among these first ministers to visit Mt. Bethel community. The ladies and gentlemen from the big plantations in a radius of twenty miles attended these services, coming by horseback, fording the streams and following trails through the woods.

In those days the distance from saw mills made the question of erecting a church a serious problem, but the men of the community went to work amd hewed timber out of the large forest trees nearby and performed all of the work of putting up a building by hand. A unique feature was the "sound-board" which was formed by two large beams placed overhead holding the plates in position.

The cemetery is located on a sunny slope about 100 yards from the church. Here lie buried the many faithful who have found the Holy Grail of knightly quest and been gathered unto their fathers. The oldest graves in the cemetery have been there beyond the knowledge of any living man and are marked with plain stone slabs, the lettering on them being undecipherable. The oldest date we can read is 1818.

The present church was organized in 1825 and was part of Laurens and some of Newberry and Greenville counties. The South Carolina Conference embraced the territory between the Cape Fear river in North Carolina to the Alabama state line. At first the

church was served by a "circuit-rider," a preacher who, mounted on horseback and equipped with the saddle-bags, traveled continually, preaching every day in a different community. The first regular pastor was Barnett Smith.

A school building stood near the church and the spiritual and educational forces thus represented together, upheld the highest

ideals and molded family and community life.

In 1851 a larger chruch was constructed, Rev. Samuel Townsend was pastor at this time. In 1854, a permanent camp ground for protracted services was established. Tents in which the people camped, were arranged around a square and a large harbor(sic.) was built in the center, where services were conducted. These sometimes continued for three or four weeks. A day at the camp ground went something like this: At dawn the trumpet sounded to rouse the encampment. It sounded again at sunrise for family worship in the tents and at eight and eleven A.M. and three P.M. for sevices under the harbor [arbor?]. At night the grounds were lighted by "fire-stands". The encampment was incorporated and controlled by police regulations. Until about 1890, Mt. Bethel camp ground was the mecca of throngs from all over the country, often numbering 1,500 or more, who came yearly to this sacred spot to worship God and incidently to hold a reunion with other devout Methodists or perhaps to drink of the healing waters of the old spring.

In 1865, Mt. Bethel was cut off from the Laurens circuit and with Lebanon, Bethesda, Bethlehem and Kings Chapel, formed the Reedy River circuit. About 1869 it became known as the Tumbling Shoals

circuit.

The first Sunday School in the church building was organized in 1842 with G.B. Riley as superintendent and has continued active until the present time. Capt. J.B. Humbert served as superintendent for fifty years and Capt. W.D. Sullivan was teacher of the Bible class for almost as long. It was a woman, Mrs. John Humbert, who kept the Sunday School going during the dark days of the Civil War.

In 1890, the name of the circuit was again changed and became known as Princeton.

Members of Mt. Bethel church have supported the oldest colleges of the South and have served their country well, in times of peace as well as war. They have ever been ready to pray for her, work for her as the need might be. In looking over the church roll down the years, we find all along the line names of many of the outstanding leaders of this section--men who helped build and develop this part of the country.

On the occasion of the centennial celebration of the church, scores were brought together who had been affiliated with Mt. Bethel in the past and who considered it a unique privilege to take part in this grand reunion or home-coming. Among the speakers were Hon. J.J. McSwain of Greenville, Dr. D.W. Daniel of Clemson College, Dr. J.C. Clinkscales of Wofford College, John B. Humbert of Seneca, W.D. Sullivan of Tumbling Shoals.

Some of the families that have been connected with the church during its history are as follows: South, Eppes, Humbert, Wood, Sullivan, Taylor, Arnold, Riley, Stone Gambrell, Carter, Sharp, Henley, Medlock, Abrams. The McCulloughs, Martins, Daniels, Babbs,

Smiths, Kilgores, and others have also been closely associated with Mt. Bethel.

The years slip by, and instead of the colorful and picturesque gatherings in the early days, new scenes are unrolling on the moving scroll of time. Mt. Bethel today has a thriving Sunday School, drawing its members from a radius of six miles. The church now, as in the past, is a dominant influence in the religious and social life of the community.

SOME OF THE FOREFATHERS OF ANDERSON COUNTY

One of the earlier families in the country was that of Peter Acker. The founder of the family in America was William Acker, who came from Germany about 1750, having started with three sons, one of whom was lost overboard on the voyage. The two left were William, Jr., and Peter. They settled in New Jersey, not a great distance from Philadelphia. Of the elder, William, Jr., nothing is known by the southern branch; it is supposed that he lived, died and left descendants in New Jersey.

The other son, Peter, with his wife, Jane Southerland, moved to Fair Field, South Carolina. He, too, may have descendants in New Jersey, as Jane Southerland was his second wife. He may have left older children in the Northern State.

Peter was a soldier in the Revolutionary War. He must have settled on the public domain in Fair Field, for no record can be found of his owning property there. In 1790 he moved to Pendleton District, buying many acres on Saluda River, near Shady Grove. Peter Acker died about 1815.

The father of Mrs. Peter Acker, Alexander Southerland, came to America under peculiar circumstances. He was a student at the University of Edinborough, and with a party of college boys one day boarded a vessel to see the sights. The ship sailed away with them, and upon reaching Boston the students were sold to pay their passage. Southerland must have liked the new country; at any rate, he remained and later married Mrs. Betsy Williams.

The children of Peter Acker and Jane Southerland were William, who married Miss Clement, Joseph, who married Ruth Alexander, Peter married Susannah Halbert, Alexander married Orma Burton, Mary married James Grace, Nancy married John McDavid, Elizabeth married James Taylor, Susan married Sanford Vandiver, Amos married Ruth Halbert.

The children of William and Clement were: Mahala married Welborn Keaton, Peter married Miss Stevenson, Rhoda married Daniel Brown, William married Miss White, John married Miss Harper, Dearborn, married Miss Cox, Amos married Miss Davis.

From Rhoda Acker and Daniel Brown are descended the family of the late Dr. Ben Brown, of Williamston; the late Elijah Brown, of Anderson; the late Samuel Brown, of Anderson, and others, a numerous connection many of whom have been in the past, and are now usful and prominent citizens of the community.

The children of Peter, Jr., and Susannah Halbert were Halbert, who married Elizabeth Garrison; Frances married William Hammond, Alexander married Mourning Garrison, William V. died young, Elizabeth married William Mattison, Mary married Joel Townsend, Teresa married Allen McDavid, Lucinda married Jesse McGee, Peter Newton married first Miss Shumate, second Miss Garris, third Mrs. Caldwell; Joel Milton moved to Mississippi where he became a judge, and was the founder of a wealthy and prominent family in that state; Joshua S. married Matilda Williams. From their sons, Peter and Amos, are descended most of the South Carolina Ackers.

Susannah Halbert, wife of Peter Acker, Jr., was the daughter of

William Halbert and Elizabeth Hill. William's father, Joel Halbert, came from Wales and settled in Virginia. Whom he married is unknown, a Virginia girl certainly, as tradition makes this William Halbert eighth in descent from Pocahontas, and also related to the Randolphs of Virginia. William was born in Virginia. In 1768 he married Elizabeth Hill and in 1786 they moved to Pendleton, settling on the Saluda River. William Halbert died in 1808, leaving to his wife and to each of his children 200 acres of land and several negroes. He was a staunch Whig, and served in the army of Virginia. After coming to South Carolina he became a man of prominence in his community; served as justice of the peace for many years. He was about five feet nine inches in height, of stout build, and had ared beard. His children were Joel, Martha, John Enos, Arthur, James, Susannah, Frances, William, Joshua, Elizabeth, Mary and Lucinda. Most of these children moved west, and today there are thousands of Halberts in Mississippi, Indiana, and other western states, but in South Carolina there is not one of the name. Joel married Mary Lindsey and went to Indiana in 1819. His daughter, Sarah, married Moses Welborn, of Anderson county. Another, Ruth, married Amos Acker, youngest son of Peter, Sr., and Jane Southerland. This couple lived at Williamston. One of their sons, "Squire" R.V. Acker, was living just a few years ago. They have many descendants who are valuable citizens, among them Mrs. D.H. Russell and her children. Martha Halbert married John Gresham, and from them was descended

Governor Joe Brown, of Georgia.

John Halbert married Margaret Harper and moved to Mississippi.

Professor Harper, of Clemson College, is descended from them. Enos married Lucy Garner and went to Tennessee; James married Fanny

Pepper and went to Missouri, Susannah married Peter Acker, Frances married Charles Garrison; they remained in South Carolina. Arthur

married Elizabeth Cobb.
William Halbert, Jr., married Betty Brown and went to Alabama.
Elizabeth married William Berry and went to Mississippi, Mary
married John Sherrell and went to Missouri, Lucinda married David
Berry and went to Mississippi.

The children of Alexander Acker, son of Peter, Sr., and Orma Burton, were George, Cecil, Mary, Elizabeth and Peter Wilson. Mary married Mr. Grace; they had a son, Baylis. Nancy Acker, daughter of Peter, Sr., married John McDavid; they were the parents of Lucinda, Richmond and five other children.

Susan Acker and her husband, Sanford Vandiver, were the parents of Helena, Peter, James, Emmaline and Hezekiah. Helena married Samuel Brown and lived in Townville; their children were: John Peter married Julia Reed, Joseph Newton married Elizabeth Bruce, Milton married Emma Farmer, Emma married Mr. Feaster, Samuel F., married Mollie Lewis; he died in a short time and his widow married Colonel C.S. Mattison, Sanford married first Maggie Longshore, second Ella Smith.

The youngest son of Peter, Sr., and Jane Southerland was Amos, who married Ruth Halbert. Their cildren were Mary, who married Humphrey Williams; she died and he married her sister, Elizabeth; then he died and his widow married Alfred Reed. Martha married James D. Smith, Halbert married Mary Marsh, Alfred S. married first Miss Martin, second Miss O'Rea; Joseph married Nancy Sitton, Elihu H.

never married, Teresa married James Reece, Sallie married Jackson Surratt, Richmond V. married Delia Roper, Susan died young.

The Acker-Halbert reunion in Anderson takes place at Shady Grove Church, where the early members of the families worshiped, many of them being buried in the adjacent grave yard.

Another old Anderson county family is the Milford. Seven Irish brothers of the name came to South Carolina before the Revolution and served through the war. Thomas stopped first in North Carolina where he married Miss Jamison, later he, too, joined his brothers in South Carolina. They settled in what is now Abbeville county. Rebecca, a daughter of Thomas, married a son of John Milford, whose name was also John. One of their sons was C.S. Milford, born in Anderson county, where his parents made their home. In 1852 they went to Pickens, settling where the town of Westminster afterward grew up. Mr. Milford bought two hundred acres of land from J.D. Kay at two dollars per acre.

C.S. Milford married Miriam Addis December 1st, 1853. They were the parents of six children, Samuel Marshall, later of Kansas City; John Thomas died young, Clayton Jones went to Lovonia, Ga.; Eliza Jane married W.F. Wooten, of Corner Township; Albert Calloway, of Anderson county, Charles Arlington, of Abbeville. Mr. Milford bought three hundred acres at one dollar an acre from Robert Steele, state senator from Pickens district, and with his bride went to live on it. He became a soldier if the Confederacy.

In 1779 Thomas Martin and his wife, Hester Roundtree, left Martins-ville, Va., and came to South Carolina. They had several little children, and creeping slowly forward in heavy carts, it was a long journey. In those pioneering days when night fell parties traveling the same way would often camp together for mutual protection. All provisions had to be transported with them, save what game they could kill on the road, and an occasional purchase made of the few farmers whose homes they passed.

At the beginning of the trip Mr. Martin promised to give two dollars and a half to such of the children as should make the whole journey without crying. Mr. Martin's children appreciated to the full the generous offer, and valiantly they strove to win the reward. But they were very little, the journey was very long, and they encountered many hardships, including winter weather; and children have always had nerves, though our forefathers scouted such attributes for small people. One by one the little folks succumbed to trials and miseries, until all but Jacob, the eldest, had lost the coveted prize. That little lad wanted \$2.50 very much indeed. It was a big sum of money, and probably he had never in his life had so much of his own. Not a tear had fallen from his bright eyes, and the journey was almost over. One day toward the very end Jacob was seated high upon the stack of domestic goods and the heavy wagon was creaking, grumbling, and painfully rolling along over the dreadful roads, mere trails through the woods, the trees hanging low over the path. Passing under one of the sweeping branches, whoever held the reins that day reached out and pushed up the swinging limb. It could not have been the father for fathers remember their little ones, and that driver forgot the boy perched aloft; as he let go the branch it swung back, striking the lad severely about the face and head, and poor little Jacob, startled

and frightened by the sudden stinging pain, as a little boy could not help doing, lost his coveted prize.

The family settled in what is now Williamston township, a mile or two east of where Piercetown is located. Big Creek church was their place of worship. There were nine children in the family who grew up. What education they got was from small country schools in their vicinity.

In later years William, a son of these early settlers, gave the site of Beaver Dam Baptist Church, and was prominently connected with it for many years.

The children of Thomas and Hester Martin were Jacob, who married his cousin, Cathrine Martin, from Edgefield. The mother of Cathrine Martin was a Rowan. The second son of Thomas and Hester was William, who married Elizabeth Duckworth, then came Charity, who married Ezekiel Murphy. James L. Orr, Sr., once said of Mrs. Charity Murphy that she was a wonderfully bright old lady. When she was over seventy years of age, he had occasion to see and hear her examined as a witness in a property case which involved twenty or thirty thousand dollars. Mrs. Murphy, though her educational advantages had been limited, showed a brilliant mind. She was catechised for four hours, lawyers bandying words over her; some of them in their usual style making every effort to confuse the witness, or to trap her into making contradictory statements. But their attempts were futile; she answered clearly and intelligently through the whole time. She told what real estate, live stock, and all other property involved had sold for so accurately that when it was over and her statements were compared with written records the difference between the two did not amount to so much as one dollar.

The next child of Thomas and Hester was Mary, called Polly, who married Thomas Welborn. Then came Abram, who married Ruth Duckworth; Frances, or "Frankie," married Baylis Watkins, Elizabeth married James Wilbanks, James married Mary Gregg, of Newberry, and Chesley married Annie Duckworth. These couples all settled in Anderson county, except the Wilbankses; and from them are descended many of the people of the county.

A daughter of Charity Murphy married a Mr. Richardson, and they were the parents of the late Matthias and A.N. Richardson, of the Lebanon section. The family furnished a number of soldiers to the Confederacy.

When the Reverend John Simpson came to Pendleton his eldest daughter, Jane was eight years old. When she grew up she married and returned to the Fishing Creek section from whence she had come. One of the sons, Dr. James Simpson, married a daughter of Colonel John Bratton, another married a daughter of Colonel Pickens, one daughter married Colonel Moffatt, a Revolutionary soldier, from whom Moffattsville took its name; two of the daughters married into the Sadler family, which along with the Simpsons had moved from to Pendleton.

Jane's first husband was James Neely. They had one son, John, who died a young man, though he had married, and left several children. Jane's husband, James Neely, died after a few years, and she married John Boyd.

Other children of Reverend John Simpson remained near the old Pendleton section of the country. The late Mrs. R.F. Divver was a descendant of that pioneer preacher, and the Simpsons have added much to Anderson county. Mrs. Emmie Cathcart and Mrs. Lila Sullivan are also descendants of the family.

The original McFall in this community was John, born at Craig's Head, Antrim, Ireland. Having quarreled with his stepmother, he ran away to sea, landing at Charleston, S.C., in 1784, when he was about sixteen years old. He went to work and became a good busi-

ness man, owning quite a comfortable property.

Early in the history of Anderson county Mr. McFall became one of its citizens. He possessed a number of slaves and a good plantation near Neal's Creek Church. He married the daughter of another early settler in the community, Miss Mary Norris. Mr. McFall was a proud, rather haughty man, generous and hospitable, and always immaculately dressed, wearing a snowy shirt adorned with ruffles, sometimes lace-trimmed. He was proud of his ancestry, and claimed descent from Mary Queen of Scots.

Mr. McFall left three sons, John, Andrew and Samuel. He and his wife are buried in the Neal's Creek cemetery. Their descendants are among our best people. Those of the name are well known; there are some, however, who bear other names, among them Mr. John McFall Hubbard and Miss Nora Hubbard, to both of whom one collecting Anderson county data has to make frequent appeals, as they know much

and remember well.

The name Clinkscales is found everywhere in the Piedmont section and especially does the family seem to belong to Anderson county. Professor John G. Clinkscales, of Wofford, a scholar and writer of ability, is an Anderson county man. Mr. Fleetwood Clinkscales was for more than fifty years a newspaper man in the town. A youth in 1854, he began as a compositor apprentice in the office of The Southern Rights Advocate. When The Anderson Intelligencer was founded in 1860, Mr. Clinkscales became associated with it. He remained with the same paper until advancing age forced him to retire from active work. Dr. Clinkscales and Mrs. E.W. Masters are members of the family well known to Anderson people.

DEATH OF A CENTENARIAN

The Yorkville Enquirer announces the death of Mr. Francis Henry, of that District, who attained the unusual age 101 years. Some incidents of his boyhood and youth are full of interest, as belonging to the historic period of the Revolution. When about fourteen years old, he was frequently employed by the whigs, in the capacity of a messenger to convey information from one settlement to another, concerning the movement of the Tories. On the day after the battle of King's Mountain, near which locality he was then living, he, in company with others of the neighborhood, visited the battle ground and assisted in attending to the wants of the wounded. During his whole life, Mr. Henry enjoyed remarkably good health, having never been confined to his bed by sickness, until within ten days of his death, and having never taken a dose of medicine in his life.

WILLIAM HENDRIX, PIONEER FOUNDER OF ABNER CREEK BAPTIST CHURCH By Lorene Burton Barnett

Have you ever wondered who was the first white man to be born within the boundaries of Spartanburg County? According to A.T. McHugh's History of Abner Creek Baptist Church (1904, p.29) it was William Hendrix. He was born in 1754 in a cane brake while his parents were hiding from the savages. (According to his tombstone he was born in 1766.)

My first "personal encounter" with William Hendrix occurred on December 15, 1966. The Late Mrs. N.T. (Agnes) Clark and I visited a log building -- formerly the Abner Creek Church building -and cemetery. Our host was Mr. Jefferson Olice Hendrix, a greatgreat-grandson of the original owner of the property. (Mr. J.O. died about 5 years ago, but Mrs. Hendrix, who turned 90 on July 4, 1983, still lives. I talked with her recently and she is still

very alert and has a keen mind.)

Mr. Hendrix very cordially told us about the church and the cemetery. He said that there once were more tembstones than those of William and Sarah Hendrix which are the only remaining marked graves. While looking at his great-great grandmother's stone, he remarked that her name may have been Elizabeth. Mr. Hendrix took us inside the fence to copy the stones, and he "shooed" the cows away from us as we did this. We found the old church building in remarkably good condition for its age. He told us it had been removed to its present location from the pasture and a barn had been built onto it.

Sixteen years have passed since my first visit to this site. I recently took Faye Emory and Joe Gainey here. We found the two extremely large tombstones fenced with heavy logs. The inscriptions are as follows: William Hendricks born Sept. 9, 1766 died Oct. 22, 1842 aged 76 yrs., 1 mo., & 15 days and Sarah, wife of William Hendricks, born June 7, 1767 died Feb. 7, 1849 aged 82 yrs., 4 mos., & days.

Being puzzled about the spelling of the surname, I asked a descendant, Mr. F.E. Hendrix, son of J.O., about it. He said that some of William's descendants spelled their name Hendricks while others spelled it Hendrix. He also stated there has been a

William in each generation since the first one.

The first William's son, William Hendrix, (Aug. 25, 1793-Mar. 31, 1876) wed Charity (Mar. 27, 1792-Oct. 17, 1887). She was a Methodist, so, I suppose this is why he is buried at Wood's Chapel United Methodist Church although Abner Creek Baptist Church was begun in his father's house. A William Hendricks was an appraiser of the estate of Barnett Dempsey in Spartanburg District on October 6, 1814. Thomas Wood was also an appraiser. Rev. Henry Wood (1756-1843) was the pastor of Wood's Chapel which is located near Abner Creek.

Abner Creek was organized and constituted in William Hendrick's log house in 1832, but it was September 26, 1834 before it was officially constituted into the Presbytery. The Elders present were E. Rodgers, J.G. Landrum and William Rodes [Rhodes?] At the time William Hendricks was a deacon at Green Pond Baptist Church.

There were 21 charter members present. They were: William Hendrix, George Holtzclaw, Reubin Owens, George McVey, Andrew Hendrix, Amos McVey, Barbary McVey, Lucinda Carman, Scena McVey, Elender Hughes, Sarah Wilson, Louisa Bennett, Tabitha Barker, Martha Hughes, Ann Carman, Hesther Hughes, Drucilla Owens, Temperance Barker, Sarah Hendrix, Polly Holtzclaw, and Sarah Hendrix, Jr.

Abner Creek celebrated its sesquicentennial on September 26, 1982. For this occasion, Mr. F.E. Hendrix updated McHugh's history.

The purpose of my article here is to perpetuate the memory of one so important to the history of Spartanburg County and to Abner Creek Baptist Church. It would be a gross neglect for William and Sarah Hendrix to be forgotten or slip into oblivion. ****

WILL OF WILLIAM SEA

In the name of God Amen. Be it remembered that I William Sea of Union County in the state of S.C. being weak in body but of sound and well deposing mind and memory (the Lord be praised). Therefore calling to mind the shortness and uncertainty of human life has thought it fit to make and publish this my last will and testament in manner and form following. (that is to say) when it shall please the Lord to call me from this transitory world. I recommend my soul to the mercy of God who gave it and my body to the earth to be buried in a decent and Christian like manner at the discretian of my executors hereinafter named in full assurance to receive the same again at the general resurrection as touching such worldly estate as it hath pleased the Lord to bless me with in this life have thought proper to dispose of the same in the following manner. (to wit) It is my will that all my just debts, doctor bills and funeral charges shall be first fully satisfied and paid out of my personal estate and the remainder of my estate both real and personal to be disposed of in the manner and form following-viz -- Imprimis -- I give and bequeath unto my son Michael Sea 68 acres of land being part of a plantation and tract of land continuing 2 hundred and 40 acres on Tyger river con...to me by Samuel Cannon to begin at the lower corner and to extend up the river far enough to include said 60 acres to have and to hold in his posession and for his use during his natural life and no longer, then to go to my son Thomas See and his heirs forever. Secondly, I give and bequeth unto my son John See 60 acres of land being a part of the above tract of 240 acres beginning next to and adjoining my son Michael above him and running up the river far enough to include the said 60 acres to have and to hold during his natural lifetime and then to be equally divided among the other boys that is to say if the said John See does conform to build, settle and live the above tract, otherwise it is to fall back and be equally divided among the other boys as above said. Thirdly, I give and bequeath unto my son Joseph 60 acres of land being part of the above tract of 240 acres beginning on the river adjoining my son John above him and extending up the river far enough to include 60 acres provided he Joseph doth build on, settle, clear and cultivate said land. Fourthly, I give and bequeath unto my son Thomas See, his heirs and assigns forever the remainder of the above tract of 248 acres still above my son Joseph See being 60 acres of land with the house and buildings and other improvements of whatever kind that he the said Thomas See hath done and caused to be done of the aforesaid tract of 60 acres and I also give and bequeath unto my above named three sons, Thomas, Joseph and John and to their lawful heirs forever 245 acres of land it being the remainder of a tract of 250 acres granted to me (the low land consisting of five acres more or less being bequeathed as above) to be equally divided among them by executors herein after named and as followeth--viz--thatmy son Thomas shall have his share and proportion of the said land to include the dwelling and improvement be now has made extending upwards and autwards so as to include his equal proportion of afore-

said land and that the remainder shall be equally divided between my other two sons, Joseph and John See to be their right forever provided they do improve and cultivate the same and nevertheless if my said sons should all be disposed to sell the above and discharged and bequeathed lands they shall be at liberty with the approbation of my executors to dispose of the same not withstanding anything herein contained to the contrary, provided they purchase other land with the consideration money which they recieve for the land above mentioned which land as purchased shall be under the same regulation and restriction as the land above bequeathed. Item -- I give and bequeath unto my sons Michael See, William See and to my daughters Catherine Breed, Jean Howel, Olivia Frazee, Sarah Bates and Nancy Jackson one guinea to each and every of them to be paid to them by my executors 12 months after my decease, if demanded. Item-It is my will that all my debts be collected and a reasonable charge paid out of the same to the collector for his trouble and the remainder to be equally divided among my three sons, Thomas, Joseph and John See, that is I commit to the care and it is my desire my executors would advertise my cattle, swine and sheep with my household furniture and casks and vessels of every kind and depose them at public auction within 12 months after my decease as the law requires and after all debts are collected and the rest to be divided as above and lastly I do hereby nominate, constitute and appoint my trusty friends Drury Murrell, George Harlan (hatter) and my beloved son Thomas See to be my sole executors to this my last will and testament hereby revoking ... Whereof I have set my hand and seal 12 September 1796.

The remains of Howard S. Bobo, son of Hon. Simpson Bobo, John E. Walker, son of Mrs. Charles S. Walker, and Lemuel Moorman, son of Daniel P. Moorman, were received by their relatives and friends, on Monday evening last, at our depot. Capt. J.W. Carlisle was charged with the solemn commission of disinterring their bodies from the soil of Virginia, where they fell in defence of their country, to transplanted to that of South Carolina, the home of their fathers. The body of Charles S. Baker, son of Mrs. C.Y. Baker, of this place, was also taken from its late resting place by the sides of its comrades, but by request, was entombed at Hollywood Cemetery, in Richmond, Va. Bobo, Baker and Moorman were killed at Fuzzel's Mill, and Walker at Petersburg. Howard S. Bobo was buried in the old family burial ground of the late Anthony Foster. John E. Walker and Lemuel Moorman were laid to rest in the grave yard of this town.

Thus have passed from earth four as noble youths as Carolina gave to the late war. Thus have these dear boys returned to their parents and kindred....

This work is part of the continuing effort to publish all of the existing minutes of the South Carolina County Courts. (Only a third of the County Courts have any existing minutes.) It presents the existing court minutes for York County-those covering late 1797 until the County Court system was abolished in 1799 are missing.

In addition to court cases, these records contain almost every function of early post-Revolutionary local government: land transactions, estate and probate actions, appointments of guardians for minors, road construction and improvements, etc. This volume is fully indexed to include not only individuals but also localities, church congregations, and other such items.

This book will provide much information for those persons who are researching the York area.

It presents transcripts of 58 Spartanburg County cemeteries in their entirety. Among the churches presented are Philadelphia Baptist, Bethesda Baptist, Concord Methodist, Mount Carmel Methodist, New Hope Methodist, and North Pacolet Presbyterian. In all, 21 churches, including 7 extinct ones, are published. Also, 34 family cemeteries, and 3 community and private cemeteries appear here.

This is a complete listing of 1866-1869 marriages found in THE CAROLINA SPARTAN, a Spartanburg, South Carolina newspaper. Although these marriages are found in Spartanburg newspapers, they are not confined to that area. Many pertain to persons living in other counties of South Carolina and a few concern persons living in other states.

The society has acquired the 28 remaining copies of this detailed study of the James Crook family of Virginia and later Spartanburg County, S.C. However, Mrs. King did not limit this work to this particular family. She included information on other branches of the Crook family in England and America. She also included pictures of tombstones and various Crook homes. The second part includes information on the following related families: Anthony, Bane, Barry, Brockman, Burk, Coleman, Evins, King, Mann, Newman, Patton, Stallworth, Travis, and White families. "Bits and Pieces" (Part III) is an abstract from records of persons of the same surname, but with whom no proof of relationship has been established.
