

VIGNETTE OF CHANCELOR JAMES J. CALDWELL

Source: Annals of Newberry, Part First by John Belton O'Neall, page 127.

James J. Caldwell (Chancellor Caldwell) was a native of Newberry; he was the only son of Dan Caldwell. He studied at the Newberry Academy part of 1813, while Judge O'Neall was the teacher; after he ceased to teach, he prepared himself for college at Mt. Bethel; he entered college in the Junior Class just as it rose in December, 1815; his father and mother both died in the great epidemic of January, 1816. He graduated in December, 1817, and began the study of law with Judge O'Neall. The latter part of 1818 he took charge of the Edgefield Academy, where he taught about a year. He was admitted to the Bar in December, 1819, or May, 1820. He entered upon the practice of law at Newberry Court House, and single-handed, toiling on year after year, he at last reached the front ranks of his profession. He married in 1826, Nancy McMorries, the eldest daughter of James McMorries, Esq. He was elected to the Legislature in 1830, and continued a member until his election to the Solicitorship in December,

1835. In December, 1833, he was elected Brigadier-General of the 10th brigade. In 1844, he removed to Columbia; in December, '46, he was elected Chancellor, in the place of Chancellor David Johnson, who was then elected Governor; he died **Monday, 11th March, 1850**, leaving his wife and five children him surviving.

This gentleman shewed what could be accomplished by good manners, patience and untiring industry. He possessed talents of high order; he spoke and wrote well. If he had a fault in these respects, it was that he was too diffuse. In all his public elections before the people, it is due to his memory to say be never treated a drop of intercicating drink. He possessed more equanimity than most men. Seldom, very seldom, did he lose this balance. He was a good man, a virtuous lawyer, a faithful Representative and a just Judge. Greater men have certainly been in the service of the State, but none of purer purpose.

OBITUARY OF MRS. REBECCA K. McMORRIES HATTON

Hatton – Rebecca K. Hatton was the daughter of James McMorris, Esq., and Frances Morgan McMorris; born 25th March, 1804, married to Maj. John H. Hatton in 1822, joined the M.E. Church in 1843, under the ministry of the Rev. George W. Moore, at Old Tranquil Church, in Newberry District, lived in the counties of Laurens and Newberry, and died at Newberry C. H., S. C., at the residence of her daughter, Mrs. Bradley, on the 10th June, 1882, survived by one son and four daughters. Since 1868 she resided at Newberry C. H., and during this period was a member of this charge, Newberry station. It is easy and pleasant to recall her constant attendance upon the services of her church, and the interest she always manifested in its welfare. Modest and unpretending as was her religious life, she, is her daily walk evidenced real piety and Christian enjoyment. Her disposition was meek and cheerful. A woman of unusual intelligence, she was fond of general reading, but especially devoted to the reading of the Bible. Socially, she was entertaining. Her children, by their affectionate remembrance of her, proved how true she was in the delicate relation of mother. It is no surprise that this intelligent, faithful and hopeful Christian woman did so gracefully decline in years, and when at last her summons came, was ready to die, and in joyful anticipation of the future could say: "I'm wafting home to heaven; to a house not made with hands, eternal in the Heavens."

THE LAST SIX WEEKS OF THE LIFE OF REV. BENJAMIN WOFFORD

> For the Southern Christian Advocate. A SKETCH – THE LAST SIX WEEKS REV. B. WOFFORD

Anything in relation to the late Rev. B. Wofford who has devised things so liberal, could not fail to be interesting to the public at the present time, especially to the members and friends of the M. E. Church, South. The object of this sketch, however, only embraces the last six weeks of his earthly existence, which was to him a season of extreme physical suffering, and filled up the measure of his days on earth. It may not be out of place to state here that this venerable minister of Jesus Christ was ordained deacon by Bishop Asbury on the 18th of November, 1814, at Bethel Assembly. On the 27th of December, 1818, he was ordained elder by Bishop Roberts in Camden. His certificate of location was furnished by Bishop George, January 19th 1820, at Charleston, S.C. From the date of his location he could only have traveled a little over one year after he graduated to elders' orders. As to his integrity of character as a citizen, his piety as a Christian man, and his usefulness as a minister of the gospel, it is not proper perhaps that any remark should be made in connection, as on these several points the public has already been sufficiently advised. These things are also known, and properly estimated by all who knew him in his native district.

Mr. Wofford was taken sick on the 18th day of October last, and departed this life on the 2nd of December, and not on the 9th, as stated in his obituary notice. He was most violently attacked, which attack was accompanied by vomiting from the very first evening until within three hours of his death. It would be paying but a merited tribute to his pious and accomplished wife to say of her that she attended him constantly and untiringly, as no one else could have done, never leaving his room unless when compelled to do so by imperious necessity. She was to him a messenger of mercy and comfort, indeed he would have no one else to minister to him. She was usually on her feet by day and by night. None perhaps are so well prepared to properly appreciate the fatigue through which she passed as well as the anxiety which she suffered, as the two attendant physicians. Surely nothing less than the mercy of God and the prayers of his people could have sustained her, her own health at that trying time being exceedingly delicate. It is to be hoped that the Church will not be forgetful of her at the throne of grace. In all that she did, it was not only doing her duty, but it was performing that duty well. May she never be wanting in time for the richest blessings that earth can bestow, or in eternity for everlasting life. Mr. Wofford would frequently say during his violent paroxysms, that he was going to die – that she must take care of herself – that he should leave her in the hands of God.

When he approached the last stage of his disease, which was on Saturday, November 23, and on Sunday following, he requested Mrs. Wofford to send out for some of his christian friends to sing and pray with him. Among others who assembled on the occasion was Miss Elizabeth Wright, who always feels it a peculiar pleasure to engage in such exercises, either in the class or sick room, and whose prayers are characterized by much fervency and strength of faith. As they were thus engaged in singing the songs of Zion, he requested Miss Wright to lead a prayer, which she did. During this prayer, he became quite happy in the Savior's love, and said he was resigned to die.

"Meek resignation, faith and hope are seen."

He then requested Miss Wright to visit all the sick, and pray with them, stating that her prayers did more good than the prayers of the preachers. In this happy state of mind he remained mostly until the

following Tuesday morning, when his friends were summoned to his dying chamber, as all supposed, to witness the last of him; and no doubt he felt also that with him it was "the last of earth," when however, to the astonishment and comfort of his christian friends, who surrounded his bed, he aroused from that slumber which seemed a death-token, he was in a very comfortable state of mind, as he observed to his weeping wife, "O the goodness and mercy of God: his perfection | my soul is happy, yea know what I mean." On another occasion when recovering from a similar condition, he asked—if they were not all very much alarmed, to which Mrs. Wofford answered, "yes;" but he was not at all terrified in view of death: "O no," said he, "I want to go! Come Lord Jesus!" A young friend of his and one who was quite a favorite, who had not long been married, made him a visit, at which he was much pleased, and exhorted her to meet him in heaven, stating that he had often prayed for her.

At this period he seemed to manifest some little anxiety to linger on the shores of time. As evidence of this he called in a third physician. On Friday evening when Dr. Boyd arrived, he said to him, "It is possible, Dr., you and the other doctors can do something for me;" to which the Doctor very judiciously replied, "All things are possible with God - you cannot live, you must die - I hope Mr. Wofford, you are prepared to meet our God." On receiving such testimony form such a source, his mind at once resumed its former position and exercises, and when the Doctor observed, I hope you are prepared to meet your God, he promptly answered, "yes." If the skill of his physicians and the attentions of his friends could have saved him, he had not died; but those kind attentions and sympathies were unavailing. Very many interesting expressions fell from his lips; it was truly good to be in that sick room, as many can testify that even in reference to this occasion, that it is better to fo to the house of mourning than to the house of feasting. On the last morning when Mr. Wofford was fully impressed that he was approaching very near the closing scene, he took his amiable wife by the hand, and asked her what o'clock it was, she replied a quarter of two; he then asked her, what day in the month it was; she replied, the second of December. These questions he had frequently asked for the last two or three days. He was then asked by Miss Wright if the Lord Jesus was still with him; his answer was, "yes, yes, yes." She then said, "all's well." He waved his hand in token of victory, but spoke no more. He seemed to maintain the vigorous exercise of his intellectual faculties up to the very last. It is true he suffered much, and yet it is equally true, he died easy - so easy that friends could scarcely tell when he was gone.

"Benign affection beaming from his eye, See with what calmness can the Christian die."

After the Land & the Buildings erected by the said, Revd Wm Wightman, H. Bass, Wm A. Gamewell, I. H. Wheeler, W. Barringer, H. A. C. Walker, John Porter & David Derrick, Maj' Harvey Wofford, H.H. Thomson, Jos. W. Tucker, Clough Beard and Doct. Benj. Wofford by them or their survivors or survivor as above Specified, and the Conference of the Methodist Episcopal Church of the State of South Carolina has appointed the thirteen Trustees as above directed and [those above named (repeated)] they or their survivors or survivor have conveyed & transferred the college Land & Buildings in trust to the said Trustees as aforesaid, then I order and direct my Executor to this will to pay over, transfer and Deliver Fifty thousand Dollars to the Trustees appointed by the aforesaid Conference, to whom and their successors I vest the said property & Estate with none other than a fiduciary estate: in trust nevertheless to, for & upon the uses, interests & purposes hereinafter expressed of and concerning the Same; in trust always to appropriate only the annual interest or dividends thereof, to establishing, endowing & sustaining said College, - taking especial care that no part of the principal shall at any time or on any account be used or expended - And the said Trustees when appointed as herein directed are hereby Vested with all rights & powers necessary for the government, control, management & discipline of the said College; for the election of such President, Professors & officers for such periods as they shall deem proper, provided they shall not elect any officers for a longer term than four years : also they are hereby vested with full power for the appropriation of the funds at their disposal as above specified, allowing such salaries & expenditures as my be requisite & expedient, and itemized account of which shall be annually transmitted to the aforesaid Conference for its inspection & examination - also they are invested with full power for establishing of such by-laws, rules & regulations, as the welfare & interest of the institution may require.

Should it turn out that the Fifty thousand Dollars devised by me to buy College Lands & Erect College buildings should not be all expended for that purpose by those to whom I have intrusted to expend the same - then they are to transfer the ballance if any to the Trustees to be appointed by the aforesaid Conference & the fund to be reed by them upon the same terms & conditions as that heretofore devised to them....

AN ACCOUNT OF THE ORIGIN OF WOFFORD COLLEGE IN TWO PARTS

The munificent bequest of a hundred thousand dollars having been made by the late Rev. Benjamin Wofford, for the establishment of a College in Spartanburg District, S.C., under the supervision of the South Carolina Conference, the Board of Trustees designated in his will were convened and organized on the 16th inst., at the town of Spartanburg. The specific object of their meeting was to select a location for the Institution, and to take the necessary preliminary steps for the erection of suitable buildings, fifty thousand dollars having been appropriated by the testator for this purpose. Several liberal offers were made from different points in the District within whose limits the Board were authorized to make a selection; but after a full and deliberate examination, the town of Spartanburg was chosen by a unanimous vote, the citizens having, at a public meeting, handsomely provided for a donation of lands sufficient for the purposes of the College. The Institution, with its entire suite of buildings, will be located on a beautiful site in the North-western suburbs of the town, within the corporate limits, commanding a fine view. A building committee was appointed, of which Col. H.H. Thomson, a gentleman peculiarly qualified for the energetic and successful prosecution of the work, was selected chairman.

Upon mature deliberation the Board resolved upon the adoption of the non-resident principle in the strangement of the buildings, excluding a common table and dormitories. We have not room here to enumerate the various reasons which led to this result, and which were entirely satisfactory to the whole Board, in their bearings upon the health, comfort, morals, and good conduct of Students, the discipline of the Institution, and a wise and economical expenditure of the means at the disposal of the Commissioners. The system thus adopted was warmly recommended by the highest authorities, and we doubt not will give general satisfaction. It will probably leave some ten or fifteen thousand dollars to be added to the fifty left for a permanent endowment.

The Rev. H.A.C. Walker was appointed agent for the College in connection with an agency for the Cokesbury School, which he holds by request of the South Carolina Conference at its last session. He was authorized to obtain scholarships at five hundred dollars each, the donor obtaining for this amount the privilege of keeping one student at the College, in perpetuity, free of tuition charges. This privilege will be guaranteed by the issue of scrip bearing the seal of the corporation, and may be transferred to heirs and assigns at the decease of the original donor. It is confidently believed that fifty thousand dollars may be readily obtained in scholarships and other donations. Several large amounts have already been voluntarily subscribed; and when it is remembered that the Institution is placed by the handsome provisions of its founder upon a firm basis so that it is beyond the remotest liability of failure, there will be the strongest inducements to the friends and members of the Methodist Church in the South Carolina Conference, to rally round it, and make it the best endowed College of the entire Church. We shall thus steer clear of that opprobrium of denominational Colleges, a half-starved Faculty, and be able to secure the best talent and learning accessible. No incubus of miserable debt will cripple the means of the Institution, or dispirit the hearts of its friends. It will enter at once upon its high mission of intellectual and moral good to society, and send out over coming generations the precious benefits of education combined with religious influence. We are sure that no similar inducements were ever before held out to the consideration and liberality of the Methodist community of this State.

The crowded state of our columns this week, precludes the mention of various particulars which

would be of interest to our Carolina readers, in connection with the location of the Wofford College. We shall take occasion shortly, to recur to the subject; merely adding at present that the corner stone at the College will be laid with appropriate ceremonies on the fourth day of July next, at the second meeting of the Board.

FIXING THE LOCATION OF WOFFORD COLLEGE

WOFFORD COLLEGE

The fixing of Wofford College at the town of Spartanburg, S. C., will interest some of our readers in a brief description of that locality. The District, of which it is the principal centre, ranks among the first in the State, in point of population and extent of mineral and manufacturing resources. It runs up to the North Carolina line and nearly to the mountains, having York on the East and Greenville on the West. Having neither river nor canal, rail-road nor plank-road, its capabilities have never been fully developed. The roads leading in that direction from Columbia, the centre of the State, are in winter, and we may add from recent observation, even late in the Spring, about as bad as an ordinary imagination could well conceive. Stage-coaches perform most of the journey at the respectable average of rate of three miles per hour; and the traveler felicitates himself if he is fortunate enough to escape with bones unbroken. To one accustomed to the speed, conveniences, and security of rail-road travel, such a state of things suggests the idea of very primitive times. You seem to have gotten years behind the age of progress, as you creep along through lanes whose mud-holes are of unknown depth, or ascend hills at which you confer a favor upon driver and team alike by taking it afoot. Thus it is obvious that a populos and wealthy district, like Spartanburg, land-locked as it is, must content itself with being a second or third-rate affair, or manfully put forth its energies and resources, and build a rail-read.

This last it has undertaken to do, in connection with the Districts below. A charter has been granted for the purpose, with a donation from the State of \$125,000, provided \$375,000 are subscribed by those interested in the road. We believe that some \$50,000, perhaps less, is all that remains to be pledged on order to secure this great and indispensable improvement. With a rail road and an Institution of learning which will command the patronage which Wofford College is certainly destined to do, the fortunes of Spartanburg are made at once. Its population will speedily be doubled, and the spirit of enterprise now in course of development will find an ample field for its exercise.

In the town, the Presbyterian, Methodist and Baptist denominations have each a church. The Episcopalians have one now erecting. The character of the community stands deservedly high for intelligence and morality. The Methodists sustain a married preacher on the station, and are very tespectably represented in the community. The town supports an ably conducted Journal, the Spartan; and exhibits all the signs of growth and improvement. We are happy to learn from all quarters that the location of Wofford College has given satisfaction. Without interfering with the present palmy prosperity of the State College, it will furnish facilities for education to thousands of young men who probably would never go to Columbia. We tender our hearty congratulations to the South Carolina Conference, under whose fostering care the Institution is to be built upon, on the flattering prospects which the future presents. In the rising College which is to bear the honoured name of its Founder, we give to our country the pledge that we shall faithfully do our part in diffusing the blessings of mental and moral culture, of enlightened liberty and christian civilization, of those elements of wisdom and strength which are the glory of a State, the palladium of a nation.

LAND RECORDS FOR THE ALLEN FAMILIES FOUND IN EARLY GREENVILLE COUNTY, SC (LATE 1700s TO MID 1800s)

Property records add to our understanding of the early Allen families in Greenville County. The earliest record that I have found is the purchase by George Allen of 202 acres on the S. Tyger River from John Evans in 1790 (Book B, Page 144, Purchased 1790, Recorded 1790). This was followed by a sale of 202 acres on the S. Tyger River by George Allen to William Grant in 1795 (Book D, Page 227, Sold 1795, Recorded 1796). In 1796, George purchased 150 acres on the S. Tyger River from Eaikie Forester (Book D, Page 505, Purchased 1796, Recorded 1798), followed by the purchase of 222 acres on the S. Tyger River from Bayless Earle (Book D, Page 448, Purchased 1797, Recorded 1797). In the Earle and Forester transactions Allen is indexed as Allin. In 1801, George Allen sold to Burnel Russell 150 acres on Mush Creek (Book F, Page 411, Sold 1801, Recorded 1802). In 1803, George Allen purchased 94 acres on the S. Tyger River from William Dill (Book G, Page 153, Purchased 1803, Recorded 1804).

Jesse Allen sold 70 acres on the Middle Tyger River to Joseph Nelson in 1814 (Book I, Page 393, Sold 1814, Recorded 1815). In 1816 Jesse Allen sold 170 acres on the S. Tyger River to Lemuel Loftice (Book Q, Page 511, Sold 1816, Recorded 1831) In 1816, Jesse Allen recorded the purchase in 1800 of 111 accres on the S. Tyger River from David Allen (Book I, Page 460). Jesse and his brother, David, inherited the real estate of their father, George Allen.

William Allen sold 200 acres on the S. Tyger River to Jesse Trammell in 1818 (Book K, Page 189, Sold 1818, Recorded 1818).

In 1794, Charles Allen purchased 100 acres on Langston branch from Joseph Langston (Book C, Page 417, Purchased 1794, Recorded 1794). I found no other Greenville County transactions for him. This appears to be the property left to his son, Thomas, in his will probated 1821.

Edward Allen purchased 100 acres on Brush Creek from Aaron Kemp in 1823 (Book N. Page 57, Purchased 1823, Recorded 1823). Edward Allen sold 100 acres, part of the grant to George Lewis, to William Green in 1824 (Book O, Page 233, Sold 1824, Recorded 1825). It is doubtful that Edward Allen ever lived in Greenville County. His probate package in Greenville County indicates a residence in Charleston, SC with extensive holdings in several locations.

In 1834, Vardry McBee purchased property on Boundary Street in Spartanburg from Thomas Allen but recorded the transaction in Greenville County (Book R, Page 261, Purchased 1834, Recorded 1834). OBITUARY OF DR. THOMAS COLLINS AUSTIN OF GREENVILLE DISTRICT, SC

Austin - Died, Saturday morning, Jan. 20th, at his residence near Bethel Camp Ground, Greenville Circuit, S. C., Dr. Thomas Collins Austin, in the 93d year of his age. And what shall we say of this great and good man? Who of the preachers that have traveled in upper Carolina, that did not know him to love and reverence? As a man, he was a born leader among men - had the faculty of attaching to him every one with whom he had intercourse. He possessed a full and manly mind. Whatever subject he touched, he discussed fearlessly and thoroughly. As a physician, at one time he was one of the most able and prominent in the State. He took an active part in the war of 1812, acting as paymaster of the regiment commanded by his father, Col. Wm. Austin, which was composed of troops from Greenville, Pickens, Anderson and Abbeville. He was of the highest type of ante-bellum South Carolina gentleman. As a Christian, a member of the M. F. Church, South, he was devoted to the Church of his choice, a truly pious, humble, holy man for several years previous to his death. On account of his great age, he was confined to his house, and later to his room; and there it was that the Christian graces cultivated in manhood's prime shone so mildly, evenly, beautifully. He met death resignedly, and his end was peaceful.

OBITUARIES OF TWO REV. WAR VETERANS WITH SURNAME DICKSON

Friday July 30, 1830, p. 2, col. 6— Matthew Dickson, age 99

Died, at Pendleton, on the 19th inst. MATTHEW DICKSON, Sen. in the 99th year of his age. The deceased was a native of Ireland, emigrated to America in 1762, and had been previous to his death sixty years a citizen of this State. When the flame of war was kindled between Great Britain and her colonies, he eagerly espoused the cause of liberty; and throughout the perilous trying times of the Revolution, was distinguished as a faithful, resolute, and active soldier.

Saturday July 31, 1830, p. 2, col. 6— General David Dickson, age 79

Died, at his residence in Fayette county, Georgia, on the 3d May last, Gen. DAVID DICKSON, aged 79 years, 8 months, and 30 days. He joined the standard of American Independence in February, 1775, at the Snow Camps, on Reedy River, at the taking of Col. Cunningham and his tories-In 1776, he commanded a volunteer company, under Gen. Williamson, in the Cherokee Nation, against the Cherokees and tories-In 1779, he brought a company of men to Georgia, and was stationed on the frontiers-In 1778 [sk], he and his company went with the American army to take St. Augustine-he and his company served in the artillery—(the taking of St. Augustine miscarried.) the minute men were discharged, and he returned to South Carolina, and joined the standard of independence there, and continued in the service of his country in that State, to the end of the war.

Another Revolutionary Soldier Gone ! Died at the house of his son, on the 25th ult. Captain John M'Connell, aged 81 years. This venerable patriot commanded a company during the revolutionary war, which he led into action at the battle of the "Hanging Rock," in which, for bravery he distinguished [Yorksille Pioneer.] himself.

DYSON KILLS BIRDSONG IN A SHOOT OUT

YORKVILLE, (S. C.) APRIL 22.—On the 28th ultimo, a band of ruffians resolved to "cowskin to death, or shoot, James H. Dyson," of Madison County, Tennessee. They had made known their intentions to different persons in the course of the day. About 10 o'clock at night they came to his house, commanded him to come out, shot his house-dog at the door, and fired two or three guns at the door and windows. Instantaneously a gun was fired, which killed William Birdsong, one of the party; the others immediately dispersed. On the next day Dyson took a warrant for two of the mob, and on the same day Dyson himself was taken by a warrant, and appeared before the Judge of the vicinity in his chambers, who granted D. Bail in the sum of \$2000 for his appearance at next July Circuit Court.

By a letter from Jackson, received by Wednesday's mail, we learn that the general impression in Madison County was, that if Dyson shot Birdsong, he shot him in his own defence. — Advecate. [Note: The connection of these events to York District, SC is not stated.]

A SKETCH OF I. W. WINGO, PATRON OF CAMPOBELLO

REV. ISHAM WOODRUFF WINGO.

Among the prominent representatives of this large [Wingo] family connection we would mention Rev. I. W. Wingo, well known to all the people in Spartanburg county, both as an educator of her young and as a minister of the gospel. He is a son of Paschal and Maiden (Foster) Wingo, and was born in Spartanburg county, May 22d, 1850.

After attending the common schools of his neighborhood, he entered the Gowensville Seminary under Rev. T. J. Earle, where he remained three years. Afterwards he entered the Furman University at Greenville, S. C., where after a course of three years, he was graduated. He then entered the Southern Baptist Theological Seminary while it was still located at Greenville, where he attended for several years and from which he was graduated.

His first pastoral work was at Pendleton, S. C., where he served from the latter part of 1877 to '81, serving, meanwhile, the church at Walhalla one year and also other churches in the surrounding country. He then went to Camden, S. C., and served the Baptist Church fifteen months, when he was called to the Baptist Church at Gaffney, S. C., where he remained nine years, leaving there in 1892. While at Gaffney, he served the Baptist Church at Limestone Springs part of his time, and taught mathematic in the Cooper Limestone Institute located at the latter place. From Gaffney he went to Ridge Spring, S. C., where he remained for three years, during which time he was engaged in pastoral and ministerial work. In 1894 he removed to Campobello, S. C., when he opened up the present High School, which ranks among the best schools of our country, and which has had much to do with the upbuilding and business prosperity in that thriving town.

Mr. Wingo has rendered the country valuable service in developing and bringing to the notice of the public the valuable medicinal properties of the Chalybeate Sulfur Spring of Campobello, which had been known for fifty years or more to a few citizens. The consistent elements of the water from this spring, as analyzed, are carbonates and sulphates of lime, iron, soda, and magnesia, a little sulphate of potash, silica, lithia, and carbonic acid gas. The spring is surrounded with a substantial brick wall and building overhead, and a handsome and well equipped hotel has been erected near by, all due to the indomitable energy and perseverance of Mr. Wingo. Numerous testimonials can be produced as to the value and health-giving properties of this spring, which in the future is destined to take its place as among the most popular summer resorts in the up-country of South Carolina. Mr Wingo is rendering not only important service as an educator, but is also laboring earnestly and zealously as a minister of the gospel. He is at present pastor of Welford, Friendship and other churches, and is doing a good work in the Master's vineyard.

In 1878 or '79 [1877; see p. 169 below] he married Miss Lula Dean, a graduate of the Spartanburg Female College, she is the only daughter of Dr. Thomas P. Dean and Mrs. Mary (Davis) Dean. By this marriage he had six children, viz: Mary Dean (deceased), Anna Lula, Joseph Paschal, Ruth Earle, Isham Dean, and William Wallace.

OBITUARY OF REV. I. W. WINGO (1850-1913)

REV. I. W. WINGO

Rev. I. W. Wingo, D. D, aged 63 years, died in a local hospital yesterday afternoon, after a long illness. Dr. Wingo had been in the ministry for the past thirty-eight years and was pastor of a number of churches in Greenville county at the time of his death. He was born near Inman in 1850, and was educated in Greenville, being a graduate of Furman university and the Baptist Theological seminary, which was located in that city in the days of Dr. Broadus. Dr. Wingo was at one time a professor in Furman university, and had a host of friends throughout the state.

He was twice married, his first wife being Miss Lula C. Dean, of Campobello, who died about twelve years ago. From this union there was born three sons and two daughters: I. D. Wingo, of Lancaster; Joe P. and Wade [sic], of Greenville, Mrs. R. A. Brown and Miss Ruth, of Greenville.

About ten years ago Dr. Wingo married Miss Blakely [sic] Sharpe of Atlanta, Georgia, who survives him.

The body will be sent to Greenville at 10 o'clock this morning, where the funeral services will be held in the First Baptist church. The service will be conducted by Rev. Dr. Cody and others. Interment will be in the city cemetery of Greenville. The following will act as pall-bearers: S. B. Exell, W. R. Brown, H. L. Bomar, J. S. Wingo, M. B. Ezell and W. H. Crews

The pall-bearers will meet at Bobo's Undertaking Parlors at 9:45 a. m.
