

BAILEYS AND COLEMANS OF BEAVERDAM CREEK OF EARLY LAURENS DISTRICT

"Do you take this woman to be your lawful wedded wife, second cousin and step-aunt?"

"Down on Beaverdam Creek, when the area was first being settled by white men, they came with large families into a frontier where there were almost no other non-Indians living there before. Their only social activity, if you could call it that, was when they went to church, or when there was a barn raising, or a family reunion. So it was that when it came time for a man or woman to find a mate, there were very few choices. Pickin's, you might say were slim. Added to all that was the old Scotch Irish tradition of keeping land and dowries as close to the clan unit as possible. It was not considered "proper" to marry outside the clan. That trait carried over.

"So although a lot of contemporary folks cluck their tongues and shake their heads at the practice, we cannot deny that for one reason or another, cousins often married in the small frontier communities of our ancestors. It was not even unusual for first cousins to marry.

"Now this gives genealogists fits, because as you can easily imagine, children down the line have the same ancestors on both sides of their families. If I run a descendant chart for William Bailey in my computer, I get 700 pages of descendants but almost half of these are repetitions because of the cross-marriages of cousins. I have tried to represent here some of the interesting relationships that this fact has created among some of the folks in the Beaverdam Creek area. If you can make it through these, you can understand why, as a child, I never could understand what Granny was trying to explain to me about our cousins.

"First, way back there, three of Zachariah Bailey's children married three of Hezekiah Coleman's children: Winifred Coleman married Zachariah Bailey. Rebecca Coleman married James Bailey and William Coleman married Lucy Bailey.

"Mary Elizabeth Coleman, daughter of William and Lucy Bailey Coleman, married John W. Coleman, the son of Absulom, who was a son of Hezekiah" . . . [Contributor's note: This goes on to Page 108, and ends with the following.] "Some people say there is something in the water in Beaverdam Creek. I don't know for sure, but I find it very strange that my mother was my fourth cousin."

INVENTION OF THE CHEROKEE ALPHABET IN 1829

Source: Charleston Courier, issue of Friday August 28, 1829, p. 2, col. 4

[From the Nashville (Tenn.) Banner.]

Cherokee Albbabet.—The invention of an alphabet by a Cherokee Indian, and the practical utility it has already afforded, are among the wonders of the present age. The characters were devised by See-quo-yah, who, without any knowledge of letters, or the principles of written language, undertook to represent by marks all the sounds uttered by the Cherokees in conversation. Col. Knapp, who relates in one of his lectures on American literature, the result of an interview with this eminent Indian philosopher, states, that his [See-quo-yah's] own ear not being remarkably discriminating, he called to his aid the more acute ears of his wife and children. He derived great assistance from them, and although at first his signs were very numerous, amounting, after he thought he had finished his invention, to upwards of two hundred characters, he was enabled by the aid his daughter, who seemed to enter into the spirit of his labors, to reduce them at length to eighty-six, the number he now uses. The "Cherokee Phoenix," a paper printed partly in English and partly in these newly invented characters, say—

"See-quo-yah certainly deserves to be held in remembrance by all who respect native genius, but more particularly, by his countrymen, on whom he has conferred a lasting blessing; they are reaping a full harvest from his invention, which, for its simplicity, is unrivaled. Its simplicity is fully demonstrated by its rapid extension since it was introduced. Without the aid of a single schoolmaster, or a single book, it has been generally acquired in the nation, and now we venture to assert, reading and writing are as common here as among the neighboring whites, and certainly those Cherokees who have attended to their alphabet once a week, write more correctly than the English scholar who has been steadfast to his books two years.

The dates of his birth and death are not available, but his life of only twenty seven years was before the Civil War.



Thomas Dean read medicine with his uncle, Dr. Alvin Dean, of Cobb County, Georgia, and graduated from the Charleston (South Carolina) Medical College.

He matried Mary, daughter of Joseph Davis, on the South Pacolet. They had one daughter, Lula, who was the wife of the Reverend L. W. Wingo, a Baptist minister of this county. He was a member of the Presbyterian church, and his life, when cut off, was one of promise and usefulness.

Carolina Spartan, issue of Wednesday October 8, 1884, p. 2, col. 2

Mrs. Jane Dean, widow of the late Alfred Dean, died Monday, at the residence of her son, Capt. George B. Dean, in her 87th year. Her maiden name was Bobo, and she was a daughter of Absalom Bobo. For 64 years she had been a consistent member of the church.

Soldier's Diary Recalls Stirring Day of Civil War as Anniversary of President of Confederacy Nears

Only 3 Spartan Veterans Expected at Jefferson Davis Dinner Friday

By GRACE BAILY BEACHAM

Instead of the several hundred Confederate veterans who used to gather annually on the courthouse lawn for dinner on Jefferson Davis' birthday, only three of the five remaining Spartanburg county veterans expect to attend the dinner to be held at 1 o'clock, at the Cleveland hotel tomorrow. They are J. A. Gamewell, R. B. Bryant, and R. C. Gabrels.

As the thin gray line grows still thinner and more broken as the years go by, so the relics and memories of these Confederate soldiers become more valuable to posterity.

It was a queer-looking coffee pot with its spout sticking out from the side instead of the front like a nose out of place, inscribed with the words "C. C. McMillin, commisary 1st S.C. Regiment, Army Northern Va., Cost \$5.00," that resulted in my interview with Mrs. T. W. Bailey, daughter of the late C. C. McMillin, affectionately known as "Uncle Cary." After two hours of greedy questioning and dusty rummaging, I stalked triumphantly home with worn Confederate [crease in paper] and the dim, tattered diary written by a nineteen-year-old Confederate soldier beside his low camp fire

while guns roared in the distance, during the War Between the States.

Soldier's Diary

From Uncle Cary's diary, I learned that the secession of South Carolina from the Union on December 20, 1860 found him and his older brother as students at Newberry college.

He wrote: "Our political leaders were holding meetings in every town and hamlet in the state, and I can see now 'torch light processions', a mile long, marching over the town of Newberry, with music to enliven the occasion. The people became so enthused that every available man and boy was ready to volunteer, and if necessary, fight for our 'constitutional rights'."

Uncle Cary and his brother "Pink" joined the Bamberg Guards and reported for duty on April 1. That same night, as the diary humorously relates, Uncle Cary was arrested for calling on a young lady "A. W. O. L." The leniency of the times is shown by the fact that he was given only one hour of guard duty.

Join Beauregard

On August 29, under orders, the Bamberg Guards joined Beauregard near Mananas. The diary graphically describes the Battle of Mananas and closes with - "For three hours the battle raged and towards nightfall the enemy was retreating nor did they stop until they had crossed the Potomac. In the battle our company lost in killed and wounded about one-third of our members." Uncle Cary was among the wounded.

The diary gives much praise to the faithfulness of his negro slave "Guinea Charles." Guinea Charles received his name because his theft of a guinea when he was a small boy. He kept up his chickenstealing during the war for the diary relates that one night when Uncle Cary was suffering from the bullet in his shoulder and the emptiness in his stomach, Guinea Charles crept away from camp, and mingling himself with the black night, returned with a beheaded chicken tucked under his shirt.

Furloughs were not granted but through special action of Congressional General Lee Ayer, one was secured for Uncle Cary from the secretary of war. The question of transportation arose. With his arm in a sling. Uncle Cary walked into the office of the president of the Pennsylvania Railroad ans asked the loan of a ticket fare for himself and Guinea Charles. It was granted and to the president's great surprise, paid back with interest several years later.

High Cost of Living

The diary here mentions the enormous cost of food and clothing in those times. As he was transferred to Quartermaster's Department in Charleston for a time, Uncle Cary often dined in the Charleston hotel paying five dollars a plate. The cheapest shoes he could buy were \$50 a pair. Toward the end of the diary when Uncle Cary is describing the four hundred mile trek home, the following incident is related. "On our 22 mile march today, we had the good fortune to meet an old darky who had some rice to sell. 'Uncle, how much do you want for your rice?' 'Five dollars a quart, sir.' 'We'll take all you have.' He measured us five quarts and we paid him \$60." Speaking of Confederate money, W. F. McMillin, brother of Uncle Cary, held a position during the war which made certain money void unless it bore his signature. He spent many a night signing hundred of large sheets of money. His wife saved all the gold pen points with which he signed the money. They were made into a wide gold band, which Mrs. Bailey wears on her finger today.

Defense of Richmond

The diary has only a brief account of the defense of Richmond and the final retreat. Only a line or two appear by some of the dates.

"Tuesday night. April 4, we are able to give two days rations of meat and some bread. For three days now our men have had almost nothing to eat. April 5. Yankee raiders gained our front, and before help could arrive destroyed 135 wagons and ambulances. Sunday morning the 9th, the whole army train was 'parked and cut down.' Grant's army being on our front. Very soon a Yankee general with his staff and couriers came dashing through the lines under the flag of truce. It was not long before firing ceased, which was a clear indication that something important was transpiring. Soon rumors went wild over our little army that Lee had surrendered. Four years' hard service on the battlefield for our freedom and independence, and now 'All save our honor is lost.' It could not have been otherwise. We were outnumbered, and had nothing to eat." In the diary is a copy of General Lee's last general order, or his farewell address.

Excerpts from Diary

Following are a few brief excerpts from the diary, which give an intimate glimpse into a soldier's life during the first few weeks after the close of the war:

"April 10 — Yesterday our armies, the Blue and the Gary, stood face to face, and at the command of General Lee, was ready to fight the last battle for our Confederate cause.; but he wisely yielded to the overwhelming number of the enemy. Ten thousand surrounded by an army of 185,000, and our veterans cut off from all supplies? Today the Blue and Gray are mixing freely together. Both are glad the carnage and slaughter of each other is over. So many of them are diving rations with our hungry boys. A lovely scene this is. Plans are now being made for us to stack our arms the day after tomorrow. I am afraid the old bitterness will return then."

"April 11 - today we got two days' rations. Hooray!"

"April 12 — Grant's army was formed into an open square. The lines looked to be two or three miles long. We were marched through this open square by regiments, brigades, and divisions. Stacked arms and marched back to camp. We had a fine opportunity of seeing in line the thousands of men who were fighting us, and by far the greater number seemed to be 'foreign hirelings'. (It is known that the Yankees sent substitutes whenever they could.) We did not see the face of a single good-looking Yankee, and I would not do violence to my conscience or an injustice to my country if I wished them all in Hell." On

the margin of the dim, tattered little diary this note had been added in a trembling hand: "With the passing of half a century of years temper and feeling have subsided, and I would not make the same wish now that I made then. In fact, I would not even write out the world for 'bad place!'

How typical of the changed feelings between the Blue and the Gray in that little note which Uncle Carv added ! A recent article stated that the veterans of both armies have agreed to hold their reunion together this last year. The last barrier between the North and South will then be broken forever, and for the first time since before 1860, we will have a really United States.

FATAL FIGHT IN CHESTER DISTRICT

YORKVILLE, April 19— Fatal Rencounter.—We have been furnished with the particulars of a rencounter which recently took place in Chester District, and which terminated in the death of one of the parties. They are as follows. As Henry Walker and Wm. Hudson were returning from Chester Court House on Saturday evening, the 9th inst. after the adjournment of the Court, a dispute arose, when Hudson undertook to beat Walker. In the course of the fight, Walker struck Hudson a blow over the left eye, either with his fist or a stick, which neither of the parties at the time supposed would prove fatal. On Sunday morning, however, Hudson was found to be speechless, and on Wednesday following died. The verdict of the jury of inquest was that Hudson came to his death in consequence of a blow inflicted on him by Henry Walker. Walker has been arrested, and now is confined in Chester jail. We understand a motion will be made by Mr. Chestney, counsel for the prisoner, before his Honor Judge Earle, now holding Court at Winnsboro, for a babeas corpus, to bring up the body of the prisoner, and for admitting him to bail.

The same is true for the 1860 Spartanburg census, even though the households of B F Bates, Moses J. Hammett, and other known near neighbors were enumerated. The wording of the deed suggests that and that Jenny cared for her until Elizabeth's death in 1847, that she lived on land in Spartanburg County, and that Jenny cared for her until Elizabeth's death in the 1860s.]

VIEWS CONTRARY TO TARLETON'S REPORT AT BLACKSTOCK'S

Historians seem to agree that when Tarleton was victorious, his account of the battle was accurate. When he was defeated, he reported the event with literary license. Such seems to be the case at Blackstock's.

In Tarleton's Campaigns of 1780 and 1781 in the Southern Provinces of North America, he writes:
"Three of the enemy's colonels fell in the action, and General Sumpter received a fierce wound in the shoulder. Upwards of one hundred Americans were killed and wounded, and fifty were made prisoners.
On the side of the British, Lieutenants Gibson and Cope, of the 63rd were killed; and Lieutenant Money, aid-de-camp to Earl Cornwallis, who had commanded the detachment of mounted infantry, with great gallantry, was mortally wounded: Another officer of the 63rd, and two subalterns of the British legion, were likewise wounded. The former corps had also thirty, and the latter fifteen, non-commissioned officers and men, with thirty horses, killed and wounded."

Patrick O'Kelley in Nothing but Blood and Slaughter, 1780, Vol. 2, reports the British casualties as 52 killed and wounded and the American casualties as 3 killed, 4 wounded, and 50 taken prisoner.

John Buchanan in <u>The Road to Guilford Court House</u> writes:

"The best estimate of Rebel casualties is three killed and four wounded. Tarleton lost ninety-two killed and seventy-six wounded, or sixty-two percent of his command that engaged the enemy," (p. 257)

After Tarleton published his account of what had happened in the south, Roderick McKenzie wrote a series of letters called Strictures on Lt. Col. Tarleton's "Of the Campaigns of 1780 and 1781 in the Southern Provinces of North America."

McKenzie was an officer in the 71st Regiment of Foot, Frazer's Highlanders, and had been in Tarleton's command, most notably at Cowpens where his unit was savagely defeated and McKenzie wounded.

He wrote letters to a friend and he is clearly determined to set the record (as he saw it) straight. He writes of Blackstock's:

"Lieutenant Colonel Tarleton, without waiting for the rest of his detachment, made a precipitate attack with one hundred and seventy dragoons, and eighty men of the 63rd regiment, upon the enemy, under the command of General Sumpter, strongly posted on Blackstock Hill, and amounting to about five hundred. That part of the hill, to which the attack was directed, was nearly perpendicular, with a small rivulet, brush wood, and a railed fence in front. Their rear, and part of their right flank were secured by the river Tyger, and their left was covered by a large log barn, into which a considerable division of their force had been thrown, and from which, as the apertures between the logs served them for loop holes, they fired with security. British valour was conspicuous in this action; but no valour could surmount the obstacles and disadvantages that stood in its way. The 62rd was roughly handled: the commanding officer, two others, with one-third of their privates, fell. Lieutenant Colonel Tarleton, observing their situation, charged with his cavalry, unable to dislodge the enemy, either from the log barn to the height upon his left, he was obliged to fall back. Lieutenant Skinner, attached to the cavalry, with a presence of mind ever useful in such emergencies, covered the retreat of the 63rd. In this manner did the whole party continue to retire, till they formed a junction with their infantry, who were advancing to sustain them, leaving Sumpter in quiet possession of the field. This officer occupied the hill for several hours, but having received a bad wound, and knowing the British would be reinforced before morning, he thought it hazardous to wait. He accordingly retired, and taking his wounded men with him, crossed the rapid river Tyger, while the victorious Lieutenant Colonel Tarleton retreated some distance, Parthian like, conquering as he flew. The wounded of the British detachment were left to the mercy of the enemy, and it is but doing justice to General Sumpter, to declare, that the strictest humanity took place upon the present occasion; they were supplied with every comfort in his power. Have been previously apprized, that the American historian, laudably, takes every opportunity to celebrate the actions, and record the death of those of his countrymen who fell in battle. He has, indeed, mentioned the wounds of General Sumpter, but is silent on the fall of the three Colonels described by our author. The real truth is, the Americans being well sheltered, sustained very inconsiderable loss in the attack; and as for the three Colonels, they must certainly been imaginary beings, "Men in Buckram" created merely to grace the triumph of a victory, which the British army in Carolina were led to celebrate, amidst the contempt and derision of the inhabitants, who had much better information."

ANECDOTE TO GENERAL GEORGE WASHINGTON AT VALLEY FORGE Source: Charleston Courier, issue of Thursday July 2, 1829, p. 2, col 1

Revolutionary Anecdote.—The following fact took place during the period when Washington and the starved, half clad troops were in winter quarters at Valley Forge. A young man not quite twenty from Massachusetts was a guard before the General's door marching back and forth in the snow, on a tremendous cold morning. Washington came out, accosted him, "My friend, how long have you been on guard here?" "Nearly two hours, sir." "Give me your gun, and go breakfast at my table." He did so, and General Washington marched the rounds until he returned.

Will of William Hallum

In the name of God amen. I William Hallum of South Carolina, Niney-six District, planter, being sick and weak in body, but of a pervious and memory, thanks be given to God. Calling to mind that it is appointed for all, once to die, do make and ordain this my last will and testament. I desire that it may be received as Such. Principally and first of all, I give and recommend God my Soul who gave it, begging his most merciful and gracious except it for Christ sake. My body, I recommend to the Earth from whom it was taken, in sure and certain hopes of receiving the Same again by the mighty power of God at the general Resurrection. As to my burial, I desire it may be decent without promp or splinder, at the discretion of my Executor and touching such more Estate as it has pleased God to give me in this life. I give, devise, and dispose of them in the following manner and form, first positively ordering all my debts be paid in full.

I will to my Dearly beloved wife, Jennie, the third of all my cleared land during life and the house I now live in, together with all my plantation tools, lakebeings, tables, chares, bed stads, likewise, one Nergo fellow named whip with all my hogs, flour, com, and fader for the use of her family under her Guidance. Likewise, I bequeath to her forever, one Negro woman named cate, one Nergo child named dinah, a mare called Rack, one milk cow, the bed I now lye on, with its furniture and gown pattern, six or seven yards of linnen cloth, all the yearn now in her possession, one picture, six pewter plates, one large iron pot, one chest, all my tea ware, together with all her bed and wearing apparel which she had when I married her.

I will and bequeath to my son, William Hallum, one hundred acres of land to be taken off the western side of this plantation I now live on, one Nergo boy named petter, one feather bed and furniture, my riffle and shot pouch, one iron pot, one small trunk and my saddle.

I will and leave to my son, James, one hundred acres of land to be taken of the one side of the place.

I now live on, beginning at the comer stone where the Surveyor first staked and so lay it off the first run and or side, also two year colt and one milk cow.

I will and give to my son, Josiah, fifty acres of land, the remainder of said plantation, also I give to him one milk cow.

I give and bequeath to my sons, Thomas, Robert Picken, and his wife Dorcas, Nergo girls named missey and sally to be divided betwixt themselves and can agree best upon.

I give to my daughter, Martha, one cow, one woman's saddle tree and all furniture proper to complete it for use, one linnen bedtick, one spinning wheel and one box iron with heaters.

To Joseph Smith and Elizabeth, his wife, I leave the sum of five shilling of sterling. I give to my wife's son, William Griffith, one three year old horse. I give to my wife's daughter, Margaret Griffith, one bed, the property of my wife before marriage, together with all the furniture belonging to it. I give to my sons, John, Thomas, and William, all my wearing apparel to be divided amongst them as equally as they can themselves agree upon.

The rest of my Estate not afore mentioned, I desire may be sold at the public sale and the monies arising from such sale, after paying my debts, to be disposed of at the discretion of my Executors for the schooling of the children, except my sheep which is to remain with my wife for the use of her family together with all the copper vessels in her house with some old wagon irons and hubs.

I likewise to constitute, make, and ordain my dearly beloved wife, Jennie, Executrix and my dearly

beloved son, John Hallum, to be Executor of this last will and testament. And I do hereby disalow, revoke, and disamull all and every other former wills, testaments, legacies, bequeast and Executors by me in anyways before named will and bequeated, ratifying and conforming this and no other to be my last will and testament in witness whereof I have here unto set my Hand and seal this ninth of January, in the year of our Lord, one thousand and seven hundred and eighty-two. William Hallum Signed, sealed and declared by the said William Hallum as his last will and testament in the presence of us who in his presence and in the presence of each other have hereto Subscribed our names.

CAPT. GEO. B. DEAN DIED YESTERDAY MORNING

Capt. Geo. B. Dean, aged 70 years, died at his home on Forest street yesterday morning at 8 o'clock. The funeral service will be held at the residence this morning at 10:30 o'clock. The body will be taken to Woodruff on the noon train over the C. & W. C. today for interment. The pallbearers are: S. J. Simpson, J. K. Hottal, J. J. Gentry, Arch B. Calvert, B. G. Landrum, A. O. Simpson, S. B. Reid and S. B. Wilkins.

The deceased was one of the best known citizens of the county. He served with distinction through the Civil War, returning after the struggle and settling on a farm a few miles from Spartanburg, where he lived until four years ago when he moved into the city. In 1892 Capt. George B. Dean was elected sheriff of Spartanburg county, and for eight years he held the office to the satisfaction of all. As an officer of the law, he performed his duty fearlessly and with discretion. So well was he liked and known as the sheriff of the county that even after going out of office he was known and saluted as "Sheriff." Capt. Dean was for years one of the county's progressive farmers. He farmed on scientific principles, and therefore he farmed to always the saluted as "Sheriff."

and therefore he farmed to advantage. His farm was always a model. In his death the county loses one of her very best citizens — a man who stood for progress, and who had the courage to stand by his convictions.

DR. JACOB H. KING

Dr. King's birthplace and date is not known. His life as a boy and elementary education was never recorded. It is known that he never graduated from a medical college but was examined after reading the usual medical books by a committee of physicians, who readily gave him a licence to practice

He began to practice in the town of Newberry in the year 1828, but was unfortunate. Some friends gave him a new outfit and sent him to Dutch Fork where he found it easy to practice.

His second field of labor was near Pomaria where he was much loved and respected. He married a daughter of Henry Ruff. He removed to Newberry Court House about 1840 where he was elected to the Legislature and there delivered a most touching speech in regard to the drought of 1845.

He wandered a great deal in the practice of his medicine and finally landed in Alabama where he died some years before the war.
