

SOUTH CAROLINA REVOLUTIONARY SERVICE OF DAVID WEIR

R 11286

The information given here was taken from the papers on file in the Revolutionary War claim for pension R 11286 based on the military service of David Weir in that war. The date and place of his birth and names of his parents were not shown.

David Weir married in 1775 to Jane whose maiden name was not given. He died March 10, 1796 in Chester District, South Carolina.

Jane Weir, widow, applied for a pension on March 16, 1849 at which time she was age 98 and a resident of Fairfield District, South Carolina. It was stated that David Weir while a resident of Laurens District, South Carolina, enlisted but the date was not given. He served six or eight months as a private; part of the time in Capt. Williams' company, Col. Andrew Pickens' S. C. Regiment, was in the Battle of Ninety-Six, and that he served as captain of a company quarding the frontiers against the savages, and that he served at various times in Lieut. John Bell's company, Colonel Edward Lacey's South Carolina Regiment, about 34 months in all.

Her claim was not allowed as she failed to furnish proof of service of six months and of her marriage as required by the pension law.

Jane Weir died January 17, 1853 in Pairfield District, South Carolina, and the following children survived her: Thomas, John, M. C., Matthew and David Weir. In 1853, Matthew was a resident of Chester District, S. C., and David was living in McMinn County, Tennessee as was a James P. living in that same county.

CORONER'S INQUESTS AND OTHER PAPERS FOR SPARTANBURG COUNTY 1803-1908

When transcribed in 1987 from the originals which are in the possession of the SC Dept. of Archives & History in Columbia, SC, the papers were in three boxes marked as Coroner's Inquisitions for Spartanburg County. Although this represents the contents of most documents in each of the boxes, there were many other loose papers representing other types of proceedings for Spartanburg County. These loose papers are included here along with the inquests. All abstracts of the documents are given in the order in which they appeared in the boxes. Approximately 500 documents were found in the three boxes.

Editor's Note: It is hoped that such a vast amount of material will eventually be put into book form. Until this can be done, we will continue to publish these documents until they are completed in our quarterly. To preserve space, the official title of the person holding the inquest has been omitted. Most cases were presided over by a coroner or one of the justices who was acting for the coroner in his absence. It is assumed that the death occured on the date of the inquest unless the inquest papers state otherwise. The original spellings of names, places, etc. has been retained.

SKETCH OF NATHAN BERRY

Elder Nathan Berry, father of the late Dr. Berry of Greenville SC, was born at Cedar Falls, in Greenville County, Nov. 3rd 1791. Barly trained in the nurture and admonition of the Lord, he made a public profession of religion in the 13th year of his age and was baptized by the pastor, Elder Jonathan Deweese, into the fellowship of the Fork Shoals Church in 1804 of which he then became a member. From the time of his conversion his life was consecrated to the Master's service and before reaching his

Majority he began to preach the gospel.

Not waiting for a call from some good field already planted by another, he proceeded at once to break up the fallow ground and sow one for himself. He began preaching in a destitute section of his native county and in 1819 founded the Standing Springs Church, of which he then became a member and was ordained the first pastor which position he filled for many years, in all probability until the close of his life. He subsequently served

as pastor for a number of years the Bethuel Church. About the year 1830 he began to preach under a brush arbor near the present site of Sandy Springs Church where in 1832 he succeeded in establishing a church of which he became pastor remaining such as long as he lived. These three churches all located in Greenville County and stand today in the front rank of the county churches, Standing Springs and Betheul having been members of the Saluda Association for a number of years.

In addition to his pastoral labors Elder Berry did a great deal of evangelistic work. His daughter, Mrs. Elizabeth Farmer of Anderson, S. C., in speaking of him says: "He travelled all the time, preaching somewhere nearly every day." He travelled extensively in S. C. and in the mountain regions of North Carolina and occasionally his visits were extended into the State of Georgia. His labors were attended with much success-great numbers professing conversion under his ministry.

For many years he was a prominent member of the Saluda
Association, his name appearing on almost all of the important
committees and he was frequently called upon to preach to immense
throngs that attended their Sunday meetings. And among those
appointed to write and hear letters of correspondence to sister
associations, both in and out of the state, Brother Berry's name
invariably appeared. In 1822 he read by appointment a circular
invariably appeared. In 1822 he read by appointment a circular
letter before the Association on the "Nature and Character of
Regeneration." This was an able paper and would do credit to any
theologian of the present day. His name appears in 1822 among
the 1st delegation ever appointed by the Saluda Association to
attend the Baptist State Convention.

"As a pastor he was faithful, and as a minister he was humble and unostentatious, but highly useful from his great earnestness and sincerity. His preaching was usually extemporaneous, combining the doctrinal, practical and experimental, but he excelled in exhortation."

"In building up and establishing the cause of Christ in his field of labor few have accomplished more. Decidedly missionary in principle and practice and a thorough Baptist in doctrine, he

About the time he commenced preaching he was married to Miss Mary Hiott, a pious lady of his native county, who was, indeed, a helpmeet for him during his whole ministerial career. Their house was ever open to the way farer and their hands to the needy,, and visiting ministers always found a warm welcome around their hearthstone. Among their honored guests were frequently found such men as Elders B. Manly, Sr., Richard Furman, Jesse Nercer of Georgia, and W. B. Johnson. Sister Berry was a very domestic woman and found much pleasure in preparing for and entertaining such visitors.

Brother Berry died at his home near Standing Springs Church in Greenville County in February 1841 in the fiftieth year of his age, . . .

All who knew him loved him, and many there are to sympathize deeply with the bereaved household. He was spared through the closing scenes of the late war to die among those who were dear to him.

BASTARDY PROCESSES FOR SPARTANBURG COUNTY

Contributed by Paye Berry. Abstracted in November 1987 from the original records found in the SC Dept. of Archives & History. The records are in boxes labled Court of Common Pleas, Bastardy Processes, Spartanburg County, SC, Bastardy Bonds. Several other types of documents were found in the box. Abstracts of them also appear here. The cases are in individual file folders. The title for each entry below is taken from the folder. It is obvious when comparing these titles with the contents of the folders that the clerk or clerks who labeled the folders paid very little attention to the actual contents of them as very often the name on the folder is not the same or is different in some way from that inside the folder. The original spellings of names, places, etc. have been retained. In some instances, a surname will be spelled more than one way within a case. Therefore, those spellings have been retained here. There is no apparent order to the material in this box. No attempt has been made to put this material into chronological order. Not all cases named the father but it is probable that whomever signed the recoginance with the mother is the father especially if that person is not a member of her family.

Editor's Note: Sometimes bond would be given to the Commissioners of the Poor for Spartanburg County who oversaw the care of the indigent. In such cases, the names of the commissioners have been given.

State vs William Grier March 14, 1838

Sarah Varner, mother, a single woman; female child, born May 14, 1835. Magistrate Joseph Smith.

Recoginance for bastardy signed by William Grist, Benjamin and Thomas Grist on April 7, 1840 before J. Smith.

State vs Fanny Parris
Informer, Benson Byars made oath before W. B. Turner, Magistrate, on July 24, 1841 that Fanny Parris had given birth to a male bastard child a few weeks earlier. A summons to appear in court was served on the mother the next day by N. Horton. She appeared before Magistrate Turner and acknowledged the child and gave security for the maintenance. Securites: James Davidson, Raymond Davidson, Jr., John Davidson.

State vs Thoms Poole
Cinthia Lancaster, single, made oath before Judge Daniel White on
July 7, 1817 that a female child was born to her on April 29,
1817 and that Thomas Poole, Esq. is the father of that child and
of a male child, born February 1, 1813. Recoginance was signed
by Thomas Poole and E. Roddy on November 13, 1817. Another
recoginance for £120 for two bastard children was signed on April

7, 1827, by Thomas Poole, James Hunt and Edmund Cooley. Witness was A. Lancaster. Note: Activity in this file from July 7, 1817 to March 15, 1827.

State vs Glenn D. Peake
Miss Louisa Kirby, a single woman, made cath before J. F. Sloan,
Magistrate, on October 13, 1863 that on January 11, 1863, at her
father's house, she gave birth to a female bastard child with
blue eyes, fair complexion and yellow hair, and named Glenn D.
Peake of Union District as the father. Bond was signed on
October 20, 1866 before J. F. Sloan by Glenn D. Peake, W. J. T.
Glenn and William Morris.

State vs Lewiston Bobo/Foster Golding/Nancy Bobo
Bond was signed on September 29, 1804 before Judge Samuel
Lancaster by Nancy Bobo, Leviston Bobo, and Foster Golding for
maintenance of a female bastard child born to Nancy Bobo.

Note: This name is really either Lettice or Lettie Lewis.
Bond was signed before Danl White on April 24, 1818 by Lettice
Lewis, Jesse Rakestraw, Richard Barnett and Jospeh Smith for
maintenance of a male bastard child born to Lettice Lewis on
March 15, 1815.

Recoginance bond was signed on September 12, 7, by Polly Rogers and Nicholas Garrett for maintenance of a female bastard child born to Polly Rogers who named Nicholas Garrett as the father. The bond was signed by Polly Rogers, Nicholas Garrett and Thomas Garrett before David Moore, Judge. Witness was Edmon Waddell.

State vs Rachel Whitemcore
A bond was signed before Drewy McDaniel on March 6, 1815 by
Rachel Whitemcore, John Wofford and Isaac Wofford for the female
bastard child born to Rachel Whitemcore on November 25, 1814.

State vs Sally Hawkins
Recoginance bond was signed by Robert Jones, Patrick Tyler and
John Graham on December 15, 1815 before A. Benson. Robert Jones
was named as the father of the illegitimate male child born to
Sally Bawkins. Commissioners of the Poor were: Tyre Glenn,
Benjamin Bearden, James Crook, Moses Casey and Richard Thompson.

State vs Fanny Lackey
Bond to the Commissioners of the Poor was signed before Henry
Turner, Judge on May 11, 1807 by Fanny Lackey, Henry Adcock, JunBurrell Jane and Henry Adcock, Sen. for support of a female child
who was illegitimately born to Fanny Lackey, a single woman.

Among the churches presented are Philadelphia Baptist, Bethesda Baptist, Concord Methodist, Mount Carmel Methodist, New Hope Methodist, and North Pacolet Presbyterian. In all, 21 churches, including 7 extinct ones, are published. Also, 34 family cemeteries, and 3 community and private cemeteries appear here.

This is a complete listing of 1866-1869 marriages found in THE CAROLINA SPARTAN, a Spartanburg. South Carolina newspaper. Although these marriages are found in Spartanburg newspapers, they are not confined to that area. Many pertain to persons living in other counties of South Carolina and a few concern persons living in other states.

The Descendents of James Crook and Related Families 1746-1978. Compiled and edited by Martha King Neubsser 463 pages, including 63 page index. \$42.00

The society has acquired the 28 remaining copies of this detailed study of the James Crook family of Virginia and later Spartanburg County, S.C. However, the late Mrs. Neubauer did not limit this work to this particular family. She included information on other branches of the Crook family in England and America. She also included pictures of tombstones and various Crook homes. The second part includes information on the following related families: Anthony, Bane, Barry, Brockman, Burk, Coleman, Evins, King, Mann, Newman, Patton, Stallworth, Travis, and White families. "Bits and Pieces" (Part III) is an abstract from records of persons of the same surnance, but with whom no proof of relationship has been established.

The 1820 Census, Chester District, South Carolina, compiled by Faye Berry. 31 pages, soft cover.

Faye Berry has abstracted the information found in the 1820 federal census for the over 1,500 families then living in Chester District. (Included in this volume are 14 families headed by "free persons of colour."). This volume eliminates the need of sitting in front of a microfilm viewer to find your ancestor's family here in 1820. It is a great research aid presented in a easy to use size and format.

The History of Mount Zion Church and Her People, by Dr. J. B. O. Landrum, edited by Joseph R. Gainey. 17 pages plus to be a proper and country.

This is a republication of a 1885 volume on Mount Zion Baptist Church, near Imman, Spartanburg County, SC. It traces the church from its establishment as a mission of Bethlehem Baptist in 1804, through it organization in 1827, up to the history's publication in 1884. This volume, though small in size, contains a wealth of information, both historical and genealogical, on Mount Zion and its early members.

1860 Mortality Census of Upper South Carolina, Volume I, compiled and edited by Faye Berry. 33 pages, soft cover. \$6.50

This is first in a two volume set which will include all of the Piedmont. Chester, Greenville, Spartanburg, Union, York, and Pickens Districts are in this volume. (Pickens at the time incorporated what is now Oconee County. Cherokee County was then found as part of Spartanburg, Union, and York counties.) Ms. Berry has listed all persons legible on the microfilm copy at the S. C. state archieves. She has given their name, sex, age, race, and month of death as reported by the enumerator.

An Account of Marriages Solemnized By Tolaver Robertson In South Carolina Between October 1842 & February 1867, edited by Joseph R. Gainey. 16 pages plus index. \$5.00

Rev. Tolaver Robertson kept an account of the marriages he "solemnized". This is not an unusual practice. What is unusual is that he published it in 1867. However, only one copy is known to have survived. This is a republication of the material found in it. Since marriage records were not kept by the State of South Carolina before 1911, this is a great boon to genealogists, especially those with roots in Laurens and Greenville counties. Robertson recorded 364 marriages for nearly 275 different surnames.
