

William Cannaday - age 19; served as private in 8th VA Regiment that was commanded by Col. Matinburgh, Capt. Geo. Slaughters Company; farmer; unable to support wife who is age 57 and child, Nancy, age 22.

13 November 1821

Joshua Nobles - age 66; served in the 4th Regiment of the VA Line in Capt. Isaac Bell's Company; farmer; family consists of five members beside himself these being: his wife, Elizabeth Noble about 46 years of age; son, William, age 17; daughter, Sarah, 13; Abner, age 10 who is deaf; Betsy, age 7.

19 April 1821

Thomas Turner - age 67; was enlisted by Capt. Thomas Threet of the 14th Regiment, commanded by Col. Lewis of the Virginia line of Continental troops; farmer, but unable to follow it to advantage being afflicted with pain; wife, age 47; has no others in family.

John Arnold - age 80; elisted by Capt. Drury Cage; discharged at Augusta.

William Gibbs - Resident of Pendleton District; served in 1779 at Good Bridge on Appomatox River in Virginia in a Company commanded by Capt. Randel and a Regiment commanded by Col. Meed in the Virginia line; farmer; no family at home, lives with his children who are residents of the District.

20 November 1828

Note: The above soldier declared in a separate statement that his service could be proven by Peter Patman and Peter Gibbs of North Carolina.

Thomas Ward - age 73; served in a Virginia Company commanded by Col. Lewis Willis; family consists of himself and wife, (Franny?) who is about 73 year of age.

22 September 1829

Benjamin Puckett - age 70; enlisted in July 1776 in a Company commanded by Capt. Thos. (Scott?) and Col. James Scrivens Regt., Prince Edward County, State of Virginia; has no home of his own but lives with some of his children.
24 October 1829
Before Jno. B. ONeal

Richard Butler - age 80; enlisted 15 October 1776 in State of Maryland in a Company commanded by Capt. Clickett, in Regiment commanded by Col. (Grunby?).

Benjamin Grist - age 70; served from State of North Carolina in a Company commanded by Col. Budley while he resided in Randolph County, North Carolina; farmer; no family at home; occasionally resides with his children.

ABSTRACT OF COURT TRIALS OF SOME KLAN MEMBERS FROM YORK COUNTY

Source: Proceedings in the Ku Klux Trials at Columbia, S. C., in The United States Circuit Court, November Term, 1871.

All cases given here were tried in Columbia, SC on December 28, 1871. Bugh L. Bond, of Maryland, Circuit Judge presided. The prisoners were all from York County, SC.

The case of Allen Crosby, Sherold Childers and Others, members of the Ku Klux Klan: The prisoner was Sherod Childers, age 23. In his testimony, the prisoner stated that he was a farmer, married and had one child. He mentioned Allen Crosby, Sylvanus Hemphill, Evans Murphy, Ki Porter in his testimony and stated that Aleck Smith was the Chief of his Klan. Childers pleaded guilty, was fined \$100.00 and sentenced to serve 18 months.

The case of William Montgomery, member of the Ku Klux Klan: The prisoner was William Montgomery, age 19. He would give no information. He pleaded guilty, was fined \$100.00 and sentenced to serve 18 months.

The case of Evans Murphy, member of the Ku Klux Klan: The prisoner, Evans Murphy, did not state his age. He stated that his family consisted of eight members including himself. They were: Four children and sisters-in-law. Persons he mentioned by name in his testimony in connection to the Klan were: Mr. Kirkpatrick, James Pursely, Allen Crosby, Sherod Childers and Bezekiah Porter. He pleaded guilty, was fined \$100.00 and sentenced to serve 18 months.

The case of Hezekiah Porter, member of the Ku Klux Klan: The prisoner, Hezekiah Porter, age 19, would not give any information except to state that the Chief of his Klan was Aleck Smith. Porter pleaded guilty, was fined \$100.00 and sentenced to serve 18 months.

The case of James William Avery, James Rufus Bratton and Others This trial was stayed.

Charge: Assault & Batt. on Amzi Rainey, colored. The prisoners all pled guilty and were tried and sentenced.

OBITUARY: Jane Caroline Moore, daughter of Hewlet and Mary Sullivan, and wife of Samuel Moore, deceased. Born the 21st of September 1798, and died the 17th day of November 1871, in her 74 year, at Lickville, Greenville County, South Carolina.

She joined the Methodist Episcopal Church, South, in 1845, and lived a consistent member of the same until death.

In all the relation of life she endeavored to fill her sphere as best she could. As a Christian, humble and retiring, feeling herself destitute of personal righteousness, but trusting in the favor and grace of God through the blood of Christ for a life of happiness beyond this vale of tears. As a wife, every thoughtful of the comfort and happiness of her husband. As a parent, kind and affectionate; and now how vividly can her children, (one of whom is a minister of the gospel,) call to rememberance her many kind administrations to them in their early training and subsequent life. As a mistress of her household, lenient and forgiving. As a neighbor, social and obliging, and ever ready to stretch out her hand to the poor, and reach forth her hands to the needy. She was a woman of unbounded hospitality, and possessed all those ennobling qualities of mind and heart which dignify and elevate woman in all spheres of life. Her house was ever open to the weary itinerent, and many members of the South Carolina Conference have been welcomed and cared for in her hospitable abode. Her social qualities shed a geneal influence around all who came within the circle of her association. For several months before her death, her sufferings were intense, all of which she bore with patience and Christian fortitude. "For I reckon that the sufferings of this present time are not worthy to be compared with the glory which shall be revealed in us. " Her relatives and friends who have been rendered desolate by this sad bereavment, are comforted by the hope of a glad reunion in

BASTARDY PROCESSES FOR SPARTANBURG COUNTY Continued from Volume VII, No. 3.

State vs Nancy L. Barry Jolly A bond was signed before A. Bonner, Mag., on Pebruary 25, 1861 by Nancy L. Barry Jolly and William Paris for an illegitimate female born on September 8, 1860. The father named was Peter P. Paris.

State vs Hiram Yarborough
On April 1, 1852, a joint recognizance was signed by Hiram
Yarborough, Junr., F. R. Bobo and George Sheldon. It was
attested to by W. H. Sheldon. The mother named was Frances E.
Fowler who had given birth on June 14, 1851 to an illegitimate
male. The father named was Hiram Yarborough.

State vs Milly Oliver
A recognizance bond was signed on September 23, 1851 by Milly Oliver, L. P. Bishop and Abel Bishop. The mother, Milly Oliver, had given birth to an illegitimate female called Caroline Oliver who was then about two years of age. Testator was G. W. H. Legg, Magistrate.

State vs Isaac F. Alexander
On September 9, 1861, a bond was signed before Randolph Turner,
Mag., by Isaac F. Alexander, Wm. C. Camp, Joseph Lawrence and Wm.
H. Golightly. The mother named was Emily J. Griffin who had
given birth to an illegitimate child born on August 14, 1861.

State vs James C. Woods
A recognizance was signed on September 29, 1851 before G. W. H.
Legg, Mag., by James C. Woods, J. B. Morgan and John Earl Bomar.
Testator was J. B. Tolleson. The mother, Elizabeth Gordon, gave
oath on April 22, 1851 before A. Bonner, Mag., that she had given
birth to an illegitimate female, born about February 22, 1851.
The father named was James Crawford Wood.

State vs John Rhodes
John Rhodes and Thomas Rhodes signed a recognizance on September
29, 1849 before P. R. Bobo, Mag. The father was John Rhodes. No
data was given on the mother and child.

State vs Willis Smith
Willis Smith, Edward Lipscomb and Elias Lipscomb signed a bond on
April 6, 1846 before J. B. Tolleson. The mother was Nancy
Blanton who had given birth to an illegitimate male. The file
gave data that told of Willis Smith being found guilty in the

DEATH OF AN OLD LANDMARK Mr. Joseph haddon, familiarly known by his accres of friends as "Joe", died Tuesday of this week at the advanced age of 94 years. INTERESTING REMINISENCES OF GREENWOOD.

Messrs. J. R. Blake, jr. & R. P. Blake have bought what is known as the old Sikes property, on McNeill street. It is the intention of the purchasers to have Major Lee survey the land and lay it off in building lots at once. The tract contains twelve acres of land, most desirable for residences. The are some historical associations, tinged with romance, connected with this property, that makes it doubly valuable to the two enterprising young men who purchased it. It was on this piece of land that their great grand father, John Blake, first settled when he came to this country form Ireland in 1795. There is an interesting ancedote, and still more interesting because it is true, which the descendants of this venerable man delight to tell of him. He was severely afflicted with dyspepsia, and it was on this spot of earth that he determined to have recourse to prayer and fasting as a remedy for his ills. Barly one morning he announced his intention to his wife, and after securing her approval secreted himself near the old homestead and remained in prayer all day long. At eveningtide he returned and reported himself ready for supper which he ate with a relish, and from that day till his death he knew no more suffering from dyspepsia. On the next morning he carved on the old rock chimney the word "Ebenezer". The stone bearing the inscription is now in the possession of Prof. J. R. Blake, of this city. On the old chimney now standing are the initials of the Messrs. Blakes father, A. M. B., carved January 9, 1827, exactly sixty-nine years ago this morning. The purchasers propose to improve and beautify the grounds, but they are not for sale at any price. They will preserve the place as a memento of worthy ancestors, of whom they are just proud. The place will be called Blakeville.
