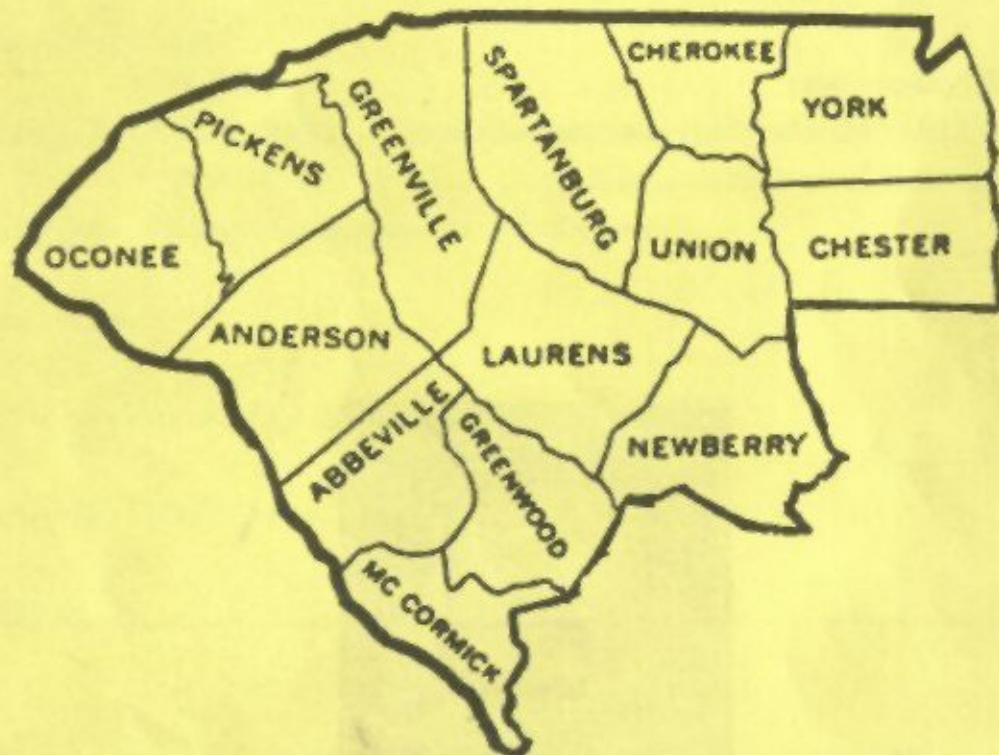

Inquest into the death of Liberty, slave of Jno. Murph.  
Taken at residence of John Murph on 1 August 1843 before H. White, Coroner.  
Jurors: Andrew Foster, Jno. Harmon, Robt. James, Harrison White, Martin Otts, E. J. Underwood, Henry Cunningham, A. Flemming (Senr?), Caswell Bogan, Hiram James, Alvin Lancaster, Jefferson Hays, Jno. Zimmerman, D. Whetston, William White, Thomas West, B. B. Foster, William James.  
Witnesses: (This sheet was missing from file.)  
Jury ruled deceased died between the 13th of July and the 1st of August of natural causes.

Inquest into the death of Ben, slave of Col. Thomas F. Farrow.  
Taken at the spring near the plantation of Thomas F. Farrow on 7 July 1843 before J. W. Martin, Coroner.  
Jurors: John Davis, John C. Abernathy, Thos. H. Smith, P. (J.?) Bobo, Ephraim Campbell, John Beavel, Chaney Bobo, William Pressley, Moses Lee, Jesse Fowler, John D. Montgomery.  
Witnesses: Samuel Stone, J. L. Farrow, John Murphy.  
Jury believed there may have been foul play but could not find enough evidence to convict anyone.

Inquest into the death of an infant.  
Taken at the residence of Lovey Kirby on 13 February 1844 before Stephen Kirby, Magistrate.  
Jurors: Thomas Littlejohn, Reubin Briant, Junr., John Briant, Junr., John Petty, Henry Kirby, Reubin Briant, Senr., Andrew T. Harmon, James Bartlett, Saml. Littlejohn, Fulton Brown, John Easterwood, Joseph Harvey, Henry Harvey, William Lee, Joseph Hays, William Kirby, Zack Kinnett, Saml. Willey, Moses Hammet.  
Jury summons was served by A. W. Kirby, Constable, on 12 February 1844.  
Witnesses: Polly Garrett, Louisa Kirby, Mary Garrett, John Burgess, Negro boy, Randal.  
Jury could not decide between the infant being stillborn or murdered.

Inquest into the death of Roseten, female slave.  
Taken on 27 July 1844 at the plantation of Fielden Clayton before Z. D. Bragg, Coroner.  
Jurors: Thomas Rhodes, T. F. Murphy, William Rhodes, Waters Farrow, John F. Dorroh, Belton Pool, Samuel Farrow, J. L. Norman, William M. Rampley, John Murphy, Thos. F. Farrow, Westly Campbell, Thos. Rhodes, Junr.

Inquest into the death of infant of Henry and Violet Alley.  
Taken at the home of Henry Alley on 20 November 1844 before J. W. Martin, Coroner.  
Jurors: Thomas Woodruff, E. F. Davis, (L.?) Cantrell, H. Oshiel, R. S. Wright, John Cole, John S. Gentry, Paul Chamblee, Samuel

Switzer, Thomas Hammet, Harvey Shands, J. B. Page, Alexander Pruitt, W. M. Skinor, William Wright.  
The jury ruled the infant died from a tumor and deformity.

Inquest into the death of Kent, property of D. F. Maberry.  
Taken on 12 January 1845 by John Chapman, Jr., J. Q., at the house of D. F. Maberry.  
Jurors: Herbert Hawkins, Richard Moss, Barney Bishop, Pinckney Bishop, Sweptson High, H. A. Johnson, William Moore, Henry Bishop, Simpson Bishop, Jonathan Lowe, Abel Bishop, Jeremiah Barnett.  
John Prigmore, law officer, served the summons.  
Witnesses: Garland Foster, Richard Moss, Jeremiah Barnett.  
The deceased was found lying dead by Garland Foster's place on Fairforest Creek. There being no sign of violence, the jury ruled he died of natural causes.

Inquest into the death of James Cook.  
Taken near the Still House of the deceased on 3 June 1845 before John Chapman, Jr., Magistrate.  
Jurors: J. G. Landrum, James Ballenger, Coleman Wingo, Saml. Johnson, John Larrens, Edward Ballenger, T. R. Fleming, B. R. Chapman, Joseph Larrens, Jefferson Larrens, John C. Hunt, William Johnson, B. R. Chapman.  
Witnesses: Marcus Cook, Judith Cook, Elizabeth Cook, John Ray, Polly Thomson, Warren Thomson.  
Jury ruled the deceased died shortly before 4:00 p.m. on June 3, 1845 in his field of a probable heart attack.

Inquest into the death of infant of Hulda Trollinger.  
Taken at the residence of Samuel Trollinger on 15 February 1845 before Hazzard Hicks, Magistrate.  
Jurors: William Morris, Capt. John H. Cooley, James Ezell, Sr., George Cantrell, D. C. Dobbson, Henry McKinney, John McCelvy, Anthony Horton, James Horton, William Ezell, Fielden Cantrell.  
Witnesses: Barbary Trollinger and Samuel Trollinger.  
John McCelvey and James W. Hammet (possible neighbors) helped Samuel Trollinger dig the infants grave.  
Jury ruled the infant was stillborn at the residence of William Wilson due to an incident that happened a few days earlier when a drunk man frightened the mother and Mrs. Wilson. They ran away; at which time the mother fell and injured herself.  
NOTE: This file has a lot of information not given here.

Inquest into the death of Dick, property of Col. Thos. Waters.  
Taken on 25 May 1845 at the plantation of Maryann Montgomery near Sedar Shoal Church.  
Jurors: Z. D. Bragg, John C. Abernathy, P. M. Waters, Ephraim Stone, H. C. Waters, R. Waters, Thomas Red, Scarlet Red, William Belton, Col. T. Farrow, Jesse Lamb, A. Stone.  
Witnesses: G. W. Johnson and Henry Cooper.  
Jury ruled deceased committed suicide by hanging himself.

# REEDY RIVER BAPTIST CHURCH MEMBERSHIP ROLLS 1799, 1813, 1818

Reedy River Baptist Church is located in Greenville County, SC. It was constituted before 1790 and was originally known as Head of Enoree Baptist Church. The present name has been used since 1827.

The church minutes are extant from 1799. The 4 August 1799 entry, pertaining to the appointment of William King as minister, includes the following list of members:

Baylis Earle (clerk), Abraham Harges, Lewis Rector, David Forrester, Issac Lemons, Sarah Stephens, Joseph Willis, George Woolf, Joseph Harden, Nathaniel Jackson.

The Church Calendar for 1813 beginning October 20 lists the following members: MALES: Issac Lamman, Robert Benson, Lewis Land, Benjamin Bridges, John Duncan, Daniel Helly (Kelly?), William Duncan, Moses Steed, John Steed, John W. Hansel, Wilm. Duncan, Thomas Cantwell, Wiley Burns, John Burns, John Barker. FEMALES: Mary Bridges, Nancy Benson, Catharine Hawkins, Rebecca Thurston, Jincy Hooper, Susanah Hooper, Sarah Duncan, Rebecca Steed, Lucy Batson, Martha McDaniel Mary W. Carrel, Agess Barnett, Mary Staten, Elizabeth Sammon, Hanah Duncan, Sarah Bradley, Frances Benson, Margaret Neely, Judith Lamman, Sarah Burns, Obedience Lamman, Polly McClanahan, Gilley Shelton, Sarah Duncan, Sarah Morress, Elizabeth Maxwell, Dolly Benson, Nancy Springfield, Morah Glaze, Kim Nelson, Sarah Brooks, Sarah Bone.

Her parents were William Everett (born January 29, 1818, died September 6, 1890) and Emily Everett (born February 26, 1823, died February 10, 1865). This family lived Ritchie County, W. VA, formerly known as Goose Creek, W. VA.

# BASTARDY PROCESSES FOR SPARTANBURG COUNTY

## State vs Nancy Forester

A bond was signed before George Camp, J. P., on March 23, 1820, by Nancy Forester, Peter Gausnel and Charles Gausnel. The mother was Nancy Forester who had given birth to two illegitimate children.

## State vs Jesse Reaves

A bond was signed before Gab. Benson on September 5, 1807 by Jesse Reaves and Longshore Lamb. The mother was Elizabeth Lamb who had given birth to an illegitimate female, named Rebekah, born March 30, 1806. The father was named as Jesse Reaves.

## State vs Isaac Compton

A bond was signed before James Hamm, J. Q., by Isaac Compton, Basil Compton and John Bearden. The mother was Barbara Smith, a single woman, who had given birth to an illegitimate male born on January 20, 181(2?). The father was Isaac Compton. Commissioners of the Poor were: Moses Casey, Zadackly Ford, John Derham, Benjamin Peak.

## State vs Eleanor Morris

A bond was signed before William Bennett, J. P. by Thomas Cantrell and Nimrod Cantrell on February 16, 1820. The mother was Eleanor Morris, widow, who had given birth to an illegitimate male, born at the house of the mother "in the year now last passed." Commissioners for the Poor: Sterling Westmoreland, Robert Alexander, Phillip Bruton, Michael Gaffney and Christopher Golightly, Esquires.

## State vs Henry Clark

A bond was signed before John Anderson, J. P. on March 20, 1801 by Henry Clark, Bartholomew Grogan and John Kirkland. The mother was Elesebeth Sosby, a single woman, who had given birth to an illegitimate male on August 15, 1798 at Pheby Mcquire's in Spartanburg District. The father was Henry Clark. Overseers of the Poor: Peter Gray and William McDowell.

## State vs Teresey Osheal

A bond was signed on June 19, 1804 before Saml. Lancaster, J. P. by Treasey Osheal, William Grant and Joseph Betterton. The mother was Teresey Osheal.

## State vs Alston Drummond

A bond was signed on April 8, 1822 before E. Bomar, J. Q., by Alston Drummond, T. J. Drummond and John Johnson. The mother, Martha Johnson, a single woman, had given birth to an illegitimate female on June 1, 1821. The father was named as Alston Drummond.



Low, Thomas Wyatt and John Low, Senr. The mother was Dicy Low, a single woman who had given birth to an illegitimate male. The Commissioner's for the Poor: Richard Thomson, Gabriel Benson, James Vernon, William Smith and Samuel Farrow.

#### State vs Elizabeth Raney

Recognizance was signed by Elizabeth Raney, Reddick Rutland and John Raney before Drury McDaniel, J. Q., on June 9, 1809. The mother was Elizabeth Raney who had given birth to an illegitimate male. Note: The mother appears to have also given her oath in Greenville County, SC.

#### State vs Frankey Dean

A bond was signed before William Simpson, J. P. by John Stone and Joseph Quinn on October 12, 1803. The mother was Frankey Dean, a single woman, who refused to name the father. Witness was Jane Simpson.

#### State vs Nancy Langston

A bond was signed before John Dean, J. Q., on October 9, 1807, by Jeremiah Bobo, Chaney Bobo and George Roebuck. The mother, Nancy Langston, had given birth to an illegitimate female, born March 1, 1807. Commissioner's for the Poor: William Smith, Gabriel Benson, James Vernon, Richard Thomson and Samuel Farrow.

#### State vs William George

A bond was signed by William George and David Thompson on August 21, 1843 before A. Dewberry, Magistrate. The mother was Sally Thompson, a single woman, who had given birth to an illegitimate female, born April 26, 1843. The father was William George. A complaint as to this matter was made on August 21, 1843 by Samuel Elders.

#### State vs Fanny Perry

Fanny Perry, Aaron Lancaster and Levi Lancaster signed a bond before Samuel Lancaster, J. P., on April 14, 1801. The mother was Fanny Perry who had given birth to an illegitimate female.

#### State vs Mary Rodgers and Aaron Moor
