

and a man named Calvin Washington, left immediately. Abraham called to those leaving to stay and take care of the injured man, remarking that this was not the first man he had shot. He left about 4 o'clock, going to a negro's house near by, telling the occupants what he had done. He carried his own and Sheffield's pistols to a young man to give to Mr. John Harris, with directions for Mr. Harris to hand them to Trial Justice J. P. Moon.

The veredict of the Coroner's jury was that Thaddeus Sheffield came to his death from a pistol shot wounded in the head at the hand of Perry Abraham. W. M. Lenderman was the foreman of the jury, and Dr. J. B. Earle made the post mortem examination.

Sudden Death.

Harriet Westfield, colored, who lived on Martin Street, in this City, died suddenly on the 27th ult. She went out to do some work early in the morning, and her dead body was found under the house by a little grand-daughter about 11 o'clock. An inquest was held by Coroner Newman, Dr. J. B. Earle making the post mortum examination. The jury, B. K. Lewis, foreman, decided that death resulted from heart disease.

A Colored Man's Crop.

Robert Cureton, colored, who lives near Sandy Springs Church, and rents land belonging to the William West estate, made this year nineteen bales of cotton on thirty-seven acres of land, and has yet to gather six or seven hundred pounds of seed cotton. He also made two hundred and fifty bushels of corn, and eighty bushels of sweet potatoes.

Fire at Grove Station.

On Thursday night last, 28th ult., a fire broke out at Grove Station on the premises of Mr. Simeon Eskew, which destroyed the entire crop of Mr. J. D. Eskew, consisting of one hundred and fifty bushels of corn, fodder, shucks, straw, hay, etc. A good cow was also burned to death. A cow, mule, buggy and a wagon were barely saved from the flames. Mr. J. D. Eskew had his right hand severly burned. The loss is from \$125 to \$150. The origin of the fire is unknown.

Colored Child Fatally Burned.

George Howard, jr., colored, was fatally burned on the 28th ult. His mother lived in the row of cottages near the Air-Line Depot, and she left the boy to go after a bucket of water. When she returned she found him behind the door dead, all his clothing being burned off. An inquest was held by Coroner Newman, Dr. J. P. Lattimer making the post mortem examination. R. M. Stevens acted as foreman of the jury, who rendered a verdict that [the] deceased came to his death by being accidentally burned.

New Year's Day is usually "moving time" in this locality, but several well-known citizens of this City have already changed their quarters; Mr. John Ferguson, who has lived many years on Main and Court streets near the Old Court House, now occupies the Marshall house near the Episcopal Church. Mr. Bobo has moved into the house vacated by Mr. Ferguson.

Sheriff Gilreath has moved into his new building on Buncombe

Street, opposite the Methodist Church.

A Nice Present for Rev. John O. Willson.

For the past two years Mr. Willson has been Chaplain of the R. E. Lee Fire Company of this City. On the eve of his departure to another field, the Company show[ed] their appreciation of his services in their behalf, presented him with an elegant easy chair.

Postmaster Crittenden has induced the Department at Washington to allow an additional letter carrier for the City, and Frank E. Nichols, Jr. has secured the appointment. . . .

Death.

On Monday last, Mrs. Margaret Ligon, wife of Col. R. B. Ligon, died at her home in Grove Township, after a long illness with consumption. Mrs. Ligon was forty-six years of age and a member of Columbia Baptist Church. A husband and eight children survive her.

School.

The public school at Mountain Creek will be opened on Monday next, and will be taught by Miss Mary Ballenger, daughter of ex-County Commissioner David Ballenger. She will board in the family of Rev. J. M. Allen.

An infant child of Mr. Mell Thompson of Cleveland Township, who resides on Capt. Jennings place, died on Sunday night last. Mrs. Thompson is also very sick.

The walls of the new County Jail are about eleven feet high. The residence part of the building, which is in the front is of brick.

Thanksgiving day was not generally observed by the business men of Greenville. Public mid-day services were held at the Episcopal and Presbyterian Churches.

Adam C. Welborn, Esq., will appeal to the Supreme Court in the action against Sheriff Bolt of Anderson, who refused to serve papers sent him by Mr. Welborn unless the fees were paid in advance.

GOUCHER BAPTIST CHURCH MINUTES JANUARY 10, 1810-NOVEMBER 10, 1859

Editor's Note: Goucher Southern Baptist Church is one of the oldest churches in the Piedmont area of SC. Its roots go back to 1772 when Richard Kelly preached here as an assistant to the Rev. Phillip Mulkey. Due to a lack of records, very little is known of its early history or membership although it was certainly disrupted by the American Revolution. As late as 1800, this church was called Goshen. Currently, it is located in Cherokee County, SC, having been a portion of Union County prior to 1897. There are also some Spartanburg County residents who appear in these records since the church is located near the Spartanburg County line. Also these records contain information on other up-state churches including Buck Creek in Spartanburg County which lacks any records of its own prior to 1851.

Editorial Method: Portions of these records, which were copied from the microfilm made for the Baptist Historical Commission, are in very poor condition. The records begin with a membership list which is merely a fragment. Brackets designate where the records are missing or illegible. All superscript letters have been lowered. Punctuation and spelling are as they appear on the microfilm. All marginal notations, which merely number cases or give dates reflected in the text, have been omitted.

Whereas our Legislature at their late Session to wit on the Eigtheenth day of December last did duly Elect you the said Lewis Trezevant John Drayton one of the Judges of our courts of General Sessions of the peace over and Terminer Assize and General Goal Delivery And also of of our Courts of common pleas, for all and each of our Districts and the Said Lewis Trezevant on the nineteenth day of December aforesaid did qualify, as a judge of the Said courts according to our constitution before By the Lieutenant his Excellency Edward Rutledge Esquire Governor deceased our late Governor and commander in chief and whereas owing to the Illness and Isaac Mote (Dart?) afterwards death of our said late Governor Secretary he did not in his life time commission the said Lewis Trezevant in consequence whereof that duly according to our constitution hath delvolved upon our Lieutenant Governor Now therefore we reposing Special Trust and confidence in your abilities care prudence and Integrity have commissioned constituted and appointed and by these presents do commission constitute and appoint you the Said Lewis Trezevant a judge of our said courts To have hold Exercise and Enjoy the said office of a Judge of our said courts Together with all Rights privileges powers & authority and all profits and Emoluments there unto belonging or in any wise appertaining [to] during your Good behavour.

Witness his honor John Drayton Esquire our Lieutenant Governor acting pro: Tempore as our Governor and commander in chief in charleston this tenth day of February in the year of our Lord one thousand Bight Hundred and in the twenty-fourth year of the American Independence.

PRESIDENTIAL PARDONS FOR UPSTATE CONFEDERATES 1865-1867

A proclamation issued by President Andrew Johnson on May 29, 1865, made provisions by which former Confederates including the highest officials of both the Confederate government and military could obtain a presidential pardon and thereby secure both their civil rights and property. In most cases, the Johnson administration granted the request. This action was one of many that the Radical Republicans used in their effort to impeach Johnson and to pursue a much more punitive course of action against the former Confederacy. The information which follows has been abstracted from the "Case Files of Applications from Former Confederates for Presidential Pardons (Amnesty Papers) 1865-1867" for South Carolina which is part of National Archives Microcopy Publication M1003.

UPSTATE AFRO-AMERICAN CONFEDERATE PENSIONERS IN 1928

Given the current controvesy regarding the flying of the Confederate battle flag atop the South Carolina state house in Columbia, the editor finds the fact that there were black Confederate pensioners and that there was a fairly large number drawing pensions 63 years after the war's end a blaring contradiction to the accepted "fact" that the Confederate cause was a white man's cause only. One wonders how many other black Confederates died before they were eligible for pensions or didn't know they could receive a pension from the state and therefore didn't apply. While the size of this group is not as large as the whites drawing pensions, it does call for a reexamination of the generally held idea that blacks did nothing to aid the Lost Cause and that anything to do with the Confederacy's battle for independence is not a part of the heritage of Afro-American heritage.
