

### **AN 1824 FOSTER LETTER**

South carolina Greenville District, 12th February 1824

Very Dear and affectionate Daughter--

We receive your letter handed by Doctor Austin which gave us great Satisfaction to hear that you were enjoying good health. & that you were very well satisfied at the place where you are, but sorry to hear that cousin James still remain(sic.) in a very low state of health. Myself & family through mercy are enjoying a good degree of health for which we ought to be thankful, your uncle moores family are at present in pretty good health & sends their best love & respects to you. Your Sisters and the family in general express a great anxiety to See you & think the time long of your absence. Your grandfather often speaks of you as wishing to see you very much. Dear Daughter I should have wrote to you by the past last week but I went to the village, the day I intended to write, & was bilated so that when I returned I had not the opportunity. I wish you to write by every convenient opportunity. There has nothing of importance occurin the settlement that I know of Since I saw you. Myself & family in general send our best love & respects to cousin James. Give my respects to all that may think worth while to enquire about me. There are many things that I could write though nothing at present of great importance I shall come to a close by subscribing myself your most loving & affectionate mother until death.

N. B. I have sent you a piece of cambrick for a Handkerchief Some yarm for stockings, gloves & Some peas for cousin James.

## THE AUTOBIOGRAPHY OF WILLIAM T. HARVEY

I was born in Spartanburg District, South Carolina, Nov. 1, 1826. My father's name was John Harvey. My mother's name was Elizabeth Bryant, and from this union they raised nine girls and four boys, as follows, from memory, not record: Nancy, Moses, Missouri, Polly, Louiza(sic.), Henry, Melissa, Emiline, Wm. T. Harvey, Firmity (or Franettie?), Altimira, Jane and Tolleson.

Grandfather Bryant's name was Rubin(sic.). Grandmother Bryant I don't remember. I was at Grandpa Harvey's funeral-was so small. [I] don't remember his name. [Records show it was John Harvey.]

I remember Uncle Alfred Bryant and his wife Aunt Polly. Uncle Thomas Bryant, Uncle David Bryant, Uncle James Bryant and wife. Uncle Ely Bryant and wife, Uncle John Bryant and wife, Uncle Berryman Bryant and wife, Uncle Wright Kirby and Aunt Sarah Harvey Kirby, Uncle Hal Harvey and wife, Uncle Joseph Harvey and wife.

All the relatives referred to except Uncle Alfred's and Uncle Wright's lived in South Carolina. They lived in Tennessee.

In 1836, my brother Moses [Harvey] married Miss Nancy Stone, and they, with his father-in-law's family, moved out to Carrol County, from a distance of 500 miles. All travel those days was by team, and of course more or less correspondence followed. In the fall following, Moses [Harvey] came back to visit and to assist Father in selling out and moving to Tennessee. So the great bulk of our relatives were left in South Carolina. I was ten years old at this time, 1836. I lived with my parents until 1850.

At this time there was great excitement over the discovery of gold in California in 1849. Dr. (Berryman) Bryant from Memphis, Tenn. In company of 25, had crossed through Mexico to California in a pack train. Bryant opened a Hospital in Sacramento city and later in the fall, he cam back by way of Panama, and came to Father's to visit us and to get me to come to California across the plains the next Spring.

His plan was to pay the way of 50 men to California for one half of what they would earn the first year here in California. He said if I would get two messes, 6 men to a mess, that it would not cost me anything, so I agreed to his offer and had the men engaged long before time to start, -could have had twice the number.

Finally he notified me when his party would be at Hickman, Kentucky. Hickman is a Steamer landing on the Mississippi [River] below St. Louis; so when we met he gave me a purse of \$1,000.00 and sent a man with me. He told me to go among the farmers and buy all the mules I could with the money. We took the

leaders of our 4 and 6 mule teams. He said they would be in St. Louis, but when we got to St. Louis, I got a letter telling me to come to St. Joseph.

We had 12 mules on the steamer and there was such a rush for California. the captain of the steamer said he would take passengers for St. Jo., so he landed us safe. Bryant was well pleased. Some of the mules were worth \$500.00 a span in Sacramento city.

Arrived in Sacramento city the 12th of August, 1850, to learn the sad news that my Father had died suddenly a few days after my leaving home. For the first

four years in California, I mined, teamed and kept hotel.

Then I met a beautiful young brunette lady just in off of the plains, with her mother, brothers and sister. Her father [had] died on the plains. Her name was Jane P. Walker--from Independence, Missouri. We married in Contracosta County. Calif. On Jan. 1, 1854 and next New Year she was buried from Quick Consumption.--[she] left a sweet little girl one month old, with its grandmother. It lived and grew fine, but at 9 months died suddenly from Spinal Meningitis.

In 1858, I met Nettie's mother and we were married in 1859. Mrs. Hannah Lawrence Harvey Tived until 1879, when she died from a long Tingering siege of dropsy. We had three children, Edward E. Harvey, Mrs. Nettie Modie and Mrs. Wm.

F. Harvey.

In 1881, I was married to Mrs. Elizabeth Polk of Indianapolis. Indiana. She lived to 1902, died in Salinas City from pneumonia. We had one son. Walter

Tolleson Harvey. He died at seven years from spinal meningitis.

In retrospect of my past life, I don't claim perfection, but my wish is to do as I would like to be done by. I am glad to think and know that I never wronged anyone wilfully and knowingly with intent. If I have an enemy, I don't know it, and I may have very few friends, yet I rejoice in the great sacrificial atonement made for salvation of the human race. I have great hope of the joys that await faithful Christians. God is not slack concerning his promises, but commandeth all men everywhere to repent and be saved.

Mrs. Nettie Harvey Modie and Charles C. Modie raised two children Ethel and Edna Zyl Modie. Ethel met an accident when she was about 12 years old. She fell from a buggy and struck her head on the hard pavement of the street. The results was her death in 1903. And Edna—what can I say about the dear sweet girl? As she is my only grandchild, it puts her in a class by herself. Oh, how I would have loved to have had the two sisters for grandchildren. But God works in mysterious ways his wonders to perform. While there are thousands of highly gifted and accomplished women in this city, dear Edna seems to me to stand out without a pier(sic.), sole and alone and how my heart goes out for her safety and welfare.

## **BOOK REVIEWS**

Historical novels aren't good. Period. They are usually not good fiction and certainly not good history. That is the consensus. Fortunately, Leather and Soul proves both of these suppositions to be dead wrong. Mr. McLellon traces the Odessa of his great-great-grandfather Lt. James Claudius Shaw. 7th Ohio Cavalry, and his slave (Union sympathizers please note this fact!) over a 26 day. 300 mile journey from prison in Columbia. SC to Dalton. Georgia. Their journey took them through a significant portion of the western Piedmont. The 513 pages of this book not only show the dangers both men endured but also that the author had done his homework not only to historical fact but also regional customs, speech and other minutiae that even the best known authors often err on. Not once did the reviewer find the author to be wrong when it came to factual matters. This is an excellent book well worth the reader's time.

The Cartee Family History by Bobby Gene Cartee. Hardbound. illustrated, 384 pages including a full name index. Available from Mr. Cartee at P. O. Box 17322, Spartanburg, SC 29301.

Bob Cartee has done an excellent job in editing and compiling this genealogy which is the first in a projected two volume set. The descendants of William James Cartee's 18 children by both wives are included here. A subsequent volume will trace the descendants of Revolutionary War soldier James M. Cartee and other Cartees in the upstate of SC. This volume traces all known descendants to the present generation, is well researched and written in a good concise style which often includes the full texts of obituaries and other source materials. Bradley, Cantrell, Gilbert, Kimbrell, and Strange are among the allied lines appearing in this volume.

# PETITIONS FOR GUARDIANSHIP

On December 21, 1822, the General Assembly of the State of South Carolina passed an "Act for the Better Regulation and Government of Free Negroes and Persons of Color; and for other purposes." (Cooper. Statutes at Large of South Carolina, No. 2277) This act which was meant to supplement "An Act to restrain the emancipation of slaves, and to prevent free persons of color from entering this State" which had been passed two years earlier. Section VII of this act required each "free male negro, mulatto or mestizo" above the age of fifteen in the state "to have a guardian, who shall be a respectable freeholder of the district" within which they both resided. The guardian had to accept the position in writing and record the instrument with the clerk of the court for that district. Failure to comply led to severe penalties for the free man. The following is the complete text of one such petition:

It was clost by the cotton patch that I Shot Tom I had no ill will at him I just shot at him for fun I am not a very good hand to shoot. After I Shot Tom we both went to the Branch to gether and I washed his head I asked him if it hurt him much and he said no it did not hurt him. After the Shooting I came to Mr Sam Reids house and then went home. I did not tell any one of the shooting. the Shooting took place about 12 oclock on friday a week ago, the 6th Jany 1871. I did not threaten to shoot at Tom at any time before this I did not tell him to tell that he had fell down on a stick and hurt him self I did not deny shooting him. Tom went home & I came to Mr Reids he said it did not hurt him and I thought he could get along by himself I did not tell any one because I felt bad about it. Tom did not tell me not to say any thing about it -- James Price who is my father did not have any thing to do with the shooting of Tom

John x Price

Murry Reid Sworn Said she is the mother of the Diseased. that Diseased said to

me John Price told me to tile [tell?] that I had fallen on a snag and struck it in my head. Tom said he was chasing a Rabbit out of a Brush heap when John shot and the shot hit him. Deseased said John shot at him on purpose Witness asked him Why he did not run out of the way Diseased said he did not know which way to run Tom told me that john shot at him with an intent to kill. Diseased came straight to me when he came to me he was shot in the Head and said John shot him. this was on Friday a week ago Witness did not know why John shot Tom that they had had no fuss or falling out. Tom Died night before last just before Any. I saw him die, don't know that thore was any hard feelings between the Boys but thore was hard feelings between Johns Mother and Tom about the children talking blackgard John was one of the ones that were blackgording Tom said he told John he might shoot at him but to wait till he could get out of the way but before he could get out of the way John shot, since Diseased has been shot John came to see him Witness asked him have you come to see my child that you shot, and asked him what made him shoot him and John said he shot him because he wanted to. Witness says I think Turner Price was the cause of John Shooting Tom I heard Turner [Price] quariling with [the] Diseased that morning-- It was soon after Tom was shot that he said John did it on purpose. he was in his right mind at the time I do not know if he thought at that time that he would die said that John tole him it would not hurt him to be shot that he (John) had been shot and it did not hurt him

Allice Jinkins sworn says I herd(sic.) John Price say he shot Diseased on purpose he shot him because he wanted to. On sunday after Diseased was shot on Friday Deseased Mother asked John Price what made him Kill her child and that his answer. I herd John Price acknowledge that he shot Deseased and that he did it because he wanted to.

Susan Reid sworn says she is a sister of Diseased that Tom told her that John shot him a purpose. did not give any reason why John shot him Just said he did it on purpose. After Tom was shot he did not appear to be mad with john Turner price said if Tom was child of his and talked to his people like he talked to my mother he would kill him mother he would kill him

Turner Price Sworn says he is the Father of John Price that John is about 17 years old. did not know of him and Diseased having any dificulty. I said when Tom was talking to his mother very roughly about some milk that if any one of my children was to talk to me or its mother as you do I would beat him nearly to death. Aunt Murry said after Tom was shot that I was the one that put John up

to this and I told her I know nothing about it. I had no ill will at Tom and did not tell John to shoot him and did not want him hurt. After we had got through picking cotton John tuck the gun and went hunting After he had bin hunting some time I heard the gun fire. Aunt Murry came running down and said something had to be done that John had shot Tom and I said <u>What</u> and John commenced crying Tom came to the house by his self John had said all the time that he shot at the Pine and did not shoot at Tom. do not know of any difficulty between themselves

# JOHN YOUNG REVOLUTIONARY WAR PENSION APPLICATION AND FAMILY BIBLE RECORD

Contributor's Note: The family record section of this Bible, presently in the possession of Mr. Joel Ragan, 396 Kingston Street, Spartanburg, SC, contains only one page, the front numbered 679 and the back 680. The preceding page containing births was cut out of the Bible and sent to Washington, DC to support the Revolutionary War pension application of Nancy Young, the widow of John Young. The back of this missing page (with page number 678) is available on the microfilm of File Number W1976 at the SC State Archives. It is not known whether the front side of his page (with page number 677) contains dates of marriages, since it is not shown on the microfilm copy. The backs and the first and last dozen pages of the Bible are missing, but otherwise this old Bible is well preserved. The publisher and the publishing date are provided at the beginning of the New Testament. Bracketed notations and comments are those of the contributor.

### Heirs of John Young [Sr.]

As an adjunct to the foregoing Bible record of John Young [Jr.], it may be of interest to present here a list of the heirs of John Young Sr. The heirs of John and Margaret Young are listed in Spartanburg County, SC Deed Book "P" at page 227, in a conveyance to John Young [Jr.] from the other heirs. This deed is dated December 9, 1814, and it is signed by the following legal heirs of John and Margaret Young:

George Salmon and Elizabeth his wife of Greenville District, SC of Greenville District, SC of Spartanburg District, SC William Foster and Nancy his wife of Spartanburg District, SC James Young of Greenville District, SC of Greenville District, SC of Franklin County, GA

James Dillingham and Hannah his wife Residence not given.
Witnesses: Alece Wall (signed by her mark), Frances Walker, and John Walker.
The place of residence of each grantor is given in the text of the deed, and has been included in the list above. The exception is James Dillingham who is not named in the text of the deed. Yet he signed the deed. John Young [Jr.] was, of course, an heir and he resided in Greenville District at that time.

Margaret Young's maiden name is proven to be Margaret Wood by the Will of William Wood (Spartanburg Co. Estate File No. 2272), which is dated January 22, 1787 in Spartanburg District, SC. This will names the children of William Wood.

"... my five children to witt Marget and John Young William Wood Moses Wood James Wood and John Woods children to have a equil part..."

### South Carolina Service of John Young [Jr.]

The data which follows in regard to John Young was obtained from the papers on file in the claim for pension and bounty land under File No W1976 based upon his service in the Revolutionary War. He was born December 1, 1762 in Frederick County, VA. He volunteered in Spartanburg, SC about November 1, 1780, served as a private in Capt. Major Persons and Thomas Prices's Companies, and Col. John Thomas' and Benjamin Roebuck's South Carolina Regiment. He was in the battle of Blackstock. In frequent skirmishes with Indians while defending the frontiers, and in a skirmish with the Tories on Bush River in South Carolina. He was elected Lieutenant of his company, in which capacity he served 8 months, and was

discharged sometime in 1782 after having served between two and three years. He was allowed a pension on his application executed October 9, 1832, while residing in Greenville District. South Carolina. He died there April 14, 1835.

John Young married in February 1797 in Greenville District, SC to Nancy Salmon, who was born October 5, 1777. They were married at the home of one John Salmon, whose relationship to Nancy Young was not stated. Nancy Young was allowed a pension on her application executed August 28, 1848, while she was residing in Greenville District, SC. While a resident there, Nancy Young applied for bounty land which was her due because of the Revolutionary War service of her husband. She made application on May 2, 1855 and was allowed 160 acres bounty land on Warrant No. 18212 under the Act of March 3, 1855. She died prior to September 1855 but the exact date is not stated. According to the Bible, she died on May 15, 1855.

In 1832, reference was made to one George Salmon, a resident of Greenville District. SC, who served part of the time during the Revolution with soldier. John Young. His relationship to soldier's wife, Nancy Young was not stated.

In 1849, Mrs. Elizabeth Salmon, sister-in-law of Nancy Young, soldier's wife, stated that at the time of Nancy's marriage to John Young, she (Elizabeth) was living in the yard of her father-in-law, whose name she did not designate, and that her 2nd child was born March 7, 1798. She did not state the name of her husband or of her child. In 1849, one Rev. Jesse Dean made affidavit in Greenville District, SC that he married one of John Young's daughters about 1820, but did not designate the name of the daughter.

SPARTANBURG COUNTY DIVORCES

Contributed by Faye G. Berry, 833 Hayne Street, Spartanburg, SC 29301

One of the lesser known changes of the laws of South Carolina during Reconstruction was the introduction of divorce. The Constitution of 1868 declared that the "courts of common pleas shall have exclusive jurisdiction in all cases of divorce." Prior to this time the Court of Chancery had jurisdiction in matrimonial causes but there powers were basicly limited to the allowance of alimony. In 1872, the General Assembly passed an act authorizing divorce on the grounds of adultery and wilful desertion. This act remained in force until repealed in 1878. However, the constitutional provision remained on the books until the current constitution was adopted in 1895. This document clearly stated that "Divorces from the bonds of matrimony shall not be allowed in this State." This remained law until South Carolina became the last state in the Union to allow divorce in 1949.

The originals documents are in the records of the Clerk of the Court of Common Pleas for Spartanburg County in the S. C. State Archives in Columbia. S. C. As will be seen below there is no order to these records.

Patrick Tucker v. Hannah E. Tucker
Complaint dated and started Feb. 26, 1877 and filed on March 21, 1877 with F. M.

Attorneys for plaintiff: Fleming and Webster

Facts of the case: Plaintiff and Defendant were married in Spartanburg on March 28, 1874. They had lived in Spartanburg five years and had no children. Cause of complaint: Defendant had deserted her husband two years earlier not having lived with him since June 1875. She had committed adultery with "divers

persons."

Witnesses: A. Peter Camp, Capt. H. C. Alley, Walker Newman, W. H. Clarke, Jacob Heller, Michael Stein, Daniel Burns, Walter Mitchell, Cora Lee (who lived in Liz Williams' house). Testimony stated that she had been going with Union soldiers and had been seen in Liz Williams' "house of ill favor" with two of them. Divorce granted on April 11, 1877.

William Rigler v. Naomi Rigler Petition for Divorce
An order by Presiding Judge J. H. Hudson to S. J. Simpson, Esq. dated June 26,
1870 (or 1878) required Simpson to take testimony in this case. The attorney for
the Plaintiff were Duncan and Cleveland. No other papers relating to this case
were found.

Among the churches presented are Philadelphia Baptat, Bethesda Baptist, Concord Methodist, Mount Carmel Methodist, New Hope Methodist, and North Pacolet Presbyterian. In all, 21 churches, including 7 extinct ones, are published. Also, 34 family cometeries, and 3 community and private consecrets appear here.

Marriages From THE CAROLINA SPARTAN Newspapers 1866-1869, compiled and edited by Faye Berry Emory 27 pages, indexed. Soft cover

This is a complete listing of 1866-1869 marriages found in THE CAROLINA SPARTAN, a Spartanburg, South Carolina newspaper. Although these marriages are found in Spartanburg newspapers, they are not confined to that area. Many pertain to persons living in other counties of South Carolina and a few concern persons living in other states.

The Descendents of James Crook and Related Families 1746-1978. Compiled and edited by Martha King Neubaser 463 pages, including 63 page index.

This is a republication of a 1885 volume on Mount Zion Baptist Church, near Inman, Spartanburg County, SC. It traces the church from its establishment as a mission of Bethlehem Baptist in 1804, through it organization in 1827, up to the history's publication in 1884. This volume, though small in size, contains a wealth of information, both historical and genealogical, on Mount Zion and its early members.
