Michael Gaffney Braved A Wilderness, Founded City

GAFFNEY (Herald-Journal Bureau) – To some, the eventful history-shaping career of Capt. Michael Gaffney has become an epic legend.

Others look upon him merely as an Irish pioneer who for some indistinct reason, perhaps seeking a favorable climate, settled in the Cherokee Indian wilderness 154 years ago and established a crossroads that grew into the City of Gaffney.

But to all, though perhaps inconspicuous to some, Michael Gaffney and his generation left a legacy in influence that perpetuated their names.

A drive through the city is a good lesson in history.

Capt. Gaffney's original home-place, still a beautiful home, stands unpretentiously on the corner of N. Granard and W. Smith Streets. The Gaffney burial plot, containing the grave of Michael Gaffney, is located nearby on the northeast corner of W. Smith and N. Logan Streets.

All three of these streets derived their names from the Michael Gaffney era.

Capt. Gaffney married Mary Smith of Smith's Ford in Union County in 1803. This was in the year before he came to this locality, apparently seeking a favorable climate in which to make his home. He settled near Limestone Springs and lived there in the same house for 50 years.

Elizabeth Logan was the wife of one of Michael's sons, Henry G. Gaffney. Her brother, John R. Logan, was the surveyor who laid out the town on the home-site plantation which Michael's widow inherited.

Capt. Gaffney was born in Granard County, Longford, Ireland and was schooled in the County of Longford and later studied at Dublin University.

Monday is his birthday. There will be no commemorative service, no special tributes. The birthday of the founder of Gaffney will slip away quietly into the future of many more tomorrows, of many more birthdays. But his influence will remain for the life of the city.

Race Street, which runs between S. Logan and S. Granard Streets, probably got its name from the huge, oval race track that Michael once had here. Part of the course followed closely the route of the present Race Street.

Montgomery Street was probably named for Victoria Montgomery, wife of Michael's grandson William W. Gaffney.

Michael Gaffney left Dublin, Ireland, on July 31, 1797 aboard the "Slow Palace." The vessel was captained by Noah Wyeth, according to a local historian.

He arrived in New York in October, 1797, after a long delay by encounter with pirates and slowed speed due to lack of winds.

Michael had yellow fever in New York during an epidemic. He left that city and traveled to Albany, N.Y., up the Hudson River. He bought two horses at Mohawk Falls which he and a companion rode back to New York. Michael came to Charleston aboard

"The Marion" when a second epidemic of the fever hit New York. He set up a business in Charleston about 1800.

Fever again interfered with Michael Gaffney's life and he left Charleston.

He joined a partner already in business in what is now Union County. He met Mary Smith at Smith's Ford there and married her in 1803.

Michael came to what is now Gaffney in 1804 and established a store. The place became known as Gaffney's Cross Roads, later "Gaffney's Old Field" and subsequently Gaffney City.

The "City" was later dropped from the name. It was chartered in 1872.

Michael was a large property owner and a wealthy man by the standards of his day. He willed each of his children several thousand dollars.

The widow, who died 20 years after Michael's death, in 1870 gave a 200-foot rightof-way to the railroad from Cherokee Ford on Broad River to Gaffney Cross Roads.

Michael Gaffney was commissioned a captain in 1809 by then state Governor Charles Pinckney. He was engaged in the War of 1812, largely around Charleston.

Michael Gaffney was a man of influence. He often received letters from prominent politicians soliciting local influential aid. This fact is attested to by Photostats of those original letters.

Many things are not known about Michael Gaffney. Countless other events of his life have not been recalled here.

[Contributor's Note: The tombstone of Michael Gaffney shows the dates his birth and death to be Sept. 29, 1775 and Sept. 6, 1854. The city of Gaffney is the county seat of Cherokee County, South Carolina. Cherokee County was created in 1896 from a large portion of the eastern part of Spartanburg County and from smaller areas from northern Union County and western York County. Michael Gaffney's will – FOURTH: It is further my will and desire that the property and estate herein before devised and bequeathed to my said wife (including the issue and increase of slaves) except what may have been consumed or worn out in use, shall on her death be equally be divided amongst and between all my children, the children of my daughter NANCY R. HENDERSON, and my son JAMES M. GAFFNEY, taking as before provided the share their parents would have respectively taken if living.}*
